A. RULES & REGULATIONS FOR PARTICIPATION:

1. Only regular employees / Management Trainees / JMOT / JTTT are allowed to participate in the sports meet.
2. He/She is to apply through their respective Head of Office. The consolidated list should reach on or before 8th January, 2014 and for Badminton & Table Tennis Tournament on or before 1st January, 2014 in the format (Excel) attached.
3. No nominations shall be considered for participating in 10th Annual Sports if received by this office after 08.01.2014 and for Badminton and Table Tennis Tournament after 01.01.2014.
4. An employee can participate in maximum three events.
5. Request for spot participation shall not be entertained.
6. Participants shall bring their shoes / dress / swimming costume / Badminton racket / Table Tennis Bat for respective events.
7. Provision for breakfast, tea, lunch shall be made for the participants during the meet.
8. Limited accommodation can be provided to the participants on advance intimation subject to availability.
9. **TA will only be allowed to those employees who will participate in the events. Their names will be uploaded in the OPTCL's website for reference.**
10. In case of any dispute on sports matter, the decision of the designated committee of Jury shall be final.

B. REGISTRATION

Employees, whose names forwarded by their heads shall have to register themselves at our reception counter, Kalinga Stadium, Bhubaneswar between 7.00 AM to 8.30 AM on 11.01.2014 to participate in the respective events positively.

C. EVENTS FOR ABOVE 50 YEARS OF AGE (MEN) :

100 Mtrs. Run - 200 Mtrs. Run - 3 km walk - Shot-put throw - Discuss throw - Long jump.

D. EVENTS FOR UNDER 50 YEARS OF AGE (MEN) :

100 Mtrs. Run - 200 Mtrs Run - 400 Mtrs. Run - 800 Mtrs. Run - Long Jump -Triple Jump - High Jump – Shot-put Throw – Discuss Throw - Javelin Throw - Sack Race – Swimming - Table Tennis (Singles) - Badminton (Doubles).

E. FOR WOMEN ONLY :

100 Mtrs. Run - 200 Mtrs. Run - 400 Mtrs. Run - Long Jump – Shot-put - Musical Chair - Badminton (Singles) - Three legged race - 50 mtrs. Spoon and Marble Race.

F. FOR SENIOR EXECUTIVES ONLY :

Blind target - Needle and Thread race (for GM and above and their spouse).

G. TUG OF WAR BETWEEN EXECUTIVES & NON-EXECUTIVES


Maximum 25 employees in each side.




