Odisha Power Transmission Corporation Limited, Janpath, Bhubaneswar, invites bids (in e-tendering mode only) under single stage two-bid system from International Competitive Bidding from reputed manufacturers/authorized channel partner for DESIGN, MANUFACTURE, TYPE TESTING, INSPECTION, LOADING AT FACTORY, TRANSPORTATION TO & UNLOADING AT SITE / STORES INCLUDING GUARANTEED OBLIGATION FOR SUPPLY OF LIGHT WEIGHT ALUMINIUM, MODULAR TYPE EMERGENCY RESTORATION SYSTEM (ERS) SUITABLE FOR 400KV TRANSMISSION LINE NETWORK & IMPARTING TRAINING (ON INSTALLATION, TESTING OF SUPPLIED EQUIPMENT & TEST COMMISSIONING OF A COMPLETE ERS TOWER) with an estimated cost of ₹ 130 Million or USD 2.17 Million (approx.) conforming to the terms and conditions mentioned in the tender document as per the following details.

The intending bidder(s) shall have to submit the non-refundable tender processing fee (inclusive of Service Tax) for the package (as mentioned in the following TABLE-A) in the form of Demand draft, drawn in favour of K.S.E.D.C.Ltd, Payable at Bengaluru or through e-payment mode payable directly to K.S.E.D.C.Ltd, Bengaluru.
3. The above (1 & 2) demand drafts are to be submitted along with the EMD on or before the last date & time of submission of documents mentioned for the e-tender.
4. The bidder(s) shall have to submit the Bid Security (EMD) in shape of Demand Draft, drawn in favour of the OPTCL, Bhubaneswar or by way of irrevocable Bank

Guarantee (as per the prescribed format enclosed at ANNEXURE-I) for an amount as mentioned in the following TABLE-A for the concerned package. EMD BG has to be submitted in original to Sr. General Manager, CPC, OPTCL before the last date & time of submission of tender.

5. The bidders shall scan the Demand Draft / Bank Guarantee, towards EMD and Tender Cost against each package and upload the same in the prescribed form in .gif or .jpg format in addition to sending the original as stated above to Sr. General Manager, CPC, OPTCL.
