REQUEST FOR EXPRESSION OF INTEREST (REOI)

Consulting Services for Odisha Transmission System Improvement Project

1. The Government of India (hereinafter called “GOI”) has signed for the ODA loan for JPY 21787 million with Japan International Cooperation Agency (hereinafter called “JICA”) on May 15, 2015 (hereinafter called “the Loan”) towards the development of Transmission System Improvement Project (hereinafter called “the Project”) and intends to apply part of the proceeds of this Loan towards payments under the Consulting Services for implementation of the Project. Odisha Power Transmission Corporation Limited (hereinafter called “OPTCL”) is the executing agencies for the projects thus desirous of employing a consulting firm for the Project.
2. OPTCL now invites eligible International Consulting Firms to indicate their interest in providing the services. Interested Consultants (hereinafter “Consultant(s)”) should provide information demonstrating that they have the required qualifications and relevant experiences to perform the services. The Consultant may associate with other firms to enhance their qualification. The Consultant shall clearly state their association, if any, whether in the form of joint venture in this Expression of Interest (hereinafter called “EOI”).
3. The Project consists of several components and the component requiring the consulting services contains the following:
 - Construction of Outdoor-Type GIS Substations

The Project will construct three (3) outdoor -type GIS substations (1 no 400/220kV and 2 nos. 220/ 132kV).Construction will be completed in 30 months, and the consulting service is required for 52 months including designing, bidding, construction supervision and Protect Liability Period.
4. The scope of the consulting service will include following:
 - For Outdoor -Type GIS Substations
 - a) Preparation of technical requirement and basic design;
 - b) Preparation of bidding documents and evaluation of bids;
 - c) Construction supervision and commissioning; and
 - d) Technology transfer for GIS Operation.
5. EOI should include:
 - 1) Expression of Interest (FORM- I)
 - 2) The firm's registration certificate;
 - 3) Joint Venture Agreement (if applicable)
 - 4) General information of the firm (FORM-2 with Firm's Brochure);
 - 5) Relevant experiences (FORM-3): Successfully completed services to meet the following criteria:
 - a) Construction of Outdoor-type GIS 400/220 KV Substation
 - Verification of detailed designing;
 - Construction supervision and commissioning; and

- Operation experience (months/years) of outdoor GIS Substation.
 - c) Japanese ODA loan project experience.
- 6) Total number of engineers/experts (permanent/regular, only those on the payroll of the firm for more than one (1) year (FORM-4);
 - 7) Corporate capacity of the firm (FORM-5 with Audited Financial Statement for last five (5) fiscal years): the firm should have average annual turnover more than one hundred (100) million INR, or equivalent to other currencies, in last five (5) fiscal years;
 - 8) Information of contacts: Name, Position, Address, Telephone/Fax number, and email address.
 - 9) Relevant supporting document.

The interested Firms shall submit one (1) original and four (4) copies of the EOI in sealed envelopes marked with "EOI for Consulting Services for Odisha Transmission System Improvement Project" with soft copy in CD-R.

The Consultants will be selected through Quality and Cost Based Selection (QCBS) method among the short-listed firms selected from applying firms of this EOI, according to "Guidelines for the Employment of Consultants" (April 2012) and "Standard Request for Proposals under Japanese ODA Loans, Selection of Consultants" (October 2012) of JICA. It is intended that short listed consultants will be invited to submit their technical and financial proposal as per the Request for Proposals document to be issued to them.
