## SECTION-I

### INSTRUCTIONS TO TENDERERS

1. The bidders must read in detail the “Instructions to Tenderers”, “General Terms and Conditions of Contract” and “Technical Specifications” before filling the Tender documents. There are seven sections in this Tender Specification.
2. **TENDERS:**
  - a. Bidders must submit their bids with original signature.
  - b. Manufacturers, Authorized Dealers are only eligible to quote. In case of authorized dealer, necessary authorized dealership certificate should be submitted along with tender which should be valid on the date of opening of the tender.
  - c. Only those bidders who have purchased the relevant tender specification from this office can submit their tender. Tenders submitted by others will be rejected. The bidders should indicate the money receipt number and date of purchase of tender specification from this Office. Bidders must submit their bid documents duly filled in our specification only.
  - d. Tender must be submitted in sealed envelope superscribed as Tender Call Notice No. 01/2016-17 for Supply of 120 Watt LED based Flood Lights with complete fittings required for Grid Sub-station at Aska & Phulbani under EHT(O&M) Division, Bhanjanagar for opening and should be addressed to Dy. General Manager, EHT (O&M) Division, Bhanjanagar.
  - e. Tender shall be submitted either in person or by Registered post with A.D. within the time specified in the Tender call notice. Any other means of delivery shall not be accepted. Detailed postal address with PIN, Phone No./FAX No., Mail-Id must be mentioned in the application requesting for Tender document on the Tender Bid. The Tender submitted in person is to be dropped in the Tender Box. Tender received after due date and time will not be considered. The authority will not be responsible for receipt of Tender after due date and time due to postal delay or any other reasons.
  - f. Tenders shall not be submitted telegraphically or by FAX.
  - g. Conditional offers will not be accepted.
  - h. If the last date of receipt/opening of tender falls on a holiday, it will be received/opened on the next working day in same time.
3. **EARNEST MONEY DEPOSIT (EMD):**

The tender must be accompanied by an amount which is equal to 1% of the estimated cost i.e; Rs. 3,435/- as EMD in shape of Cash / Bank Draft drawn in favour of **EHT(O&M) Division, OPTCL, Bhanjanagar payable at Bhanjanagar**. Those who claim exemption from furnishing the E.M.D. should submit the copies of documents on the basis of which exemption is claimed. The EMD of successful Tenderer will not be adjusted towards security deposit and shall be refunded on written request after receipt of security deposit. The EMD of all unsuccessful Tenderers shall be refunded on written request after finalization of Tender. No interest shall be paid on E.M.D.
4. **FORFEITURE OF E.M.D AND SECURITY DEPOSIT:**
  - a. In the event the successful Tenderer failing to accept the order or supply the materials as per the technical specification EMD/SD so deposited shall be forfeited.

- b. Any deviation from the Terms and Conditions of the contract awarded, may also lead to forfeiture of EMD without any notice.
5. **INFORMATION OF COMPETITORS:** Bidders have right to know information on Competitors **only at the time of opening of the bids**. No further information on competitors shall be provided at any other point/stage of the tender without prejudice to Right to Information Act. 2005.
6. **OPENING OF TENDERS:**
  - a. Copy of up-to-date PAN Card and VAT Registration Certificate & valid VAT clearance certificate should be enclosed with the tender.
  - b. Bidders themselves or their authorized representatives (**one person only, possessing authorization letter in original**) shall be allowed to attend opening event of the tender.
7. The purchaser may alter the quantities of materials at the time of placing orders. Orders may also be split up among more than one tenderer if necessary in the interest of the purchaser.
8. The Tenderers may please note that the word 'item' used in the foregoing paragraphs shall mean the materials/equipment as specified in the 'Tender Specification'. In case of deviations, the decision of the purchaser shall be final.
9. The purchaser reserves the right to reject the lowest or any other tender or all tenders without assigning any reason whatsoever.
10. Tenders should be prepared clearly without any overwriting and corrections. Erasures and other changes shall bear the dated initial of the person signing the tender.
11. In the event of discrepancy or arithmetical error in the schedule of price, the decision of the purchaser shall be final and binding on the tenderers.
12. For evaluation, the price mentioned in words shall be taken, if there is any difference in figure and words in the price bid.
13. In the event of disparity of price due to tax rates, the comparison of price shall be made exclusive of tax and order shall be placed with tax rate as per Govt norms.
14. **THE TENDERS SHALL BE LIABLE FOR REJECTION IF THEY DO NOT AGREE TO OR COMPLY WITH ANY OF THE TERMS AND CONDITIONS SET FORTH AND PROVIDED IN THE TENDER SPECIFICATION.**

## SECTION-II

### GENERAL TERMS AND CONDITIONS OF CONTRACT

1. **SCOPE OF CONTRACT:** This specification covers Supply of 120 Watt LED based Flood Lights with complete fittings required for Grid Sub-station at Aska & Phulbani under EHT(O&M) Division, Bhanjanagar as per the technical requirement mentioned in section-III. The scope of the contract shall be to deliver the materials on Rail/Road transport at the destination sites of OPTCL i.e; **Grid Sub-station, Aska & Grid Sub-station, Phulbani**. The bids must be accompanied with *LM 79 & 80 test certificates*. Luminary manufacturer has to submit authorisation certificate from LED chip manufacturer like CREE, NICHIA & PHILIPS LUMILEDS only without which their tender will not be entertained.
2. **PRICE:** The price should be firm and FOR destination. The price should be inclusive of packing, forwarding, freight, insurance charges, excise duty, and other taxes if any. The amount & nature of taxes should be clearly specified in the price schedule.
3. **DELIVERY:** The materials shall be supplied at different sites within 30(Thirty) days from the date of issue of purchase order. The purchaser however reserves the right to reschedule the delivery or change of destination. Early delivery is preferable.
4. **VALIDITY:** Price with terms and conditions of the offer shall be valid for a minimum period of 180 days from the date of opening of tender.
5. **INSURANCE:** Insurance of materials is to be done by the supplier at his own cost. The responsibility of delivery of the materials at destinations in good condition rests with the supplier. Any claim with the insurance company Railway authority/Road transport authorities arising due to loss or damage in transit has to be settled by the supplier. The supplier shall undertake free replacement of materials damaged or lost which will be reported by the consignee within 30 days of the receipt of the materials at destinations without waiting for the settlement of the claims with the carriers and underwriters.
6. **GENERAL REQUIREMENT:** The LED fittings must to be suitable for the purpose of outdoor switch yard lighting of Grid Substations. The fittings must satisfy the entire requirement as specified in the technical specification. Each unit must be accompanied with LED chip manufacturer certificate and LM 79 & 80 test certificates. The fittings must be water proof and dust proof as per protection certificate IP 66.
7. **TERMS OF PAYMENT:** Payment will be made with taxes and duties after delivery of materials at the respective sites subject to inspection and detailed verification, deposit of security amount & approval of guarantee & test certificate and availability of funds from Head office.

- 8. PENALTY FOR DELAY IN DELIVERY:** If the supplier fails to deliver the materials within the delivery period as stipulated under Clause No.3 (Section-II) of this tender document or any extension granted thereto, the purchaser shall recover from the supplier penalty for a sum of half percent (i.e. 0.5 percent) of the contract price for each calendar week or part thereof for delay. However the total amount of penalty shall not exceed 5% (five percent) of the cost of undelivered items. Materials will be deemed to have been delivered only when all the component parts are delivered. If certain components are not delivered in time, the supply will be treated as delayed until such time the missing/undelivered parts are delivered.
- 9. EXTENSION OF TIME:** If the delivery of materials is delayed due to reason beyond the control of supplier, the supplier shall without delay give notice to the purchaser in writing for an extension of time with detail justification. The purchaser on receipt of such notice may agree to extend the contract delivery date if reasonable but without prejudice to other terms and conditions of this contract.
- 10. GUARANTEE PERIOD:** The materials i.e. 120 Watt LED based Flood Lights with complete fittings are to be guaranteed for trouble free service for a period of 24 months from the date of supply. Any defect if noticed during the above guarantee period shall be replaced/ rectified by you of free of cost provided such defects are traced due to bad material, bad workmanship & faulty design etc. The above guarantee certificate in **triplicate** must be furnished by the successful bidders to this office for approval of the undersigned.
- 11. PERFORMANCE CUM SECURITY DEPOSIT :**  
The successful bidder has to deposit 10% of contract value as Performance cum Security deposit within 15 days from the issue of purchase order. In case of non execution of the order the security deposit and EMD shall be forfeited. The Performance cum Security deposit amount will be refunded after successful completion of guarantee period. The Performance cum Security deposit shall not carry any interest.
- 12. AUTHORITY :**  
Dy. General Manager (Elect), EHT(O&M) Division, Bhanjanagar.
- 13. CONSIGNEE:**  
Manager, EHT(O&M) Sub-Division, Aska & Dy. Manager, EHT(O&M) Sub-Division, Phulbani.
- 14. PAYING OFFICER :**  
Dy. General Manager(Elect), EHT(O&M) Division, Bhanjanagar.
- 15. VAT REGISTRATION CERTIFICATE, VAT CLEARANCE CERTIFICATE, PAN CARD & AUTHORIZED DEALERSHIP CERTIFICATE(IF APPLICABLE) :**  
Attested legible photocopies of Income Tax PAN Card, VAT Registration Certificate and Valid VAT Clearance Certificate valid on the date of opening of the tender and authorized dealership certificate(if applicable) should be submitted along with tenders without which tender will be liable for rejection at the time of opening. If required, the firm may be asked to produce original documents for verification any time after opening of the tender. Those who fail to produce the same and found not to be valid on the date of opening of the tender, their tenders will be liable for rejection.
- 16. REJECTION OF MATERIALS:**  
In the event any of the equipments/material supplied by the manufacturer is found defective due to faulty design, bad workmanship, bad materials used or otherwise not in conformity with the requirements of the Specification,

the Purchaser shall either reject the equipment/material or ask the supplier in writing to rectify or replace the defective equipment/material free of cost to the purchaser.

The Supplier on receipt of such notification shall either rectify or replace the defective equipment/material free of cost to the purchaser within 15 days from the date of issue of such notification by the purchaser. If the supplier fails to do so, the Purchaser may:-

- [a] At its option replace or rectify such defective equipments/materials and recover the extra costs so involved from the supplier plus fifteen percent and/or.
- [b] Terminate the contract for balance work/supplies, with enforcement of penalty Clause as per contract for the un-delivered goods and with forfeiture of Performance Guarantee/ Composite Bank guarantee.
- [c] Acquire the defective equipment/materials at reduced price, considered equitable under the circumstances.

**17. JURISDICTION OF COURT:-** Dispute if any, arising against the supply order issued to the supplier shall be filed by either party in any court of law to which the jurisdiction of Odisha High Court extends.

The Authority reserves the right to reject the notice/ award the contract among any responsive bidders against this tender or without assigning any reason thereof. All other terms and conditions will be governed by OPTCL as per Rules.
