Bid shall be received in all offices as well as office of the undersigned where the bids have noticed to be sold.

- 10 Bid document can be purchased from all offices mentioned in the table column 4 against a non-refundable fee towards cost of the documents as indicated in column 6 of the table in cash or Demand Draft issued from any Scheduled Bank payable at Burla in favour of Executive Engineer, Civil Works Division NO-II, OPTCL, Burla.
11. Bidding documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs. 500.00 over cost of documents. The Executive Engineer, Civil Works Division NO-II, OPTCL, Burla will not be held responsible for the postal delay if any in the delivery of the documents or non-receipt of the same in time.
12. The Bids will be opened on dated 04.11.2013 at 11.30 A.M. in the office of the undersigned in the presence of the bidders or their authorized agent who wish to attend. If the office happens to be closed on the last date of sale/receipt and opening of the bids as specified the bids will sold/received and opening on the next working day at the same time and venue.
13. The bidders shall furnish the attested copies of all valid registration certificates, PAN Card, Valid VAT clearance, Service Tax Registration Certificate along with the Bid failing which his/her bid shall not be considered. The bidders shall have to furnish an affidavit at the time of submission of the bid about the authentication of all the tender documents including E.M.D. failing the bid shall be considered as non-responsive and thus liable for rejection.
14. The successful bidder shall have to deposit additional performance security when the bid amount is seriously unbalanced i.e. less than the estimated cost by more than 10% in such an event the successful bidder shall deposit the additional performance to extent of the differential cost of the bid amount and 90% of the estimated cost in shape of Post Office Shaving Bank Account/NSC/KVP/Deposit receipt of Scheduled Bank.
15. Exemption holder like SC/ST contractors should submit attested copy of caste certificate and an application for the rate preference for availing the facilities, Engineering Contractors should submit an attested copy of Engineer Degree Certificate and an undertaking in shape an affidavit that he has not availed concession 3(three) times in the current financial year 2013-2014.




