INVITATIONS FOR BID (IFB), BHUBANESWAR

1. For and on behalf of Odisha Power Transmission Corporation Limited, the Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar invites percentage rate bids in Double cover system for the works through e-procurement as detailed in the table. The bid should be submitted only online in the <http://tenderorissa.gov.in> by eligible class of contractors for construction of building works registered with the State Government and Contractors of Equivalent Grade / Class Registered with Central Government / MES / Railways having registration for execution of civil works can participate in the works on production of definite proof from the appropriate authority. But successful bidder other than State/ MES/Railway/ CPWD equivalent rank has to be registered under the State P.W.D. before signing the agreement. The bidders should have the necessary Portal Enrolment (with his own digital signature certificate).
2. The bidders may submit bid for the works as per the following table :-

- a. Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the website <http://tenderorissa.gov.in> as specified at column-8 above except on Sundays and public holidays.

- b. Bids must be accompanied by Earnest Money Deposit / Bid Security of the amount @ of 1 % of the estimated cost specified for the work in shape of N.S.C. / K.V.P. / Postal Pass Book pledged in favour of Superintending Engineer, Civil Works circle, OPTCL, Bhubaneswar and will have to be in any one of the forms as specified in the bidding document. Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 2 % of the amount put to tender as Bid Security.
- c. The Bid documents will be available in the <http://tendersOdisha.gov.in> from **11.00 Hours of 15.01.2014 to 31.01.2014 upto 17.00 Hours.**
- d. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
- e. Bids shall be received only “**online**” on or before **17.00 Hours of 31.01.2014**
- f. Bids received “on line” shall be opened at **11.30 Hours on 05.02.2014** in the office of the Superintending Engineer (civil), Civil Works Circle OPTCL, Bhoinagar, Bhubaneswar, in the presence of bidders who wish to attend Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of Bids as specified, all the bids will be opened on the next working day.
- g. The bidders shall furnish the attested copies of the valid registration certificate, PAN, Valid VAT clearance, Service Tax Registration Certificate and Labour License along with his Bid failing which his / her bid shall not be considered.
- h. The successful bidder shall have to deposit additional performance security when the bid amount is seriously unbalanced i.e. less than the estimated cost by more than 10 %, in such an event the successful bidder shall deposit the additional performance to the extent of the differential cost of the bid amount and 90 % of the estimated cost in shape of Post Office Saving Bank Account / NSC / KVP / Deposit receipt of scheduled Bank.
- i. Exemption holder like SC/ST contractors should submit attested copy of caste certificates and an application for rate preference for availing the facilities. Engineering contractors should submit an attested copy of Engineering degree certificate and an undertaking in shape an affidavit that he has not availed concession 3 (three) time in the current financial year **2013-14**
- j. For a particular work a bidder can submit only one set of tender paper. Submission of more than one set of tender paper by a bidder for a particular work will be liable for rejection of all such tender paper of the concerned bidder.
- k. Original Bid Security & demand draft towards cost of bid document may be submitted in the office of the undersigned after bid closing date **31.01.2014** and on or before 11.00 Hours on dated **05.02.2014** during office hours on working days failing which the bid will be rejected.
- l. The cost of bid documents in shape of demand draft drawn in favour of **Superintending Engineer, Civil works circle**, OPTCL, Bhubaneswar on any Scheduled Bank mentioned at column-6 above, payable at Bhubaneswar separately towards cost of each tender.
- m. Other details can be seen in the bidding documents.
- n. The authority reserves right to cancel any or all bids without assigning any reason.
