The last date of receipt of the sealed tenders 1.30P.M. of dt. 17.06.2013 and will be opened on the same day at 4.00P.M. in the presence of the Tenders or their representatives. The vehicle can be inspected by the tenderers in respective Grid premises as mentioned against each during office hours.

The intending purchasers are requested to pay 25% of the quoted price for each vehicle as earnest money in shape of Bank draft drawn in favour of E.H.T. (O&M) Circle,OPTCL,Cuttack. The earnest money will be refunded to the unsuccessful tenderers. For successful highest bidder this 25% of EMD will be treated as initial deposit towards cost of the vehicle. The highest tenderer will have to deposit the rest amount (i.e. balance 75%)of the offered amount after the tender is accepted by the competent authority and within seven days of clear instruction from this office. If the tenderer fails to deposit the full amount within the stipulated period the earnest money so deposited shall be forfeited.

In case The vehicle / vehicles is/ are not removed within the prescribed time limit the ground rent at the rate of 1% of the tendered amount for each day of delay will be charged. Where the ground rent for each vehicle so charged exceeds the price deposited the tenderer shall cease to have any right on the vehicle / vehicles. The amount deposited by him shall be adjusted towards the ground rent and the vehicle shall become the absolute property of OPTCL free from encumbrances and to be disposed off by fresh tender.

The authority reserves the right not to accept or reject the highest tender or any other tenders without assigning any reason thereof.
