SECTION -I

INSTRUCTIONS TO TENDERERS

- 1. Sealed Tenders (each complete with all details in the manner here-in-after specified) together with the declaration form duly signed by the tenderer are to be submitted in the office of the General Manager, EHT (Construction) Circle, OPTCL, Sambalpur in sealed covers superscribed with the relevant tender specification number and due date of opening as indicated in the tender notice as well as on the cover page of this specification.
- 2. The specification is divided into four sections: -

 - (ii) Section II General Conditions of Contract.
 - (iii) Section III Technical Specifications.
 - (iv) Section IV Schedules and Forms, Annexure etc.
- 3. The Authority may alter the quantities of material at the time of placing Work Orders. Work Orders may also be spilt up among more than one bidder.
- 4. - 6. The Authority reserves the right to reject the lowest or any other tenders or all the tenders without assigning any reason what so-ever if it is considered expedient in the overall interest of OPTCL.
- 7. The tender should be submitted in person or by Registered post with A.D. Any other means of delivery shall not be accepted. When submitted by post, postal delay shall not be entertained. When delivered in person, the tenders shall be received by a responsible officer of the office of the tender issuing Authority who shall officially acknowledge the receipt of the same.
- Tenders received after due date and time shall be returned unopened. Telegraphic or Fax Tenders shall not be accepted under any circumstances.

9. EARNEST MONEY DEPOSIT:

The tender shall be accompanied by Earnest Money Deposit @ 1% of their total quoted amount in shape of Bank draft drawn in any Nationalized Bank in favour of "EHT (Const.) Circle, OPTCL, Sambalpur" payable at Sambalpur subject to the condition mentioned below.

- No interest shall be paid on Earnest Money Deposit.
- (ii) No adjustment towards Earnest Money Deposit shall be permitted against any outstanding amount with OPTCL.
- (iii) In the case of unsuccessful tenderer, the Earnest Money will be refunded only after finalization of tender. In the case of the successful bidder the Earnest Money will be taken into account in arriving at the Security Money referred to in clause (3) of Section - II General Condition of Contract.
- (iv) Earnest Money / Security Deposit will be forfeited if the tenderer fails to accept the letter of intent and / or Work Orders issued in his favour.
- Tenders not accompanied by Earnest Money shall be (v) disqualified.
- Earnest Money will be forfeited if the tenderer fails to execute (vi) the works.

10. Validity:

The tenders should be kept valid for a period of 180 days from the date of opening of the tenders as notified in the tender notice and subsequent amendment thereof, failing which the tenders will be rejected.

The Tender should be accompanied By Earnest Money Deposit as per Clause-9 of this Section. Tenders not accompanied by Earnest Money Deposit shall be disqualified.

- 12. Bidders must quote their price in line with the specification and conditions. Any deviations from the above shall be considered as an alternate bid. Bids will be evaluated based on the main offer only.
- Overwriting shall be avoided. 13. (i)

- (ii) Overwriting, erasures and other changes shall bear the dated initial of the person signing the tender.
- (iii) In the event of discrepancy or arithmetical error in the schedule of price the unit price shall prevail and the purchaser shall accordingly correct the total price. The above arithmetical correction shall be accepted but the decision of the OPTCL shall be final and binding on the tender.
- (iv) For evaluation, the price mentioned in word shall be taken if there is any difference in figures and words in the price bid.
- (v) The quoted price should be kept valid for 180 days from the date of opening of the tender. Bidders are requested to quote Firm price only.
- (vi) Each page of the tender document shall be signed and sealed with official rubber stamp by the tenderer.
- 14. Price quoted should be inclusive of all taxes and duties.

<u>SECTION -II</u>

GENERAL CONDITIONS OF CONTRACT.

1. **DEFINITION OF TERMS:**

In writing these General Conditions of Contract, the specification and bill of quantity, the following words shall have the meanings hereby indicated, unless there is something in the subject matter or content inconsistent with such construction.

"OPTCL" shall mean the Odisha Power Transmission Corporation Limited represented through the General Manager (Elect.), EHT(C) Circle, OPTCL, At:132/33 KV Grid Sub-station, Ganesh Nagar, Bohidar Nuapali, P.O.: Sankarma, Via: Remed, Dist.: Sambalpur-768 006.

"The Engineer in charge" shall mean the Engineer or Engineers authorised by the General Manager (Elect.), EHT(C) Circle, OPTCL, At: 132/33 KV Grid Sub-station, Ganesh Nagar, Bohidar Nuapali, P.O.: Sankarma, Via: Remed, Dist.: Sambalpur-768 006 for the purpose of this contract.

"OPTCL Engineer" shall mean any Engineering person or personnel authorised by the OPTCL to supervise and inspect the survey work.

"The Contractor" shall mean the successful bidder awarded with the contract or their successor and permitted assigns.

"Contract Price" shall mean the sum named in or calculated in accordance with the provisions of the contract as the contract price.

"General Conditions" shall mean these General Conditions of Contract.

"Specification" shall mean the specification annexed to these General Conditions of Contract and shall include the schedules and drawings attached thereto or issued to the contract as well as all samples and patterns, if any.

"Month" shall mean calendar month.

"Writing" shall include any manuscript, type written; printed or other statement reproduced in any visible form where under seal or underhand.

2. CONTRACT DOCUMENT:

The term "Contract" shall mean and include the General Conditions, specifications, schedules, drawings, work orders issued against the contract, schedule of price or the final general conditions, any special conditions applying to the particular contract specification and

drawings and agreement to be entered into. Terms and conditions not herein defined shall have the same meaning as are assigned to them in the Indian Contract Act falling that in the Orissa General Clauses Act.

3. MANNER OF EXECUTION:

- 3.1 Loading of 4000 nos of 90 KN disc insulators and 2000 nos of 120 KN disc insulators at Grid S/s Udala and unloading of the same at 132/33 KV Grid S/s Padampur including transportation from Grid S/s Udala to 132/33 KV Grid S/s Padampur shall be carried out along with cleaning of weeds and stacking and packaging of insulators in an approved manner as outlined in the technical specification or where not outlined, in accordance with relevant Indian Standard Specification, to the reasonable satisfaction of the Engineer.
- 3.2 The contractor shall within 7 days after the date of acceptance of Work Order, submit to the Engineer, a detail programme for execution of the work for his consent. The contractor shall whenever required by the Engineer also provide in writing for his information the general description of the arrangements and methods which the contractor proposes to adopt for execution of the work.
- 3.3 If at any time, should it appear to the Engineer that the actual progress of works does not confirm to the programme to which consent has been given under sub-clause-3.2, the contractor shall produce at the request of the Engineer a revised programme showing the modification to such programme necessary to ensure completion of the works within the time of completion.
- 3.4 The Tenderer should engage skilled and unskilled labours along with valid labour license and covering all insurances to above labours to the worst fatal and non fatal accidents. OPTCL shall not be held responsible in any way, in this regards.

4. VARIATION, ADDITIONS & OMISSIONS:

The OPTCL shall have the right to alter amend, omit or otherwise vary the quantum of modification (survey) work by notice in writing to the contractor. The contractor shall carry out such variation in accordance with the rates specified in the contract so far as they may apply and where such rates are not available; those will be mutually agreed between the OPTCL and the contractor.

5. INSPECTION DURING LOADING & UNLOADING WORK:

The Engineer-in-charge will be entitled at all reasonable times to inspect and supervise the work. Such inspection will not release the contractor from their obligations under this contract, to perform as per specification and standard. Advance intimation must be given to Engineer-in charge whenever it is needed prior to execution of work.

6. **COMPLETION OF WORK:**

Time being the essence of contract; the loading and unloading work including transportation along with cleaning of weeds and stacking and packaging of insulators must be completed within 15 days from the date of issue of the Work Order.

6.1 TAKING OVER:

Upon receipt of intimation about completion of loading and unloading work including transportation in all respect, OPTCL Engineer-in-charge shall issue a completion certificate in which he shall certify the date on which the transportation, loading and unloading work has been completed. This certificate shall be issued within 7 days of the intimation received from the contractor.

The issuance of a completion certificate shall in no way relieve the contractor of his responsibility for the satisfactory completion of the work in terms of the specification.

7. CONTRACTORS DEFAULT LIABILITY:

The OPTCL may upon written notice of default to the contractor terminate the contract in circumstances detailed hereunder.

- (a) If, in the judgement of the OPTCL the contractor fails to complete the work within the time specified in the contract agreement or within the period for which the OPTCL has granted extension to the contractor.
- (b) If, in the judgement of OPTCL the contractor fails to comply with any of the provisions of this contract.
- (c) In the event OPTCL terminates the contract in whole or in part as provided in paragraph (a) & (b) above, OPTCL reserves the right to engage another contractor or agency upon such terms and in such a manner as he may deem appropriate and the contractor will be liable to the OPTCL for any additional costs as may be required for the completion of survey work in addition to forfeiting all the deposits of the contractor, the contractor is likely to be blacklisted in future for any work of OPTCL.
- (d) In the event OPTCL does not terminate the contract as provided in paragraph (a) & (b) above, the contractor shall continue the performance of the contract in which case he shall be liable to the OPTCL for penalty for delay as set out in this contract until the work is completed.

8. FORCE MAJEURE:

The contractor shall not be liable for any penalty for delay or for failure to perform the contract for reasons of FORCE MAJEURE such as acts of God, acts of public enemy, acts of Government, cyclone, fires, floods, epidemics, quarantine restrictions, strikes, freight embargoes provided that the contractor shall within 10(ten) days from the beginning of such delay notify the OPTCL in writing of the cause of delay. The OPTCL shall verify the facts and grant such extension as facts justify.

9. REJECTION OF WORKS:

In the event of any of the work done by the contractor is found defective in material or workmanship or otherwise not in conformity with the requirement of this contract specification, the OPTCL shall either reject the material and/or work and request the contractor to rectify the same. The contractor on receipt of such notices rectify or replace the defective material and rectifies the work, free of cost. If the contractor fails to do so the OPTCL may,

- (e) at its option rectify such defective work and recover the extra cost so involved plus fifteen percent from the contractor and/or
- (f) terminate the contract for balance work/supplies with enforcement of penalty as per contract.

Defective workmanship will not be accepted under any condition and shall be rejected outright without compensation. The contractor shall be liable for any loss/damage sustained by OPTCL.

10. EXTENSION OF TIME:

If the completion of loading and unloading work including transportation is delayed due to reason beyond the control of the contractor, the contractor shall without delay give notice to the OPTCL in writing of his claim for an extension of time. The OPTCL on receipt of such notice may agree to extend the contract delivery date of the rewinding work as may be reasonable but without prejudice to other terms and conditions of the contract.

11. TERMS OF PAYMENT:

The contractor shall present the final bill after completion of the work being duly inspected and verified by OPTCL Engineer-in-charge or his authorized representative. 100% value of the work done shall be paid within a period of one month on presentation of the final bills subject to taking over as per Clause-6.1. & furnishing a security deposit as per Clause-13 of this Work Order. Taxes and duties as applicable from time to time will be deducted from the bills at the time of releasing the payment. No running bill is permitted.

Sub-Divisional Officer, EHT(Constn.) Sub-Division, Barpalli shall be the Engineer In Charge for this work.

Deputy General Manager (El.), EHT(Constn.) Division, OPTCL, Bolangir shall be the Paying Officer for this work. Bills in triplicate cleared marked as "Original", "Duplicate", "Triplicate" shall be furnished to the paying Officer.

12. PRICE REDUCTION SCHEDULE:

The price reduction schedule shall be imposed @0.5% of the contract price for each calendar week for delay or part thereof subject to maximum 5(five) % of the contract amount, if the works is not executed within the stipulated period.

13. SECURITY DEPOSIT:

The contractor shall furnish security deposit to this office in shape of Demand Draft/Bank Guarantee for an amount of 10% of the total work order value as a contract security within 7 days of receipt of work order. In case of deposit of security deposit through Demand Draft, the same should be made in favour of the "E.H.T. Construction Circle, OPTCL, Sambalpur" on any Nationalized Bank payable at Sambalpur. No interest shall be paid by OPTCL on the security deposit. The same will be refunded after satisfactory completion of work. In case of non-fulfillment of contractual obligations and performance guarantee by the contractor the security deposit shall be **forfeited**.

14. JURISDICTION OF THE HIGH COURT OF ORISSA:

Suits, if any, arising out of this contract shall be filed by either party in a court of law to which the jurisdiction of High Court of Orissa extends.

15. CONTRACTORS RESPONSIBILITY:

15.1 Not withstanding anything mentioned in the specification or subsequent approval or acceptance of the survey work by OPTCL, the ultimate responsibility for satisfactory performance of the work shall rest with the contractor.

16. NON-ASSIGNMENTS:

The contractor shall not assign or transfer the work orders issued as per this contract or any part thereof to anyone else without the prior approval of OPTCL.

17. CERTIFICATES NOT TO AFFECT RIGHTS OF OPTCL:

The issuance of any certificate by OPTCL or any extension of time granted by OPTCL shall not prejudice the rights of OPTCL in terms of the contract nor shall this relieve the contractor of his obligations for due performance of the contract.

18. SETTLEMENT OF DISPUTES:

- 18.1 Except as otherwise specifically provided in the contract, all disputes concerning question of fact arising under the contract shall be decided by OPTCL provided a written appeal by the contractor is made to OPTCL. The decision of OPTCL shall be final to the parties hereto.
- 18.2 Any disputes or difference including those considered as such by only one of the parties arising out of or in connection with this contract shall be to the extent possible be settled amicably between the parties. If amicable settlement cannot be reached then all disputed issues shall be settled by Arbitration as provided in this contract.

19. ARBITRATION:

19.1 If at any time any question, dispute or difference whatsoever arises between the OPTCL and the contractor, upon or in relation to or in connection with this contract, either party may forthwith give to the other a notice in writing of the existence of such question, disputes or

difference and the same shall be referred to the adjudication of three arbitrators, one to be nominated by OPTCL, the other by the contractor and the third by the President of the Institution of Engineers, India. If either of the parties fails to appoint its arbitrator, within sixty (60) days after receipt of notice for the appointment of its arbitrator then the President of Institution of Engineers, India shall have the power at the request of either of the parties to appoint an Arbitrator. A certified copy of the "President" making such an appointment shall be furnished to both parties.

- 19.2 The arbitration shall be conducted in accordance with the provisions of Indian Arbitration Act, 1940 or any statutory modification thereof and shall be held at such place and time in India as the Arbitrators may determine. The decision of the majority of Arbitrators shall be final and binding upon the parties hereto and the expenses of the arbitration shall be paid as may be determined by the Arbitrators.
- 19.3 Performance under the contract shall if reasonably possible continue during the arbitration proceedings and payments due to the contractor by OPTCL shall not be withheld unless they are the subject matter of the arbitration proceedings.

20. LAWS GOVERNING CONTRACT:

The contract shall be constructed according to and subject to the Laws of India and jurisdiction of the Courts of Odisha.

21. LANGUAGE AND MEASURES:

All documents pertaining to the Contract Including specifications, schedules, notices, correspondence, operating and maintenance instruction, drawings or any other writings shall be written in English language. The metric system of measurement shall be used exclusively in this contract.

22. CORRESPONDENCE:

- 22.1 Any notice to the contractor under the terms of the contract shall be served by registered mail or by hand to the authorised local representative of the contractor and copy by post to the contractor's principal place of business.
- 22.2 Any notice to OPTCL shall be served to the General Manager (Elect.), EHT(C) Circle, OPTCL, At: 132/33 KV Grid Sub-station, Ganesh Nagar, Bohidar Nuapali, P.O.: Sankarma, Via: Remed, Dist.: Sambalpur-768 006 in the same manner.

23. SECRECY:

The contractor shall treat the details of the specification and other documents as private confidential and they shall not be reproduced without written authorization from OPTCL.
