#### **INSTRUCTION TO BIDDERS**

The Bidders must read in detail the "Instruction to Bidders" and "General Terms and Conditions" before filling the tender documents.

#### 1. TENDERS:

- A) Bidders must submit their bids with original signature. Only those who have purchased the Tender Specification from this office can submit their Tender. Tenders submitted by other means will be rejected.
- B) Tender must be submitted in sealed cover, subscribed as "Tender call Notice No. 09/2019-20(LOT-I) for Supply of 4 Bolted PG Clamp for ACSR Zebra to Zebra Conductor required for L-Cut jumpering in Tension Towers of 220 KV Narendrapur-Atri DC Line under EHT (O&M) Division, Berhampur" on or before Dated 18.02.2020 and addressed to the General Manager, EHT (O & M) Circle, Berhampur.
- C) Tender shall be submitted either in person or by registered post & any other means of delivery shall not be accepted. Detailed postal address with PIN No., Phone / Fax/Email of bidder must be mentioned in the application requesting for tender document and on the tender bid. The authority is not responsible for receipt of tender after due date due to postal delay or any other reasons. Tenders received after due date due to postal delay or any other reason will not considered. The tenderer who wants to receive the tender paper by post have to deposit additional amount of Rs.100.00 along with the tender paper cost. On-line downloaded Tender Specification Documents from our OPTCL website shall not be accepted.
- D) The bidder is to deposit EMD in shape of Bank Draft drawn in favour of General Manager, EHT (O & M) Circle, Berhampur. The EMD of successful tenderers will be refunded only on written request, but after deposit of security-cum-performance deposit. The EMD of all unsuccessful tenderers shall be refunded on written request after finalization of tender. No interest shall be paid on EMD. No adjustment towards EMD shall be permitted against outstanding amount, if any, remained with the OPTCL.

#### 2. Experience:

The Tenderers should be registered Order suppliers/ Manufacturers. The bidders may submit the copy of past experience, if any regarding supply of similar materials to GRIDCO/ OPTCL or any other state or central PSUs.

#### 3. FORFEITURE OF EMD:

A) In the event the successful tenderer fails to accept the Purchase Order issued in his favour or to execute the order, placed on him, the EMD so deposited shall be forfeited.

The EMD, not claimed for refund within a period of one year from the date of issue of Purchase Order, will be forfeited.

#### 4. INFORMATION ON COMPETITORS:

Bidders have right to know information on competitors only at the time of opening of the bids. No further information on competitors shall be provided at any other

point / stage of the tender without prejudice to Right to Information Act – 2005.

#### **5. OPENING OF TENDERS:**

- A) Copy of PAN Card, GST Registration Certificate & Dealership Certificate (In case of Supplier) must be enclosed with the tender bids.
- **B)** Bidders themselves or their authorized representatives limited to one person only (possessing authorization letter in original) shall be allowed to attend opening event of the tenders.
- 6. The purchaser may alter the quantities of materials at the time of placing orders. Orders may also be split up among more than one tenderer if necessary. The purchaser reserves the right to reject the lowest or any other Tender or all tenders without assigning any reason what so ever.
- **7.** Tender should be prepared clearly and without any overwriting and corrections. Erasures and other changes shall bear the dated initial of the person signing the Tender.
- **8.** In the event of discrepancy or arithmetical error in the schedule of price, the decision of the purchaser shall be final and binding on the tenderer. For evaluation, the price mentioned in words shall be taken if there is any difference in figure and word in the price bid.

#### **GENERAL TERMS AND CONDITIONS**

- 1. <u>Scope of contract</u>:-The scope of contract shall be to deliver materials at destination in accordance with the enclosed Technical Specification (Section-III) and schedule of requirement (Annexure-I).
- **2.** <u>Manner of execution</u>:-All materials should be supplied under the contract shall confirm to the latest publication of relevant IS Specification.
- **3.** <u>Validity</u>:-Tenderers are requested to keep the validity of their offer for a period of 180 Days from the date of opening of tender.
- **4.** <u>Price:</u>-The price quoted by tenderer should be firm, F.O.R. destination inclusive of freight, Insurance, Packing, and Forwarding Charges etc.
- **5.** <u>Taxes</u>:-Taxes, if any shall be mentioned extra.
- **6.** <u>Terms of Payment</u>:-100% payment with Taxes etc. shall be made within 45 Days after receipt of materials in full and in good condition & verification thereof by the consignee.
- 7. <u>Delivery</u>:-The materials in full quantity shall be delivered within 20 days of receipt of purchase order, failing which purchase order shall be liable for cancellation with forfeiture of Earnest money/ Security Deposit.
- 8. Penalty:-If the supplier shall fail to deliver the materials within the delivery period as stipulated under clause No. 7 (Section-II) of this Tender document or any extension granted there to, the purchaser shall recover from the supplier penalty for a sum of half percent (i.e. 0.5 percent) of the contract price for each calendar week or part thereof of delay. However the total amount of penalty shall not exceed 5% (five percent) of the contract. Materials will be deemed to have been delivered only when whole quantity is delivered. If certain quantity is not delivered in time, the supply will be treated as delayed until such time the undelivered quantities are delivered period.
- **9.** Extension of time:-If the delivery of materials is delayed due to reason beyond the control of supplier, the supplier shall without delay give justification. The purchaser on receipt of such notice may agree to extend the contract delivery date if reasonable but without prejudice to other terms and conditions of this contract.
- 10. <u>EMD</u>:- The tenderers are requested to deposit EMD in shape of D.D. Drawn in favour of General Manager, EHT (O & M) Circle, Berhampur. The tender without EMD will be liable for rejection. The D.D for the EMD amount should be enclosed along with original tender paper.

#### 11. Security Deposit:

(i) The tenderers whose offer qualifies for acceptance will be awarded Purchase Order and the supplier shall have to be deposit Security-Cum-Performance Guarantee equal to 10% (Ten Percent) of ordered value in shape of Bank Draft in favour of Dy. General Manager, EHT (O & M) Division, Berhampur within 5 days from the date of issue of Purchase Order. The Security deposit will be released after two months of completion of the guarantee period subject to fulfillment of guarantee stated under Clause No.-12 on a receipt of application for this purpose. No interest shall be paid to the supplier towards the security deposit so deposited by the supplier. Security Deposit will be forfeited if the successful tenderer fails to execute the order placed on him.

A Composite Bank Guarantee as per the Proforma enclosed at Annexure-III of the specification for 10% [ten percent] of ordered value shall be furnished from any

- 12. <u>Guarantee</u>:- The materials covered under this contract should be guaranteed for trouble free and satisfactory performance against any defect in design, materials and workmanship for a Period of at least 18 (Eighteen) Months from the last date of delivery or 12 (Twelve) Months from the date of use, whichever is earlier. Any defect noticed during this period should be rectified / replaced by the firm free of cost provided such defects are due to faulty design, bad workmanship or bad materials used. The replaced materials should also have similar guarantee. In the event of any breach on default in all or any condition of purchase order Security Deposit will be forfeited.
- 13. <a href="Insurance">Insurance</a> of materials is to be done by the supplier at their own cost. The responsibility of delivery of the materials at destination in good condition rests with the supplier. Any claim with the insurance company Railway authority/ Road transport authorities arises due to loss or damage in transits has to be settled by the supplier. The supplier shall undertake free replacement of materials damage or lost which will be reported by the consignee within 20 Days of the receipt of the materials at destination without waiting for the settlement of the claims with the carriers.
- **14.** <u>Despatch Instruction</u>:- The materials should be securely packed and dispatched by Rail/ road transport to **220/132/33 KV Grid Sub-Station, Narendrapur**. The cost of transportation will be borne by the supplier.
- **15.** <u>Consignee</u>: The SDO, 220/132/33 KV Grid Sub-Station, Narendrapur is the consignee & verifying officer.
- **16.** <u>Paying Officer</u>: The **DGM, EHT (O&M) Division, Berhampur** is the paying officer for this contract.

#### 18. Submission of Sample:-

The Sample of all bides shall be scrutinized by a Sample Scrutiny Committee, to be constituted by the purchaser. If required, the bidder or their authorized representatives may be informed to remain present during scrutiny of sample. The date of sample scrutiny will be intimated to the bidders in due course. #### **TECHNICAL SPECIFICATION**

1. Scope:-This specification covers the design, manufacture, assembly, inspection, testing, packing and delivery of PG Clamps suitable for ACSR Zebra Conductor (54/7/3.18). The material offered shall be complete with all components that are necessary for efficient operation. Such parts shall be deemed to be within scope of the supply whether specifically mentioned or not. PG Clamps shall confirm in all respect to the highest standard of engineering, design, and workmanship and shall be capable of performing trouble free continuous operation.

#### 2. Climatic Conditions:-

The overall climate is moderate hot, humid, tropical, highly polluted and conductive to rust and fungus growth. The clamps shall be given tropical and fungicidal treatment and shall be capable of satisfactory operation under the hot and humid climatic conditions that would prevail at sites. The climatic conditions are prone to wide range of variation in ambient conditions. The materials offered shall be suitable for installation at any of the 220 KV Lines in Odisha.

- **3.** All casting shall be free from shrinking, blow holes, surface blisters, cavities, cracks, other defects and quality of product shall be uniform throughout. All sharp edges and corners shall be blurred and rounded off.
- **4.** The Clamps shall be designed and manufactured in such a way so as to have minimum contact resistance.
- **5.** The clamps offered shall be inherently resistive to atmospheric corrosion or be suitable to protect against corrosion both during storage as well as in service.
- 6. The clamps shall not cause any damage to the conductor in any way.
- 7. No part of a clamp shall be less than 15 mm thick for fittings with ACSR Zebra conductor.
- **8.** All ferrous parts shall be hot dip galvanized confirming to IS:2633.
- **9.** Clamps shall be designed to be corona free in accordance with the requirements stipulated in

IS: 5561

**10.** The required bolts and nuts for the clamps must be hot dip galvanized/stainless steel.

#### 11. Material:

The clamps shall be made of materials listed below:-

i) For connecting ACSR Zebra conductor aluminum alloy casting conforming to designation A6 of

IS: 617.

- **ii)** Bolts, nuts, plain washers and spring washers for the item: Hot dip galvanized mild steel/stainless steel.
- **12.** The clamps shall be designed to withstand the flow of continuous current as follows:

ACSR Zebra Conductor- 2000 Amp

The temperature rise when carrying full load current shall not exceed 45°C above site ambient temperature of 40°C.

#### 13. Designs:-

Responsibility of satisfactory design of the clamps to safely withstand the specified mechanical stresses and carry the rated current without exceeding the temperature rise specified, shall solely rest with the bidder. For this purpose, a minimum factor of safety 2 (two) shall be taken into account.

#### 14. Test:-

The clamps shall be subjected to following Type, Acceptance and Routine Tests.

#### 16. Type Test Certificates:-

- (a) True copies of all the Type Test Certificates of Govt. recognized Laboratory in respect of the offered item only shall be furnished with the offer.
- (b) Offers without samples and type tests reports will be out rightly rejected.

#### 17. General:-

- **a).** All ferrous parts shall be hot dip galvanized, after all machining has been completed. Nuts may however be tapped (threaded) after galvanizing and the threads oiled. Spring washers shall be electro-galvanized. The bolt threads shall be undercut to take care of the increase in diameter due to galvanizing. Galvanizing shall be done in accordance with IS-2629-1985 and shall satisfy the tests mentioned in IS2633-1986.
- **b).** The zinc coating shall be perfectly adherent of uniform thickness, smooth, reasonably bright, continuous and free from imperfections such as flux, ash, rust stains, bulky white deposits and blisters. The zinc used for galvanizing shall be of grade Zn 99.95 as per IS 209-1979.
- **c).** All current carrying parts shall be so designed and manufactured that contact resistance is reduced to minimum.

#### Mechanical design:-

The Aluminum alloy should be based on Aluminum – Magnesium – Silicon system. The physical properties of the Aluminum Alloy is as follows:

- (1) Melting temperature = 620°C.
- (2) Density = 2.7 Kg/dm3.
- (3) Co-efficient of linear expansion per °C = 23 X 10-6
- (4) Modules of elasticity in Kg / mm2 = 5200 to 5600.
- (5) Surface hardness = 80 BHN.

#### TECHNICAL PARTICULARS.

- (1) The clamps with accessories should be as per drawing attached in this Tender Paper.
- (2) The clamps should be as per IS: 5561, 1970.
- (3) The clamps should be suitable for ACSR Zebra to Zebra Conductor.
- (4) All sharp corners should be rounded off.
- (5) All ferrous parts are to be electro galvanized.
- (6) Contact surface are to be machine finished.
- (7) Short time current rating should be 40 KA for 1 sec.
- (8) Max. Temperature rise should be 35°C over ambient temperature 50°C at rated current of ACSR Zebra Conductor.
- (9) All nuts & bolts should be electro galvanized passivated with Zinc Chromate Solution.


