The travel agencies/ vehicle owner should have to submit the following documents along with the 2 set of Tender Papers.

i) Photocopy of Registration of Travel agency/ copy of Registration certificate of vehicle issued by RTO in name of the Agency / Owner

- ii) Photocopy of Goods & Service Tax Registration Certificate from the Central Excise Dept.
- iii) Photocopy of Valid PAN card.
- iv) Photocopy of valid 3years State Road permit to run the vehicles within the Odisha.
- v) Photocopy of the valid First Party Insurance
- vi) Photocopy of contract carrying certificate/ Taxi permit
- vii) Photocopy of valid non-pollution certificate.
- Viii) Photocopy of fitness certificate.
- ix) Photo copy of valid driving license of driver.

The vehicle should not be more than 03 years old from the date of registration of the vehicle.

The Fuel (Diesel) and Engine Oil required for the vehicle for department use shall be reimbursed by OPTCL such as (i)Engine Oil (Mobil) – One Ltr. on every 750 KM of running(ii)H.S.D @ 10 KM/Ltr. All other expenses like replacement of Engine Oil, replacement of spare parts, maintenance charges etc., are to be borne by the Travel Agency/Owner of the vehicle.

The tender specification for the same shall be obtained from the Office of the undersigned on payment of requisite amount (non-refundable) in shape of cash/DD of any nationalized Bank in favour of Deputy General Manager, E&MR, Division,OPTCL, Bolangir. The bid must be accompanied the EMD receipt against cash paid /DD in favour of Deputy General Manager, E&MR, Division, OPTCL, Bolangir, and will be opened in presence of Tenderers or their authorized representative (one person only) with original authorization letter, if present during opening of tenderer. Incomplete Tender and Tender without EMD shall be rejected. The Original DD/ money receipt for the EMD should be enclosed along with original tender paper.
