- 11 Bid must be delivered in the tender box having identification NO. E.E. CWD- II, TENDER CALL NOTICE NO 06 of 2022-23.
- 12 Bid security declaration – if the bidder withdraws or modifies his bid during the validity period, he will be suspended for a time period of 1 year.
- 13 Bid document can be purchased from the office mentioned in the table column 7 against a non-refundable fee towards cost of the documents as indicated in column 5 of the table in cash.
- 14 Bidding documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs. 500.00 over cost of documents. The Executive Engineer, Civil Works Division No-II, OPTCL, Burla will not be held responsible for the postal delay if any in the delivery of the documents or non-receipt of the same in time.
- 15 The Bids will be **opened on dated 29.03.2023 at 11:30 A.M.** in the office of the undersigned in the presence of the bidders or their authorized agent who wish to attend. If the office happens to be closed on the last date of sale/receipt and opening of the bids as specified the bids will sold/received and opening on the next working day at the same time and venue.
- 16 The bidders shall furnish the attested copies of **all valid Registration Certificates like, PAN Card, GST Registration Certificate and Contract Licence** along with the Bid failing which his/her bid shall not be

considered. The bidders shall have to furnish an affidavit at the time of submission of the bid about the authentication of all the tender documents failing the bid shall be cancelled as non-responsive and thus liable for rejection.

17. The bidder shall have to furnish EMD with the bid failing the bid shall be considered as non-responsive and liable for rejection.
18. The amount put to tender is inclusive of 1% Cess, which will be adjusted during payment of bills.
19. The bidder whose quoted rate is less than the estimated cost by more than 14.99% will be rejected.
20. Additional Performance Security shall be obtained from the bidder before drawl of agreement.
