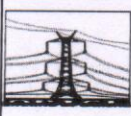

The Tender shall be received Up to 02.00 PM of dated 18.12.2021 & will be opened at 04.00 PM on dt.21-12-2021 in the Office of the undersigned in the presence of the Bidders (or) their Authorized Representatives present if any. If any of the above date happens to be a holiday, the next working day will be the corresponding effective date. One Tender paper shall be issued to one Bidder. E.M.D Rs.4449.00 (Four thousand four hundred forty nine) only should be deposited in shape of Demand Draft only in favour of DGM, E.H.T. (O&M) Division, Kesinga & payable at Kesinga drawn on any Nationalized bank along with Self Attested Copy of Valid Civil Contract License, PAN and GST Registration Certificate failing which the tender will be liable for rejection.

The bidder should superscribe only the “Tender Call Notice No. & Date of Opening of the tender on the body of the Sealed Envelope”. Bidder should not write their name or any other information on the body of the sealed envelope.
