Sealed tenders are invited from the eligible bidders for hiring of diesel run commercial registered light motor vehicles on monthly hire basis for a period of **One year** for different units under EHT (O&M) Circle, Cuttack as follows:

- a) **220/132/33KV Grid Sub-station, Paradeep**
- b) **132/33KV Grid Sub-station, Choudwar**
- c) **EHT (O&M) Division, Paradeep**
- d) **EHT (O&M) Division, Choudwar**

Normally the vehicles will be stationed at respective Sub-Divisions or Divisions only.

**The vehicle to be provided should not be more than 2 (two) years old as on the date of opening of tender. Fuel reimbursement – Diesel @ 10 KM/ Ltr for Mahindra Bolero or equivalent and Lubricant @ 750 KM/ Ltr.** The tender specification can be obtained from the office of the undersigned, on payment of dues as mentioned below during office hours from **Dt.17.07.2019 to Dt.29.07.2019**. The tenders shall be received up to **3 P.M.** on **Dt.30.07.2019** and shall be opened at 3.30P.M on the same date in the office of the undersigned.
