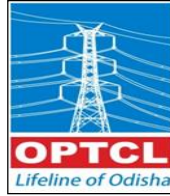

1. SUBMISSION & OPENING OF TENDER: - Tender shall be submitted with other documents in duly sealed envelope super scribed on the body of envelope “Tender for Construction of Safety zone boundary (Length 155m)in west direction of 132KV Switchyard at **400/220/132/33KV Grid S/S, Meramundali** under EHT (O&M) Division, Meramundali”. The bidder should write only Tender Specification No, the name of work and date of opening of the tender on the body of the sealed envelope. Bidder should not write their name or Agency name on the body of the sealed envelope which may make the offer liable for rejection.

2. RIGHT & AUTHORITY FOR REJECTION: - Tenders received after due date and time will be summarily rejected. The. General Manager (Electrical), E.H.T. (O&M) Circle,Chainpal reserves the right to reject any or all of the tenders without assigning any reason thereof.

3. VALIDITY OF OFFER: - The offer should be firm and valid for a period of at least 180 days from the date of opening of tenders. Unless the tender will be rejected.

4. EARNEST MONEY DEPOSIT:- The tenderers are required to submit EMD amounting to Rs 10000.00 /-in shape of Cash/ Bank Draft in favour of EHT (O&M) CIRCLE, CHAINPAL payable at UCO Bank, TTPS branch otherwise tender will be out rightly rejected. 6. SECURITY DEPOSIT: - The successful tenderers will be required to deposit a Security Deposit-cum-Performance Guarantee amounting to 10% of the contract value valid up to two months after the guarantee period shall be deposited within 10 days (Ten) days of placement of the Work order in the shape of Cash/DD/Composite B.G. from a Nationalized Bank, drawn in favour of EHT (O&M) Circle, Chainpal, UCO Bank, TTPS Branch which will be refunded after two months of completion of the Guarantee period on written request subject to approval of guarantee certificate. Security Deposit not claimed for refund within three years from the date completion of Guarantee period shall be forfeited.

7. COMMENCEMENT & COMPLETION OF WORK: - The works awarded should be commenced from 15 days of the award of the contract and completed **within 60 days**. If the work could not be completed within scheduled date due to any valid reason, then completion period may be extended on written request by the Bidder.

If the work will not commence & complete within the stipulated period, then the price reduction should be imposed as per clause No.08 of SECTION-III.

8. PRICE REDUCTION SCHEDULE: In case the executing agency fails to complete the entire work within the time specified, OPTCL shall recover from executing agency price reduction schedule for a sum of half%(0.5%) of the taxable value of the contract of the work for each calendar week of delay or part thereof of the entire work. However, the total amount of the price reduction shall not exceed 5% of the taxable value of the contract.

9.ADDITIONAL PERFORMANCE SECURITY:- Additional performance security i.e. the differential amount of the bid amount and the estimated cost shall be deposited in shape of Bank Guarantee / Term Deposit Receipt pledged in favour of General Manager, EHT (O&M) Circle, Chainpal (BG in the prescribed format of OPTCL) **within 05 days by the successful bidder** after opening of the tender. The same amount shall be released / refunded after execution of the work without any interest. 10. TERMS OF PAYMENT: - 90% payment with taxes and duties will be paid after completion of the work in all respect which shall be certified by the executing officer subject to approval of guarantee certificate and availability of funds and balance 10 % will be paid after completion of Guarantee period..

11. GUARANTEE PERIOD: - The work done by the contractor as per contract specification should be guaranteed for satisfactory operation and against any defects, in materials & the workmanship for a period of 18 months from the date of completion of the work or 12 months from the date on which material has been put to service, whichever is earlier. The above guarantee certificate shall be furnished in triplicate to the undersigned for approval. Any defects noticed during the period shall be rectified by the contractors at its own cost, without any financial burden to OPTCL.

The venue of arbitration will be Bhubaneswar.

15. CONSIGNEE: - The Manager, 400/220/132 kV Grid S/S, Meramundali is the consignee for the contract.

16. PAYING OFFICER: - The DGM, EHT (O&M) Division, Meramundali is the paying Officer for contract.

17. JURISDICTION OF COURT: - Suits if any, arising against the work order to be issued to the Bidder shall be filled by either party in any court of law to which the jurisdiction of Odisha High Court extends.

18.SAFETY PRACTICE: - The Bidder must be followed the OPTCL safety Rule while performing the work. The workmen must be provided with Safety equipment by the contractor while performing the works .No deviation will be allowed and the consignee has got any power to stop the work at any time on the breach of safety practice.

19.OUTRIGHT REJECTION OF TENDERS: - The tenders shall be liable for outright rejection if the following have not been complied.

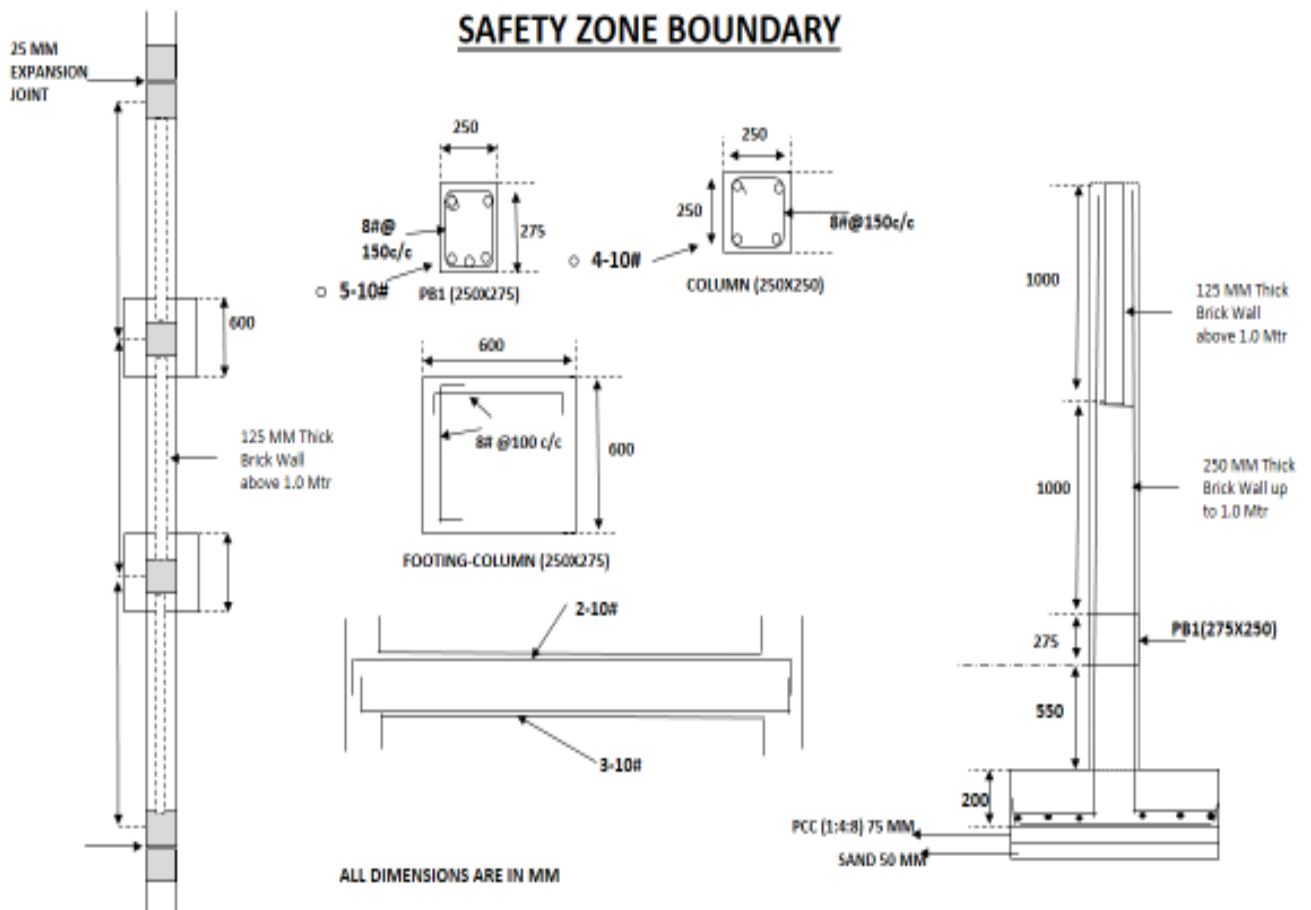

The Scope of work: - The scope of works must covers the followings & as per Drawing.

- i) Specification and all other dimensions are as per drawing mentioned below.
- ii) 53 grade cement shall be used of any reputed manufacturers of cement inside the state.
- iii) Pond watering shall be provided for RCC work as per the instruction of site in-charge. The contractor has to arrange adequate supply of clean water required for the work whenever necessary at his/her own cost.
- iv) The successful bidder shall make his own arrangement for all materials and T&Ps such as concrete mixture, vibrator, PRR etc. for the work.
- v) The quoted rate for the work will deem to include all incidental items which may necessary for construction of benchmarks, level pillars, profiles, benching levels of the ground etc. where required. No extra payment or claim will be admissible on this ground.
