1. For and on behalf of Odisha Power Transmission Corporation Limited, the Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar invites percentage rate bids in **Double cover system** for the works through e-procurement as detailed in the table. The bid should be submitted only online in the <http://tenderorissa.gov.in> by eligible class of contractors for construction of building works registered with the State Government and Contractors of Equivalent Grade / Class Registered with Central Government / MES / Railways having registration for execution of civil works can participate in the works on production of definite proof from the appropriate authority. But successful bidder other than State/ MES/Railway/ CPWD equivalent rank has to be registered under the State P.W.D. before signing the agreement. The bidders should have the necessary Portal Enrolment (with his own digital signature certificate).

2. The bidders may submit bid for the works as per the following table :-

3. The prospective bidders are advised to register their user ID, Password, company ID from website www.tenderwizard.com/OPTCL by clicking on hyper link "Register Me".

4. Bids must be accompanied by and Earnest Money Deposit / Bid Security of the amount @ of 1 % of the estimated cost specified for the work in shape of **Deposit Receipt of Schedule Bank /N.S.C. / K.V.P. / Post Office Savings Bank Account /Post Office Time Deposit Account** pledged in favour of Superintending Engineer, Civil Works Circle , OPTCL, Bhubaneswar and will have to be in any one of the forms as specified in the bidding document. Bidders desirous to hire machineries or equipment's from outside the State or owned but deployed outside the state are required to furnish 2 % of the amount put to tender as Bid Security.
5. The Bid documents will be available in the <http://tenderwizard.com/OPTCL> from **11.00 Hours of 21.05.2015 to 20.06.2015 upto 15.00 Hours**
6. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
7. Bids shall be received only “**online**” on or before **17.00 Hours of 20.06.2015**
8. The Cover-I(Techno-Commercial Document) of the Bids received “on line” shall be opened at **11.30 Hours on 25.06.2015** in the office of the Superintending Engineer (civil), Civil Works Circle, OPTCL, Bhoinagar, Bhubaneswar, in the presence of bidders who wish to attend Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of Bids as specified, the bids will be opened on the next working day. The date of opening of Cover-II(BOQ) will be communicated in due course of time to the qualified bidders of Cover-I.
9. The bidders shall furnish the attested copies of the valid Contract Licence,Pan,VAT-612,Service Tax Registration Certificate(ST-2), Solvency Certificate from a Nationalised /Scheduled Bank issued within last 6(Six) month, Copy of Balance Sheet of last Three Years(duly certified by a Chartered Accountant),list of works executed with in last three years, list of works in hand along with self-attested copies of supporting documents & other documents as mentioned in DTCN along with his/her Bid failing which his / her bid shall not be considered.
10. The successful bidder shall have to deposit additional performance security when the bid amount is seriously unbalanced i.e. less than the estimated cost by more than 10 % and within 15%, in such an event the successful bidder shall deposit the additional performance security to the extent of 1.5 times of the differential cost of the bid amount and 90% of the estimate cost in shape of Post Office Saving Bank Account / NSC / KVP / Deposit receipt of scheduled Bank.
11. Exemption holder like SC/ST contractors should submit attested copy of caste certificates and an application for rate preference for availing the facilities. Engineering contractors should submit an attested copy of Engineering degree certificate and an undertaking in shape an affidavit that he has not availed concession 3 (three) time in the current financial year **2015-16**

12. For a particular work a bidder can submit only one set of tender paper. Submission of more than one set of tender paper by a bidder for a particular work will be liable for rejection of all such tender paper of the concerned bidder.
13. The packet super scribing “*Construction of office building(Three Storey PEB) of Gridco at Saheednagar,Bhubaneswar*” and containing cost of bid document & EMD/Bid Security in original, may be submitted in the office of the undersigned after bid closing date **20.06.2015** and on or before 17.00 Hours on dated **24.06.2015** during office hours on working days failing which the bid will be rejected.
14. The documents uploaded by the bidders will be verified with originals from 12.30 hrs of 26.06.2015 to 30.06.2015 up to 17.00 hrs during the office hours on working days failing which the bid will be rejected.
15. The cost of bid documents in shape of demand draft drawn in favour of Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar on any Scheduled Bank mentioned at column-6 above, payable at Bhubaneswar separately towards cost of each tender.
16. Experience certificate furnished below the rank of Executive Engineer of Government Department/Public Sector Undertaking or below equivalent rank in private firms will not be accepted. The original agreement in support of experience certificate submitted by the bidder will be verified before opening of the financial bid.
17. The bidder is required to furnish the list of completed works of Costing between ₹300.00 lakh to ₹ 400.00 lakh during last Three Financial Years.
18. The bidder is required to furnish Solvency Certificate of ₹ 100.00 Lakh from a Nationalised /Scheduled Bank issued within last 6(Six) months.
19. The bidders are to submit Balance Sheet of last 03(Three) financial years i.e. from 2012-13 to 2014-15 duly certified by Chartered Accountant and the turn over should be of ₹ 600.00 Lakh in an average of last 03 financial years.
20. The bidders are to submit an affidavit certifying the documents & information furnished by them are genuine
21. The bidders shall have to submit non-refundable amount of **₹ 5618 /- (Rupees five thousand six hundred eighteen only including service tax)** towards the tender processing fee in the form of Demand draft, drawn in favour of **K.S.E.D.C.Ltd, Payable at Bangalore**.
