If the office happens to be closed on the last date of sale/receipt and opening of the bids as specified the bids will sold/received and opening on the next working day at the same time and venue.

The bidders shall furnish the attested copies of all valid registration certificates, PAN Card, Valid VAT clearance, Service Tax Registration Certificate along with the Bid failing which his/her bid shall not be considered. The bidders shall have to furnish an affidavit at the time of submission of the bid about the authentication of all the tender documents including E.M.D. failing the bid shall be considered as non-responsive and thus liable for rejection.



Exemption holder like SC/ST contractors should submit attested copy of caste certificate and an application for the rate preference for availing the facilities, Engineering Contractors should submit an attested copy of Engineer Degree Certificate and an undertaking in shape an affidavit that he has not availed concession 3(three) times in the current financial year 2014-2015.


