**CONTRACTUAL ENGAGEMENT OF RETIRED ELECTRICAL ENGINEER AS TRAINER /
RETIRED TECHNICIAN AS INSTRUCTOR**

Odisha Power Transmission Corporation Limited (OPTCL), a state owned power utility organisation in Odisha engaged in the business of Transmission of electricity with a vision to emerge as one of the leading utilities in the country in Transmission space, invites applications from retired Electrical Engineers (both Degree / Diploma) for engagement as Trainer and retired ITI qualified technician as Instructor on contractual basis for a temporary period of one year, for imparting training (both class room as well as on-job-training) in the area of operation and maintenance of Grid Sub-stations and Transmission Lines as well as in Distribution of electrical power.

1. Posts

i) **Trainer** : Two Retired Electrical Engineers (Degree / Diploma) not below the rank of Asst. Manager will be engaged as Trainer for imparting training (both class room as well as on-job-training) at OPTCL Power Training Centre, Chandaka.

ii) **Instructor** : One Retired ITI qualified Technician will be engaged as Instructor for imparting training (both class room as well as on-job-training) to technicians at OPTCL Power Training Centre, Chandaka.

2. Eligibility Conditions:

TRAINER

- (a) Retired Electrical Engineer (Degree / Diploma) not above the age of 63 years having good service records and who are physically fit will be eligible to apply.
- (b) They should have at least 15 years of experience in any Transmission / Distribution utility with proven ability as Trainer.
- (c) Officers against whom departmental proceedings or criminal cases are contemplated or pending or who have been penalized for misconduct during the period up to five years preceding their retirement will not be considered for engagement.

INSTRUCTOR

- (a) Retired ITI qualified Technicians not above the age of 63 years having good service records and who are physically fit will be eligible to apply.
- (b) They should have at least 15 years of experience in any Transmission / Distribution utility with proven ability as Trainer
- (c) Persons against whom departmental proceedings or criminal cases are contemplated or pending or who have been penalized for misconduct during the period up to five years preceding their retirement will not be considered for engagement.

3. Selection Process:

Selection will be made through personal interview by a Selection Committee.

4. Tenure, Terms & Conditions:

- (a) The engagement will be made for a period of one year, which may be extended further depending on satisfactory performance and requirement of OPTCL.

- (b) **Trainer** : The Retired Electrical Engineer will be engaged as Trainer on contractual basis on fixed remuneration of Rs.15,000/- per month.

Instructor : The Retired ITI qualified Technician will be engaged as Instructor on contractual basis on fixed remuneration of Rs.8,000/- per month.

- (c) He shall not be eligible to get Dearness Allowance or any other Special Pay or Allowance, over & above the consolidated remuneration.

- (d) During the period of contractual engagement, he shall be entitled to get Traveling Allowance for approved tours in line with the Corporation's prevailing norms.

- (e) He will be entitled for mobile reimbursement of Rs 500/-p.m.

- (f) The engagement will be terminated at any time by OPTCL for dis-satisfactory performance, on notice of one month, and in cases of any misconduct including but not limited to misappropriation, negligence or causing loss to OPTCL without any prior notice.

5. Procedure to Apply

The interested candidates may apply in the prescribed format to the undersigned along with the following documents: (i) Proof of Experience (ii) 2 nos. of recent passport size photographs. The envelope containing application
