### SCOPE OF THE WORK & OTHER CONDITIONS OF CONTRACT

#### **1. SCOPE OF CONTRACT:**

The scope of contract shall be delivered free on road transport at destination or at our OPTCL site.

#### **2. PRICE/RATE:**

a. The price quoted should be firm, F.O.R. destination inclusive of freight, insurance, packing forwarding charges inclusive discounts if any.

#### **3. DESTINATION:**

Different Grid sub-stations/Divisions under the Circle as mentioned below.

- i. 220/33 KV Grid Sub-Station, Balimela for materials of EHT (O&M) Division, Jayanagar.
- ii. 132/33 KV Grid Sub-Station, Akhusingh and Parlakhemundi for materials of EHT (O&M) Division, Therubali.

#### **4. VALIDITY:**

The rate with terms and conditions of the offer shall be valid for a minimum period of 180 (one hundred eighty) days from the date of opening of tender.

#### **5. TERMS OF PAYMENT:**

100 % (Hundred Percent) payment with taxes etc. shall be made after receipt of materials in full and in good condition and verified thereof by the consignee subject to availability of funds from the Head quarters office.

#### **6. PENALTY:**

If the supply is not made within the stipulated delivery period the Penalty shall be imposed @ 0.5 % (Half Percent) per week subject to a maximum of 5% (five percent) of such portion of contract which remain undelivered within the stipulated period. The date of receipt shall be treated as the date of delivery. The imposition of penalty is however subject to force major condition

#### **7. DELIVERY:**

The materials in full quantity shall be delivered at 220/33 KV Grid S/S, Balimela and 132/33 KV Grid S/S Akhusingh within 60 days of issue of purchase order. An early delivery shall be preferred.

#### **8. SECURITY DEPOSIT:**

The successful tenders will be required to deposit a sum amounting to 10 % (Ten percent) of the value of the contract in shape of DD/Pay order with the General Manager.

EHT (O&M) Circle, Jeypore, within 2(two) weeks of receipt of work order & which will be released after Completion of the guarantee Period, on written request, duly verified by the Consignee. In the event of breach or default in all or any conditions of the purchase order, the General Manager (Elect.), EHT (O&M) Circle, Jeypore may forfeit the whole amount of Security Deposit. The security deposit shall not carry any interest.

**9. GUARANTEE:**

The materials covered under this contract should be guaranteed for trouble free and satisfactory performance against any defect in designing materials and workmanship for a period of at least 18 (eighteen) months from the date of delivery of 12 (twelve) months from the date in which the materials are put to service, whichever is earlier. Any defects noticed during this period should be rectified/replaced by the firm free of cost to OPTCL provided such defects are due to faulty design, bad workmanship or bad material used. The replaced materials also have similar guarantee.

**10. AUTHORITY:**

**11. VAT & I.T. PAN :**

Clear xerox copies of valid VAT Registration Certificate, PAN & VAT Clearance Certificate, Dealership Certificate on the date of opening of tender should be submitted along with tenders without which tender will be rejected.

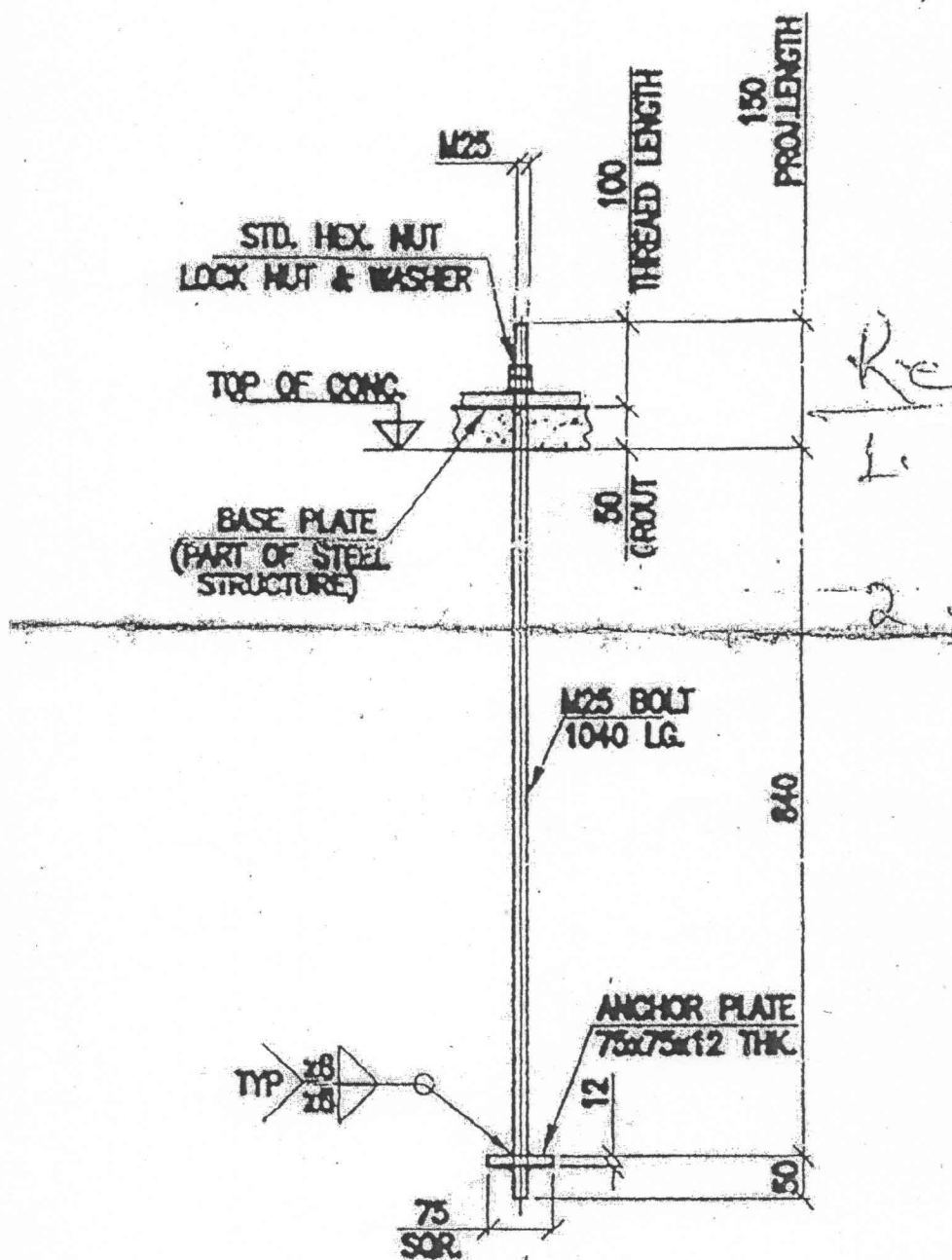

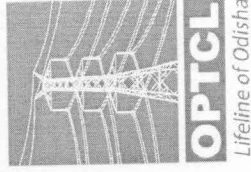
