1. GENERAL INFORMATION TO THE BIDDERS

I. Scope of work: Scope of work comprises supply, installation, commissioning and integrating all components of the Automatic fire fighting equipment at Server, Network, UPS rooms and IT Store of OPTCL,GRIDCO & SLDC along with other accessories that meet the full functionality, provide the maintenance services during the warranty period of the systems.

II. DEFINITION OF TERMS:

In writing these General Conditions of Contract, the Specification and bill of quantity, the following works shall have the meanings hereby indicated unless there is something in the subject matter or contract in consistent with such constructions.

(a) "The Purchaser" shall mean the ODISHA POWER TRANSMISSION CORPORATION LTD or OPTCL.

- (b) "The Engineer" shall mean the engineers appointed by the Purchaser for the purpose of this contract.
- (c) "Purchaser's representative" shall mean any person or persons or consulting firm appointed and remunerated by the Purchaser to supervise, inspect, test and examine workmanship and materials of the equipment to be supplied.
- (d) "The Contractor" shall mean the Bidder whose bid has been accepted by the Purchaser and shall include the Bidders executions, administrators successors and permitted agencies.
- (e) "Contract Price" shall mean the sum named in or calculated in accordance with the provisions of the contract as the "contract price" which shall include packing, forwarding freight, Insurance, Excise Duty, Sales Tax, Octroi and other taxes and duties if applicable.
- (f) "General Condition" shall mean these General Condition of Contract.
- (g) "The Specification" shall mean the specification annexed to or issued with the General Conditions and shall include the schedules and drawings attached thereto as well as all samples and pattern, if any.
- (h) "Month" shall mean of calendar month.
- (i) "Writing" shall include any manuscript, typed/hand written/ printed or other statement re-produced in any visible form and whether under seal or under hand.
- (j) "F.O.R. Destination" costs shall mean the cost of equipment and material at the consignee's store (Schedule K). The cost is exclusive of Excise Duty, Sales Tax and other local Taxes, but is inclusive of packing, forwarding and insurance & Freight charges.
- (k) The "term" contract shall mean & include General Conditions, Specifications, and Schedules, Drawings, form of tender, covering letter, schedule of prices or the final General Condition, any special conditions applying the particular contract, specifications and drawings and agreement to be entered in.
- (I) Terms and condition not herein defined shall have the same meaning as are assigned to them in the Indian Contract Act, failing that in the ODISHA General Clauses Act.

III GUIDELINES FOR THE BIDDER:

(a) The Contractor shall examine the instructions to Tenderers, General Conditions of Contract, Specification, the Schedules of Quantity and delivery and rest of the bidding document to satisfy himself as to all terms and conditions and circumstances affecting the contract price. He shall quote price (s) according to his own allowances except as otherwise provided therein will be levied. The purchaser shall not be responsible for any misunderstanding or incorrect information obtained by the contractor other than information given to the contract in writing by the purchaser.

10. INSPECTIONS AND TESTING

The Purchaser or its representative shall have the right to inspect and/or to test the Goods to confirm their conformity to the Contract specifications at no extra cost to the Purchaser. The Purchaser shall notify what inspections and tests the Purchaser requires and where they are to be conducted. The Purchaser shall notify the Supplier in writing, of the identity of any representatives retained for these purposes.

The inspections and tests may be conducted on the premises of the Manufacturer or Supplier at point of dispatch. The Supplier shall provide all reasonable facilities and assistance, including access to drawings and production data, shall be furnished to the inspectors at no charge to the Purchaser.

Should any inspected or tested Goods fail to conform to the Specifications, the Purchaser may reject the Goods, and the Supplier shall either replace the rejected Goods or make alterations necessary to meet specification requirements free of cost to the Purchaser.

The Purchaser's right to inspect, test, and where necessary, reject the Goods after the Goods' arrival at Project Site shall in no way be limited or waived by reason of the Goods having previously been inspected, tested, and passed by the Purchaser or its representative prior to the Goods' shipment.

f. CONTRACT'S DEFAULT LIABILITY:

i) The purchaser may upon written notice of default to the contractor terminate the contract in circumstances detailed hereunder.

- a) If in the judgment of the purchaser, the contractor fails to make delivery of equipment within the time specified in the contract or within the period for which extension has been granted by the purchaser, to the contractor.
- b) If in the judgment of the purchaser, the contractor fails to supply with any of the other provisions of this contract.
- ii) In the event purchaser terminates the contract in whole or in parts, the purchaser reserves the right to purchase upon such terms and in such a manner as he may deem appropriate, equipment similar to that of terminated and the contractor will be liable to the purchaser for any additional costs for such similar Software and/or for penalty for delay as defined in penalty clause. Clause-25 Section –III until such reasonable time as may be required for the final supply of Fire fighting equipment Software. Execution of contract under such circumstances shall however be on express written willingness of both the parties.

13. REJECTION OF Supplied Materials:

In the event on any of the materials/ equipment supplied by the contractor is found defective in materials or workmanship or otherwise not in conformity with the requirements of the contract specification, the purchaser shall reject the materials/equipment and request the contractor in writing to rectify the same. The contractor on receipt of such notification shall either rectify or replace the defective equipment free of cost to the purchaser. If the contractor fails to do so within 30 days of written notice, the purchaser may

- (i) At its option replace or rectify such defective equipment and recover the extra costs so involved from the contractor and/or
- (ii) Terminate the contract for balance work/supplies, with enforcement of penalty as per contract.
- (iii) Acquires the affected equipment/materials and services at reduced price considered equitable under the circumstances.

The contractor shall not be allowed any extension in contract completion period due to time taken to replenish the rejected material/work.

14. EXTENSION OF TIME:

If the delivery of equipment/materials is delayed due to reasons beyond the control of the contractor, the contractor shall without delay give notice to the purchaser in writing of his claim for an extension of time. The purchaser on receipt of such notice may agree to extend the contract delivery date as may be reasonable but without prejudice to other terms and conditions of the contract.

15. WARRANTY

- 1. Comprehensive on-site warranty for the products supplied for a period of 3 year.
- 2. Vendors must send the technical literatures along with the quotation and quote only one make.
- 3. The commercial terms and conditions asked in the tender enquiry form should be filled clearly.

The free comprehensive support during the warranty period will include the following:

- a) The vender shall rectify the fault within 6 hours from the time of registration of the call.
- b) The vendor shall be responsible for any defects that may arise out under normal usage due to faulty materials attached to the system, designing lacuna or poor workmanship. The vendor shall have to take immediate remedial measure for such defects at his own cost when called upon to do so by the Purchaser.
