On dtd.10.02.2016 will not be accepted since the tender box will be closed at 1.00PM.
- 2.(a) Tender document can be purchased from the office of the undersigned in the working hours on written request from Dated 20.01.2016 to 09.02.2016 up to 5.00P.M. Tender documents can also be issued by post on payment of Rs 100/- (Rupees One Hundred) only towards postal charges over & above the cost of tender document.

The original money receipt towards purchase of tender paper should be enclosed with the tender documents failing which the tenders will be rejected. The Tender may be submitted in duplicate with original signature in both copies in a sealed cover.
3. The Authority reserves the right to reject the lowest or any other tenders or all tenders without assigning any reason there of what-so-ever.
4. Tender shall be submitted in person or by Registered post with A/D. Any other means of delivery shall not be accepted. When submitted by post, postal delay shall not be considered. Tenders received after due date and time shall be returned un-opened.
5. Telegraphic tender shall not be accepted under any circumstance.
6.
