SECTION-I

INSTRUCTION TO THE BIDDERS (CHECK LIST)

1. The Bidders must read in detail the "Instruction to the Bidder" & "General terms and conditions" before filling the Tender Documents.

2. EXPERIENCE

The Tenderers should be registered order suppliers/ Manufacturer/ their authorized dealer. The bidders may submit the copy of past experience if any regarding supply of similar materials to GRIDCO/ OPTCL or any other state or central PSUs.

3. TENDERS: -

(a) Bidders must submit the tenders in duplicate in the specified specification only.

(b) Tender must be submitted in Sealed envelopes superscribed as "Tender Call Notice No.- 11/15-16 (Supply & Installation of 2 Tons Split Type Air Conditioner with 3 STAR Rating & Cordless Remote control), Date of opening- 10.02.2016" and addressed to General Manager, EHT(O&M) Circle, Jajpur Road.

(c)Inside the above mentioned envelope there should be two closed sealed envelope. In one annexure-II & III along with the Tender Specification Booklet will be there with mentioning technical and in another Annexure- IV will be there mentioning financial. The technical bid will be open at 03:00 PM and if through its financial bid will be open at 04:00 PM on the same day.

(d)Tender shall be submitted either in person or by Registered Post with A.D. Any other means of delivery shall not be accepted. Detailed postal address with PIN No., Phone/ FAX must be mentioned on the tender bid. Tenders received after due date due to postal delay or any other reason will not be considered.

(e) Conditional offers will not be considered.

4. EARNEST MONEY DEPOSIT (EMD)

Tenders not accompanied with E.M.D. shall be rejected. No further query shall be entertained in such case. EMD of successful Tenderers will not be adjusted towards security deposit. The E.M.D.of all unsuccessful Tenderers shall be refunded on written request after finalization of award of contract. Any exemption of EMD will be submitted with proper document.

5. FORFEITURE OF E.M.D: -

(i) In the event the successful tenderer fails to accept the order or supply the materials within the stipulated period, the E.M.D. so deposited shall be forfeited.

(ii) Any deviation from terms and conditions may amount to forfeiture of EMD without any notice.

6. INFORMATION ON COMPETITORS:

Bidders have right to know information on competitors only at the time of opening of the bids of Competitors. No further information on competitors shall be provided at any other point/ Stage and before finalization of the tender without prejudice to Right to Information act.

7. AUTHORISED REPRESENTATIVES: -

Bidders themselves or one authorized representative (possessing authorization letter in original) for each bidder shall be allowed to attend opening event of the tenders.

8. OPENING OF TENDERS:

Copy of PAN card/ TIN/ VAT Registration No. & VAT clearance certificate should be enclosed with the Tender.

9. The purchaser may alter the quantities of materials at the time of placing orders. Orders may also be split up among more than one tenderer for any particular item if necessary. Only those who have purchased the Tender specification from this office can submit their Tender. Tenders submitted by other will be rejected.

The purchaser reserves the right to reject the Tender-without assigning any reason.

- 10. Tender should be prepared clearly and without any overwriting and corrections. Erasures and other changes shall bear the dated initial of the person signing the Tender.
- 11. In the event of discrepancy or arithmetical error in the schedule of price, the decision of the purchaser shall be final and binding on the tenderer.
- 12. For evaluation, the price mentioned in words shall be taken if there is any difference in figure and works in the price bid.
- 13. The tenders shall be outright rejected if they do not comply with the following requirements.
 - a) Tenderers should have purchased the relevant specification from the office of the General Manager, E.H.T.(O&M) Circle, Jajpur Road and indicate the money receipt No. and date of this office.
 - b) Tenders shall be submitted in person or by Registered post with A.D. which should be received before the opening of Tender as specified in the Tender call notice.

 - d) Tenders shall be accompanied with prescribed Earnest Money Deposit.

SPECIFICATION DETAILS FOR 2 TONS SPLIT TYPE AIR CONDITIONER

- Split type Air Conditioners conforming to IS: 1391 (Part-2)-1992 with Amendment No. 1 to 4 with Rotary compressor using HCFC Refrigerant (R-22) suitable for wall mounting.
- 2. Air Conditioners suitable for 230V, 50Hz single Phase AC supply shall be capable of performing the functions as cooling, dehumidifying, air circulation and filtering. The air conditioner shall be complete with automatic temperature control and cut-in and cut-out etc. for temperature range 16 to 30 degree celcious. The differential of the thermostat for cut-in and cut-out shall not be greater than +/- 1.75 degree celcious. The Air Conditioner may either be provided with adjustable step less type mechanical thermostat or electrical thermostat as per IS: 1138:1985. The ECO friendly Air Conditioners shall have ECO MARK from Bureau of Indian Standard.
- 3. Outdoor unit of the Air Conditioners shall be fitted discharge cooled type rotary compressor operating on Refrigerant R-22 (or non CFC refrigerant R-410 in case of ECO friendly Split Type Air Conditioner) with suitable rated capacitor start electrical motor. It shall be equipped with overload protection and shall be mounted on resilient mounting quite operation.
