INSTRUCTION TO BIDDER.

1. Definition:

i. <u>Jhula person</u>: The person who can crawl over the conductor / insulator string in over head line with safety measure such as with a Jhula (a safety belt being tied to his waist) and also can do the work by sitting over it.

ii. Tower Climbing person: A person who can climb to the top of the tower (400kV / 220kV /132kV) and do tower assembly work up to the peak portion of the tower.

2. Experience of the contractors :

Labour supply having valid HT / EHT Electrical contract License with at least one year experience in deployment of skilled manpower in any Transmission utility shall upload the complete tender application duly filled in along with the copy of the testimonials as required under the qualifying price bid

3. Opening of Tender:

The tender shall be opened in the O/O the CGM (O&M), OPTCL, Bhubaneswar. In case the tender is not opened on the same date due to some unavoidable reasons then it will be opened afterwards at the earliest.

4. EMD:

The bidders shall have to furnish a Demand Draft towards EMD (Earnest Money Deposit) as per the detail notice ,drawn on any scheduled Bank in favour of Drawing & Disbursing Officer, Odisha Power Transmission Corporation Limited, payable at Bhubaneswar.

5. Mode of Submission of Tender:

[a]Tenders shall be submitted in electronic mode only. (www.tenderwizard.com/OPTCL)

[b] Telegraphic or FAX tenders shall not be accepted under any circumstances.

6. Refund of EMD:

The E.M.D. of unsuccessful bidders will be refunded within 90 days / after finalization of the Tenders without any interest.

7. Quoting of rates:

The rates of different category of Skilled Technical (Jhula person / Tower Climber) Personnel shall not be less than the rates of minimum wages prescribed by the Government from time to time under the Contract Labour (R& A) Act, 1970 and the Minimum Wages Act, 1948 and other statutory dues payable as per the Govt. Rules.

8. Rate of wages:

The rate of wages, statutory dues and other allowances etc. under the labour laws and other laws payable by the employer (the contractor) should be indicated in detail.

9. Revision of rates of wages:

The bidder has liberty to seek revision of rates of wages of different category of Skilled Manpower if the minimum wages and other statutory dues are revised by the Govt. of Odisha and OPTCL during operation of the contract agreement.

10. <u>Dues payable by the OPTCL:</u>

No other dues on any account shall be payable by the OPTCL except the rates of wages agreed upon and subsequent revision thereof during the period of contract agreement.

11. Mode of bidding:

The bidders can quote for any or all the O&M circles.

12. <u>Contract Agreement:</u>

The successful bidder shall have to execute an contract agreement with the Circle/ Divisional head defining the respective zonal head. Any grievance/complaints shall be processed through the respective zonal head.

13. Labour license:

The bidder have to furnish copy of the valid license from the licensing authority under the Contract Labour (Regulation and Abolition) Act, 1970 having jurisdiction of the respective departments / Circle / Division, along with the bid or the firm will produce an undertaking that he would submit Labour license at the time of supply of Labour if he is selected by OPTCL. failing which the bid shall be summarily rejected.

14. <u>Security Deposit:</u>

On his being successful, the amount deposited by the bidder as E.M.D. will be retained by the OPTCL towards Security Deposit till subsistence of the contract.

15. Payment of wages & dues by the bidder:

If it is found that the amount payable by the bidder towards wages, allowances and statutory dues etc. in respect of the engaged personnel is not paid, then the same shall be adjusted from the security deposit. If the security deposit amount is found insufficient then OPTCL reserve right to recover the deficit amount through other modes of recovery, including the right to terminate the contract without prior notice.

16. <u>Bidder's Responsibility:</u>

The successful bidder shall be solely and exclusively responsible for engaging their personnel. OPTCL will have no liability whatsoever concerning the employees of the bidder. The bidders shall have to make regular and full payment of all wages and allowances to its workers/employees so also the statutory dues, etc. He shall also be liable to indemnify OPTCL against all losses, damages caused due to any commission and omission on the part of the personnel deployed by him.

17. Period of Contract:

The period of contract shall be for a duration of 24 months from the date of agreement. However the work order will be issued for 12 months in 1st phase & after getting satisfactory performance report from field office the work order will be extended for another 12 months.

18. Termination of Contract:

The contract can be terminated by giving three months notice from either side during the period of contract or on completion of the period of contract. In case where the successful bidder commits any breach of the terms and conditions, the contract can be terminated without notice and on that event the EMD / Security Deposit shall be forfeited.

19. Subletting of Contract:

The bidder shall undertake not to sublet the work order to other Agencies.

20. Undertaking by the Bidder:

The bidder shall undertake to abide by the terms and conditions appended to this instruction on being successful in the bid.

21. Rejection of Tender:

CGM(O&M), OPTCL, Bhubaneswar reserves the right to reject all tender without assigning any reason whatsoever and the decision of the OPTCL Management shall be final and binding on all the bidders.

22. General: -

- (i) The tenderers can offer their bids for a single LOT or more lots.
- (ii) The tender paper cost (Form fee) for an amount of Rs 10,500/- is to be paid whether the tenderer offers for a single LOT or more lots.
- (iii) The tender processing fee for an amount of Rs 2,247/- is to be paid whether the tenderer offers for a single LOT or more lots.
- (iv)The EMD amount is to be paid against each LOT as mentioned in the detail tender Notice.
- (v)In the event of discrepancy or arithmetical error in the schedule of price, the decision of the purchaser shall be final and binding on the Tenderer.
- (vi)Notice inviting tender shall form part of this specification.
- (vii) The EMD, if any, shall be returned to the unsuccessful bidders.
- (viii) It should be distinctly understood that the price bid shall contain only details/documents relating to price, as mentioned herein above.
- (ix) The tenderer must submit the EMD amount, cost of tender document and Tender processing fee in a sealed cover envelope super scribing the tender specification number, Tender Notice No & Date opening of tender clearly on the envelope cover. The said envelope is to be submitted in the office of the purchaser on or before the last date and time of submission of tender.

GENERAL TERMS AND CONDITIONS OF CONTRACT

1. Scope of Work:

The successful bidder at its own cost and expenses shall provide the trained personnel within the age group of 18 to 35 years, possessing valid electrical workman permit, issued by competent licensee-issuing- authority to perform the emergency / maintenance work in the respective Circles / Divisions and all other places as required at the instructions of the OPTCL. When there is no emergency work; they are to perform the other maintenance work.

The emergency / normal nature of works define as follows:-

- i) Repair / maintenance of overhead lines with Jhulla arrangement.
- ii) Errection / Repair of tower by climbing up to the top of the tower.
- iii) Normal / emergency nature of works relating to S/S equipments Viz-TRF, CB, CT, & PT etc.

If required the successful bidder are to demonstrate the fitness of the personnel prior to deployment for the above works.

2. Engagement & Maintenance of Personnel:

The successful bidder at its own cost and expenses and with all its liabilities employ and maintain the engaged personnel and shall keep them at its own roll and pay their salaries including allowances and to pay other advances, and leave benefits, etc. as per the Govt. Rules

The deployed gang of a particular zone, when deputed to emergency restoration / maintenance work of different areas other than their headquarter will be provided with fooding arrangement either by OPTCL or will be reimbursed Rs. 50/- per person per day.

3. Payment of Statutory Contribution:

The successful bidder shall pay all statutory contribution payable under the provisions of the various Labour laws and other laws in force and applicable during operation of the contract.

4. Observation of Rules:

The successful bidder shall deploy / arrange the staff in accordance with the observance of the leave rules and other rules applicable to it.

5. <u>Indemnity to owner (OPTCL):</u>

(i). The successful bidder shall be responsible for any loss on account of any act of commission or omissions by the deployed personnel and shall be liable for payment to OPTCL for the loss so determined. If the bidder fails to deposit the loss amount, the same shall be deducted from the EMD / Security Deposit reserving its right to recover the deficit amount by adopting other mode of recovery. The successful bidder shall be responsible for all statutory payments including the taxes in respect of the engaged personnel. If any complaint with regard to non-payment of wages or allowances and statutory benefits is received, the amount shall be recovered out of the bills. E.M.D./ Security Deposit of the bidder. The successful bidder shall raise bill by quoting Order No. and date for the payment of deployed personnel with certificate to the concerned Officer / D.D.O of OPTCL for every month. Payment shall be made by the firm to the deployed personnel latest by the 2nd week of the succeeding month.

(ii) The bidder shall have no claim whatsoever against the OPTCL for any loss / damage caused to the Agency / Firm by reasons of war, riot, commotion disturbance, pestilence, epidemical sickness, strike, lockout, earthquake, fire, storm, flood, explosion, electrical / General accident or any change in the nature, breakdown of plant or machinery for whatever reasons.

6. <u>Document to be submitted for bill Processing:</u>

- The bills shall be submitted latest by the 2nd week of succeeding month with all (i). the particulars i.e. Names of personnel engaged, Account No with amount of deductions made from the monthly salary/ wages towards E.P.F. & ESI of individual personnel, Employer's share E.P.F & E.S.I contribution along with Chalans / Vouchers of the preceding month with signature of M.D. / Chief Executive or the Authorized Representative of the bidder, absentee statement of the engaged personnel of the previous months to the concerned Officer /D.D.O. of OPTCL for verification. Failure to comply the above, the Officer concerned / D.D.O of the respective units of OPTCL has rights to withhold the payment of the bills. Any interest / penalty imposed on the Agency by the Statutory Authorities shall be liable to pay such interest / penalty by the Agency and OPTCL shall not be held responsible in respect of statutory deposits. It is also the sole responsibility of the contractor to ensure timely payment for the deployed person latest by 2nd week of succeeding month even if the payment of said month is not received for any reasons.
- (ii) The successful bidder / Agency shall furnish the records / documents / original Vouchers / Challan in respect of Statutory Deposits in respect of the engaged personnel to the Officer concerned of OPTCL as and when required, failing which the Management has every right to terminate the contract with one month notice to that effect.

7. Tax Deducted At Source:

Income Tax shall be deducted at the prescribed rate as per provisions of Income Tax Act on the gross value of the bills.

8. <u>Safety and Workmen compensation:</u>

The bidder / contractor will supply all the ISI marked safety equipments to the deployed persons like Helmet , Safety Shoe, Hand Gloves, Safety Belt etc at their own cost. The safety of contract Jhulla and Tower Climber deployed by the contractor shall be sole responsibility of the contractor. The contractor shall also be fully responsible for payment of compensation under the workmen Compensation Act in respect of workmen deployed by him. The contractor must take adequate measures regarding the above.

9. Outright Rejection of Tender:

The tender submitted by tenderer shall be out-rightly rejected, if they do not comply to the followings.

- a) The bidder must have HT / EHT License with at least one year experience in supply of manpower (Jhulla and Tower Climber) in any transmission utility in India.
- b) The bidders shall have to furnish a Demand Draft towards EMD, cost of tender documents and tender processing fee.
- c) The bidder must have Registration Account Numbers under the ESI Act, 1948 and EPF (M&P) Act, 1952 with latest returns furnished under the said Acts.

10. Jurisdiction of Court:

Any dispute or difference under or arising out of or in respect of this Contract, may be referred to the sole Arbitrator to be appointed by the CMD, OPTCL, Janpath, Bhubaneswar and his decision in the matter on the dispute will be final and binding on the bidder as well as the Executants of the respective units of OPTCL. The Courts in Bhubaneswar shall have the exclusive jurisdiction in the matter of dispute. The Executants of respective Units of OPTCL has the right to add in addition to the above terms and conditions as may be considered proper at the time of execution of the agreement.
