#### 1. Submission of Bids: -

The OPTCL reserves the right to reject any bid, which is not submitted according to the instruction, stipulated above. The participants to the tender should be registered under IT Act / Service tax Act.

#### 7. Validity of the Bids: -

The tenders are requested to keep the validity of their offer for a period of **180** days from the date of opening of the tender, failing which the tenders will be rejected.

#### 8. PRICE: -

The bidders are advised to quote their rate as per the price schedule attached with this specification and shall remain firm inclusive of all taxes & duties, labour charges etc. within the validity of the tender. However Service tax will be paid extra as per Govt. Prevailing rule.

#### 9. Bidders to be fully conversant with the clauses of the Specification:

Bidders are expected to be fully conversant with the meaning of all the clauses of the specification before submitting their tenders. In case of doubt regarding the meaning of any clause, the bidder may seek clarification in writing from the GM EHT (O&M) Circle, Chainpal, This, however, does not entitle the bidder to ask for time beyond due date, fixed for receipt of tender.

#### 15. PAYING OFFICER:-

The DGM, EHT (O&M) Division, Chainpal is the paying officer for the contract to be issued to the Contractor for for above Painting work.

#### 16. General: -

- (i) The tenderers can offer their bids for complete work.
- (ii) The tender paper cost (Form fee) for an amount of Rs 06,300/- is to be paid for the work.
- (iii) The tender processing fee for an amount of Rs 1,252/- is to be paid for the work.
- (iv)The EMD amount is to be paid against as mentioned in the detail tender Notice.
- (v)In the event of discrepancy or arithmetical error in the schedule of price, the decision of the purchaser shall be final and binding on the Tenderer.
- (vi)Notice inviting tender shall form part of this specification.
- (vii) The EMD, if any, shall be returned to the unsuccessful bidders.
- (viii) It should be distinctly understood that the price bid shall contain only details/documents relating to price, as mentioned herein above.
- (ix) The tenderer must submit the EMD amount and cost of tender document in a sealed cover envelope super scribing the tender specification number, Tender Notice No & Date opening of tender clearly on the envelope cover. The said envelope is to be submitted in the office of the purchaser on or before the last date and time of submission of tender.

#### SECTION-III

#### GENERAL TERMS AND CONDITIONS OF CONTRACT [G.T.C.C.]

#### 1. Scope of the contract:

#### The Work Includes supply of paint materials & work for painting:-

- (a) All the surfaces to be painted shall be free from grease, oil and other contaminants by applying de-greasing solvent.
- **(b)** Removal of rusting and old paints are to be done and surfaces to be cleaned by making full use of mechanical tools along with manual scrubbing and wire brushing.
- (c) Surface to be washed thoroughly and then dried properly.
- (d) One coat primer is to be applied by brush with Bison Zinc phosphate primer.
- (e) Second coat of primer is to be applied by the spray machine with high built M10 (sand with coat) over the primer coat.
- (f) Final painting of 2 (two) coats is to be applied by a spray machine with Burger/Asian make enamel paint over the sand witch coat. The painting work shall be done carefully in such a way that the paint shall not scale off or shall be removed by abrasion due to normal handling and capable to withstand extremity to weather condition. The minimum thickness of final painting of ail surface of transformers shall be 80microns.
- **(g)**All materials required for painting including Berger paints, Asian paints, thinners etc., tools and plants are to be supplied / arranged by the contractor. The quality of primer & burger/Asian make paints to be used for painting works of transformer shall be examined for its genuineness by verifying purchase document made by the Contractor from the manufacturer/authorized dealer and the colour of the paint areto be approved by committee, which is headed by concerned AGM, TA to GM & Concerned consignee prior to execution of the works & the paint must be kept under the custody of consignee.
- **(h)**The painting work shall be done carefully in such a way that the paint shall not scale off or crinkle or shall be removed by abrasion due to normal handling and capable to withstand extremely of weather condition.

#### 2.0 Definition of terms:

For the purpose of this specification and General Terms and Conditions of contract [GTCC], the following words shall have the meanings hereby indicated, except where otherwise described or defined.

- 2.1 "The Purchaser" shall mean the General Manager, EHT (O&M) Circle, Chainpal for and on behalf of ODISHA POWER TRANSMISSION CORPORATION LTD., Bhubaneswar.
- 2.2 "The Engineer" shall mean the Engineer appointed by the Purchaser for the Purpose of this contract.
- 2.3 "Purchaser's Representative" shall mean any person or persons or consulting firm appointed and remunerated by the Purchaser to supervise, inspect, test and examine workmanship and materials of the equipment to be supplied.
- 2.4 "The Contractor" shall mean the bidder whose bid has been accepted by the purchaser and shall include the bidder's executives, administrators, successors and permitted assignees.
- 2.5 "Painting of Equipment" shall mean and include painting including supply of materials, labour charges etc. to be done under the contract by the Contractors.
- 2.6 "Contract Price" shall mean the sum named in or calculated the bid.
- 2.7 "General Condition" shall mean these General Terms and Conditions of Contract.
- 2.8 The Specification" shall mean both the technical as well as commercial parts of the specification annexed to or issued with GTCC and shall include the schedules .

- 2.9 "Month" shall mean "Calendar month".
- 2.10 Writing" shall include any manuscript, type written, printed or other statement reproduction in any visible form and whether under seal or under hand.
- 2.11 "FOR Destination costs" shall mean the cost at our work site. The cost is inclusive of all taxes & duties etc., but excluding Service tax.
- 2.12 The term "Contract document" shall mean and include GTCC, specifications, form of tender, Notice Inviting Tender, covering letter, schedule of prices or the final General Conditions, any special conditions, applicable to the particular contract.
- 2.13 Terms and conditions not herein defined shall have the same meaning as are assigned to them in the Indian Contract Act, failing that in the ODISHA General Clauses Act.

#### 3. Manner of execution:

The works awarded should be commenced from 15 days of the award of the contract and completed within 3 months (i.e.90 days). If the work could not be completed within scheduled date due to want of Shut down, hence completion period may be extended on written request of the Bidder.

All materials required for painting including Berger paints, Asian paints, thinners etc., tools and plants are to be supplied / arranged by the contractor. The quality of primer & burger/Asian make paints to be used for painting works of transformer shall be examined for its genuineness by verifying purchase document received from the manufacturer/authorized dealer by committee, which is headed by concerned AGM, TA to GM & Concerned consignee and the colour of the paint are to be approved by the concerned Assistant General Manager (O&M) Division prior to execution of the works & the paint must be kept under the custody of consignee.

#### 4. Language and measures:

All documents pertaining to the contract including specifications, schedule, notices, correspondence, operating and maintenance instructions or any other writing shall be written in English language. The metric system of measurement shall be used exclusively in this contract.

#### 5. Right to reject/accept any tender:

The Purchaser reserves the right either to reject or to accept any or all tenders if the situation so warrants in the interest of the OPTCL. Orders may also be split up between different Tenderers on individual merits of the Tenderer. The Purchaser has exclusive right to alter the quantities of work at the time of placing final work order.

#### 6. Completion of work

The works awarded should be commenced from 15 days of the award of the contract and completed within 3 months (i.e. 90 days) from the date of issue of work order.

#### 7. Force Majeure:

The Contractor shall not be liable for any penalty for delay or for failure to perform the contract for reasons of force majeure such as acts of god, acts of the public enemy, acts of Govt., Fires, floods, epidemics, Quarantine restrictions, strikes, Freight Embargo and provided that the Contractor shall within Ten (10)days from the beginning of delay on such account notify the purchaser in writing of the cause of delay. The purchaser shall verify the facts and grant such extension, if facts justify.

#### 8. Extension of time:-

If the Completion of work is delayed due to reasons beyond the control of the Contractor, the Contractor shall without delay give notice to the purchaser in writing of his claim for an extension of time. The Purchaser on receipt of such notice may or may not agree to extend the contract period date as may be reasonable but without prejudice to other terms and conditions of the contract.

#### 9. Guarantee period: -

(i)The work done by the contractor shall be guaranteed for a period of 12 months from the date of completion of work against any bad materials used and bad workmanship done for the work. The above guarantee certificate shall be furnished to the ordering authority for his approval. Any defects noticed during this period shall be rectified by the contractor, free of cost to OPTCL within one month, upon written notice from OPTCL provided such defects are due to bad materials used and bad workmanship failing which provision of clause 13 shall apply.

(ii)The work failed or found defective during the guarantee period shall have to be guaranteed after rework for a further period of 12 months from the date of completion of work. The Bank Guarantee is to be extended accordingly without any financial burden to OPTCL.

#### 10. SERVICE TAX REGISTRATION No., PAN CARD & HT/MV LICENSE:

Scanned copies of PAN, Service Tax Registration no. & HT/MV License valid on the date of opening of tender should be uploaded along with tenders, falling which the tender will be rejected. The contractor or their authorized representatives should produce the original documents for verification within 10 days from the date of opening of tender. Those who fail to produce the same and found not to be valid at the time of verification, their tenders will be rejected.

#### 11. B.G. towards security deposit, 100% payment and performance guarantee:

- [i] A Composite Bank Guarantee as per the Performa enclosed at Annexure-III of the specification for 10% [ten percent] of the total contract value shall be furnished from any nationalized/scheduled bank having a place of business at Bhubaneswar, to the office of General Manager EHT (O&M) Circle, Chainpal within 15 days from the date of issue of the work order,. The BG shall be executed on non judicial stamp paper worth of Rs.29.00 [Rupees twenty nine] only or as per the prevalent rules, valid for a period of 14 months from the last date of stipulated work completion period, for scrutiny and acceptance, failing which the work order will be liable for cancellation without any further written notices. The BG should be accompanied by a confirmation letter from the concerned bank and should have provision for encashment at Bhubaneswar, before the Bank Guarantee is accepted and all concerned intimated. The B.G should be revalidated as and when intimated to you to cover the entire guarantee period.
- [ii] No interest is payable on any kind of Bank Guarantee.

[iii] In case of non-fulfillment of contractual obligation, as required in the detailed purchase order/Specification, the composite Bank guarantee shall be forfeited.

#### 12. Terms of Payment.

(i)100% (one hundred percent) payment along with full taxes & duties (if any) shall be made after successful completion of the work in all respect as per JMC and verification thereof subject to approval of guarantee certificate & performance BG. Taxes and duties will be deducted from the bill as per Govt. norm.

(ii)The contractor is fully responsible for safe handling of the tower members to be painted during execution of the work. After completion of the work, the contractor shall produce the printed bills in triplicate to the respective consignee/Paying Officer for effecting payment.

#### 13. Penalty for Delay in Completion of Contract

Penalty shall be imposed @ ½% (half percent) of contract price for each calendar week of delay of part thereof subject to maximum of @ 5% (five percent) of contract amount.
