The sealed tenders should be submitted on or before **25.02.2015, 01:00PM** in the office of the DGM (Transport), OPTCL Hqrs., Janpath, Bhubaneswar-22, super-scribing the vehicle **Registration Number** and the **Model** on top of the envelope, which shall be opened on the **same day at 3:30 P.M.** in the presence of the tenderers or their representatives. The above mentioned vehicle can be inspected by the tenderers in the Head qrs. Office, OPTCL, premises during office hours, with intimation to the DGM (Transport), OPTCL.

The intending purchasers are requested to pay **Rs.1,500/-** (Rupees one thousand five hundred) only as earnest money in shape of **Bank Draft** drawn in favour of **Drawing & Disbursing Officer, OPTCL Hdqrs. Office, BBSR**. The earnest money will be refunded to the unsuccessful tenderers. The highest tenderer will have to deposit at least 25% of the offered amount within five days with the D.D.O., Hdqrs. office, OPTCL after the tender is accepted by the competent authority. The balance amount if any should be deposited within ten days. If the successful tenderer fails to deposit the full amount within the stipulated period, the earnest money so deposited shall be forfeited.

The vehicle, in case is not lifted within 30 days from the date of opening of tender, the ground rent, at the rate of 1% of the tendered amount for each day of delay will be charged. When the ground rent for each vehicle so charged exceeds the price deposited, the tenderer shall cease to have any right on the vehicle. The amount deposited by him shall be adjusted towards the ground rent and the vehicle shall become the absolute property of OPTCL, free from encumbrance and to be disposed of by fresh tender.

The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
