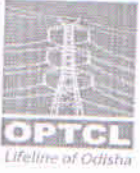

Experienced bidders may be given preference. Bidders fulfilling the qualifying criteria and possessing I.T. PAN Card and service tax registration, certificates are only eligible to apply.

- (1) Registration of travel Agency/copy of Regd. Certificate of vehicle issued by the R.T.O. In the name of the Agency/owner.
- (2) Service Tax Regd. Certificate from the central excise Deptt.
- (3) Valid PAN Card.
- (4) Copy of State Road permit to run the vehicle within the Odisha.
- (5) Copy of the valid first party Insurance.
- (6) Copy of contract carrying certificate / Taxi permit.
- (7) Copy of valid non pollution certificate.

(8) Copy of fitness certificate.

(9) Copy of up to date tax payment.

(10) Copy of valid Driving license of the driver.

The tender specification for the same shall be obtained from the office of the undersigned on payment of requisite amount (Non-refundable) in shape of cash/D.D/Pay order drawn in favour of "D.G.M.,EHT (O&M) Division, OPTCL, JODA", payable at Joda and will be opened in presence of tenderer or their authorised representative(one person only) with original authorisation letter, if present during opening of the tender. Incomplete tender without EMD shall be rejected.
