With reference to the above, I am to inform you that OPTCL's Foundation Day will be celebrated on 1st April, 2013. In line with the previous practice the Cultural Festival will be organized on 13th and 14th April 2013. The venue for the Cultural Festival will be Power Club, Gridco Colony, OPTCL.

The following cultural Items, Prizes & Norms are stated below for your kind information,

1. Cultural Items, Prizes & Norms.

a) Drama: 50 minutes + 10 minute = 1 hr for each Drama (one

Drama from each Zone).

Prize : 1st, 2nd, 3rd& Consolation prize.

Special : Best Actor, Best Supporting Actor, Best Actress, Best

Prize Supporting Actress, Best Actor in Negative Character, Best Comedian, Best Script, (if written by our

employee), Best Director (if directed by our employee).

Note : Only Lady artistes / child artistes may be allowed from

outside but they are not eligible for prizes. If apart from them any other artiste from outside is found to be acting

in the drama, the drama will be disqualified. All the artistes from OPTCL will carry their I-card with them.

b) Song : 5 minutes each (one participant from each Zone)

Prizes : 1st, 2nd & 3rd prize.

Folk Dance : 5 minutes (one group from each Zone. The group will

(Group) bring CD with them)

Prizes : 1st, 2nd& 3rd prize.

2. Eligibility criteria of participants

Only the employees OPTCL & GRIDCO can participate in the Cultural Festival. The names of selected employees may be forwarded in the proforma (Annex-I) by the nodal officer.

3. Selection of participants

c)

The nodal officer shall conduct a selection test for song, Folk dance & Artistes for drama among the interested employees working under respective circle. After selection, rehearsal may be conducted among the selected employees & the list may be forwarded for inclusion in the event on or before 02.04.2013. The new faces may be encouraged with due regard to the best performers to participate in the competition.

4. Nodal Officer

The respective circle Heads will be the nodal Officer. Nodal officer for Bhubaneswar zone will be Sr.G.M (C.P). The nodal officer will authorize an employee to act as Manager of the cultural team of the respective Circle.

5. Expenditure

T.A. & D.A. will be paid by the concerned office as per rule. The nodal officer is authorized to sanction a consolidated amount of Rs.12,000/- (Twelve Thousand) only for rehearsal of song, dance and drama expenses & Rs.1,000/- (One Thousand) only for the Circle who will not participate in Drama but will participate in other events i.e. Songs and Folk Dance.

Accommodation shall be provided to all participants on 13th and 14th Apr., 2013 for Cultural Festival in OPTCL Transit House with food arrangements.
