Group-B Supply and Erection of 14 nos 8 mtr long PSC poles, supply and stringing of 10 KM AB cable along with all other required materials and fixing of street light fittings at village Mendhasal on turnkey basis as per specification and price schedule except Light fittings which are to be supplied Departmentally.
