CONTRACTUAL ENGAGEMENT OF RETIRED OAS OFFICERS AS OSD (LAND)

Orissa Power Transmission Corporation Limited (OPTCL), a state owned power utility organisation in Orissa is engaged in the business of Transmission of electricity with a vision to emerge as one of the leading utilities in the country in Transmission space, invites applications for engagement of retired OAS(I) Officers as OSD (Land) on contractual basis for a temporary period of two years to look into the land related works, correction of Record of Rights and other estate activities of OPTCL.

1. Posts

Two Retired OAS(I) Officers will be engaged at two different zones – one for Western Division at Burla and the other for Southern Division at Berhampur, for zone-wise supervision of work.

2. Eligibility Conditions:

- (a) Retired OAS (I) Officers not above the age of 63 years, having good service records and who are physically fit will be eligible to apply.
- (b) The applicants should have adequate experience and successful track records in land acquisition and RoW issues. They should have worked as Tahasildar or Addl. Tahasildar for a minimum period of three years.
- (c) Officers against whom departmental proceedings or criminal cases are contemplated or pending or who have been penalized for misconduct during the period up to five years preceding their retirement will not be considered for engagement.

3. **Selection Process:**

Selection will be made through open advertisement & personal interview by a Selection Committee.

4. **Tenure, Terms & Conditions:**

(a) The engagement will be made for a period of two years, which may be extended further depending on satisfactory performance and requirement of OPTCL.

(b) The Retired Officer will be engaged as OSD(Land) on contractual basis on fixed remuneration of Rs.18,000/- PM.

(c) The Retired Officer shall not be eligible to get Dearness Allowance or any other Special Pay or Allowance, over & above the consolidated remuneration.

(d) During the period of contractual engagement, the Retired Officer shall be entitled to get Traveling Allowance for approved tours in line with the Corporation's prevailing norms.

(e) He will be entitled for mobile reimbursement of Rs 1000/-PM.

(f) The engagement will be terminated at any time by OPTCL for dis-satisfactory performance, on notice of one month, and in cases of any misconduct including but not limited to misappropriation, negligence or causing loss to OPTCL without any prior notice.

5. **Procedure to Apply**
