#### **GENERAL TERMS AND CONDITIONS OF CONTRACT [G.T.C.C.]**

#### 1. <u>Scope of the contract:</u>

The scope of contract covers "Construction of a new Heritage Gate for 132/33 KV Grid Sub-Station ,Puri which will include Construction of RCC Welcome gate, Security room and Wicket gate at the entrance of Grid Sub-Station ,Puri. The work shall be carried out as per construction drawings, specifications, the description of the items in this schedule and/or Engineer's instructions. The layout, sizes and details of the Security shed, structures and foundations will be done as per the attached approved drawing.

#### 2. <u>Definition of terms:</u>

For the purpose of this specification and General Terms and Conditions of contract [GTCC], the following words shall have the meanings hereby indicated, except where otherwise described or defined.

- 2.1. "The Purchaser" shall mean the General Manager, EHT (O&M) Circle, Bhubaneswar for and on behalf of ODISHA POWER TRANSMISSION CORPORATION LTD, Bhubaneswar.
- 2.2. "The Engineer" shall mean the Engineer appointed by the Purchaser for the purpose of this contract.
- 2.3. "Purchaser's Representative" shall mean any person or persons or consulting firm appointed and remunerated by the Purchaser to supervise, inspect, test and examine workmanship and materials of the equipment to be supplied.
- 2.4. "The Contractor" shall mean the bidder whose bid has been accepted by the purchaser and shall include the bidder's executives, administrators, successors and permitted assignees.
- 2.5. "Contract Price" shall mean the sum named in or calculated the bid.
- 2.6. "General Condition" shall mean these General Terms and Conditions of Contract.
- 2.7. The Specification" shall mean both the technical as well as commercial parts of the specification annexed to or issued with GTCC and shall include the schedules.
- 2.8. "Month" shall mean "Calendar month".
- 2.9. Writing" shall include any manuscript, type written, printed or other statement reproduction in any visible form and whether under seal or under hand.
- 2.10. "FOR Destination costs" shall mean the cost at our work site. The GST is to be calculated extra.

- 2.11. The term "Contract document" shall mean and include GTCC, specifications, form of tender, Notice Inviting Tender, covering letter, schedule of prices or the final General Conditions, any special conditions, applicable to the particular contract.
- 2.12. Terms and conditions not herein defined shall have the same meaning as are assigned to them in the Indian Contract Act, failing that in the ODISHA General Clauses Act.

#### 3. MANNER OF EXECUTION:

Construction of Heritage Gate should be done as per the instruction of the engineer – in- charge. All the work shall be taken as per the civil engineering procedure. The work is to be done while strictly adhering to the Technical Specification of **Section III.** 

#### 4. <u>PERIOD OF EXECUTION</u>:-

The work shall be carried out and completed in all respect within 120 days from the date of issue of this work order.

5. <u>INSPECTION/SUPERVISION:</u>- Necessary inspection/supervision of the work will be done by the consignee / Supervising officer during execution of work. The steel materials and other materials required to be used are to be inspected by the engineer in charge before taking up the work.

#### 6. Language and measures:

All documents pertaining to the contract including specifications, schedule, notices, correspondence or any other writing shall be written in English language. The metric system of measurement shall be used exclusively in this contract.

# 7. <u>Right to reject / accept any tender</u>:

The Purchaser reserves the right either to reject or to accept any or all tenders if the situation so warrants in the interest of the OPTCL. The Purchaser has exclusive right to alter the quantities of work at the time of placing final work order.

#### 8. <u>COMPENSATION</u>: -

The contractor shall be fully responsible for paying compensation, if any, under the Workmen Compensation Act on account of workmen deployed by him. He must have followed all the safety rules and provide all the required protective equipments to his workmen as they are to work in the surrounding of Extra High Voltage System. OPTCL in no way will be responsible for payment of any compensation.

#### 9. FORCE MAJEURE:

The Contractor shall not be liable for any penalty for delay or for failure to perform the contract for reasons of force majeure such as acts of god, acts of the public enemy, acts of Govt., Fires, floods, epidemics, Quarantine restrictions, strikes, Freight Embargo and provided that the Contractor shall

within Ten (10) days from the beginning of delay on such account notify the purchaser in writing of the cause of delay. The purchaser shall verify the facts and grant such extension, if facts justify.

#### 10. Extension of time:-

If the Completion of work is delayed due to reasons beyond the control of the Contractor, the Contractor shall without delay give notice to the purchaser in writing of his claim for an extension of time. The Purchaser on receipt of such notice may or may not agree to extend the contract period date as may be reasonable but without prejudice to other terms and conditions of the contract.

#### 11. Guarantee period: -

The guarantee period for this contract shall be One Year. Any defect / deviation if noticed during this period shall be immediately rectified free of cost on written notice from the consignee, failing which the security deposit shall be forfeited.

#### 12. GST REGISTRATION, PAN CARD & CIVIL LICENSE:

Clear attested Xerox copies of PAN No./ Valid GST registration & clearance certificate / Civil contractor license issued by Govt of Odisha / Railways / Military valid on the date of opening of tender should be submitted along with tender, without which tender will be rejected. The Contractor may be requested to produce original PAN card, GST registration and clearance certificate as applicable & Civil contractor license and all other relevant documents for verification. Those who fail to produce the same and found not to be valid on the date of opening of tender, their tenders will be rejected.

13. **<u>QUANTITY VARIATION</u>**: The quantity to be ordered may undergo revision at the time of the placement of orders

# 14. <u>SECURITY DEPOSIT TOWARDS, 100% PAYMENT AND PERFORMANCE</u> <u>GUARANTEE:</u>

The successful tenderer will be required to deposit a sum amounting to 10% of value of the contract in shape of Bank Draft /composite BG from any nationalized bank valid for up to two months after the guarantee period, drawn in favour of the **paying officers**, within 15 days of receipt of the work order. In the event of any breach or default in all or any conditions of the work order, the G.M., EHT (O&M) Circle, Bhubaneswar may forfeit the whole amount of Security deposit. No interest will be paid on the security deposit and will be released after expiry of the guarantee period by the paying officer. The security value must be deposited prior to execution of work.

#### 15. Terms of Payment.

 a) 100% of the Contract Value with GST shall be paid after successful completion of the work, subject to approval of the Guarantee Certificate by the Ordering Authority and deposit of security amount.. b) Deduction of Tax shall be made as per the prevailing norms of OPTCL

#### 16. Penalty for Delay in Completion of Contract

Penalty shall be imposed @ 0.5% (half percent) of contract price for each calendar week of delay or part thereof subject to maximum of @ 5% (five percent) of contract amount. Charges towards penalty shall be counted after scheduled date of completion / issue of clear instruction to the contractor for commencement of works by the General Manager, E.H.T (O&M) Circle, Bhubaneswar /concerned Deputy General Manager, E.H.T (O&M) Divisions.

#### 17. Jurisdiction of the High Court of ODISHA

Suits, if any, arising out of this contract shall be filed by either Party in a court of Law to which the jurisdiction of High court of ODISHA extends.

#### 19. Outright Rejection of Tenders

- 1. The Scope of work:- The scope of works covers construction of a new Heritage Gate for 132/33 KV Grid Sub-Station ,Puri which will include Construction of RCC Welcome gate, Security room and Wicket gate at the entrance of Grid Sub-Station ,Puri. The work shall be carried out as per the attached drawings, specifications, the description of the items in the schedule and/or Engineer's instructions.
- 2. Reinforcement Schedule and dimension details :- The work ( PCC& RCC) should be carried out as per the attached drawing.
- **3. Supply of Materials:-** All required materials, consumables, paint are to be supplied by the Contractor and must be of approved quality. Different sizes of steel rod to be used must be of TATA/SAIL make. The materials are to be inspected by the representative of OPTCL before utilization of the same.. All other materials which have not been mentioned and are required at site for proper execution of the work shall also be supplied by the contractor including cost, conveyance, royalty and taxes of all materials, cost of all labour, T&P etc. as required for the work complete and as per direction of Engineer-in-charge.
