The packet super scribing the name of the work and containing cost of bid document & Affidavit in original and other documents may be submitted in the office of the undersigned on or **before 17.00 Hours on dated 26.09.2023** during office hours on working days failing which the bid will be rejected
- The cost of bid documents in shape of demand draft drawn in favour of Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar on any Scheduled Bank, payable at Bhubaneswar separately towards cost of each tender. The purchaser of the demand draft has to be the bidder himself or his authorised representative. In case of authorised representative, the bid must be accompanied by a affidavit/undertaking of authorisation.

The bidders should have successfully executed/completed at least a single civil nature of work ,ie, composite work of buildings worth 50% of tender value of each work during the last five financial years i.e. 2018-23 in a single contract. The bidders failing to produce authenticated document in

support of work experience from competent authority is liable for rejection. Experience certificate from any Private Organisation will not be entertained. Experience certificate furnished below the rank of Executive Engineer of Government Department/ Public Sector Undertaking will not be accepted. The original agreement in support of experience certificate submitted by the bidder will be verified before opening of the financial bid.

- 16. **EPF and ESI certificate with last 03 month (May 2023 to July 2023)** updated challan is mandatory for qualification.
