#### 1. Submission of Bids: -

#### **SECTION-III**

#### SCOPE OF THE WORK & GENERAL TERMS AND CONDITIONS OF CONTRACT

#### 1. SCOPE OF THE WORK:

- i. Cleaning of transformer & its accessories.
- ii. Measurement of IR & PI values before overhauling.
- iii. Draining of transformer oil.
- iv. Note down the tap position of transformer before opening of the top cover.
- v. Dismantling of all transformer accessories (like- radiators, conservator, buchhloz relay pipeline, etc.)
- vi. Opening of top cover by suitable capacity of hydra / crane.
- vii. Inspection of core coil assembly for physical damages from top.
- viii. Tightness of Tie rod and core nut bolts to reduce the humming of the transformer.
  - ix. Checking & Tightness of wooden support's nut and bolts of winding.
  - x. Replacement of old insulation paper with new one where it is necessary.
  - xi. Cleaning of core coil assembly by fresh hot oil.
- xii. Cleaning of sludge content from main tank by cotton cloth.
- xiii. Cleaning of all accessories of transformers.
- xiv. Cleaning of DM box & Marshalling Box.
- xv. Replacement of all gaskets & O-ring by new gaskets of main tank, radiators, conservators and all other accessories.
- xvi. Replacement of oil seals and gaskets of HV and LV bushing by new oil seal.
- xvii. Replacement of OLTC top cover gasket /O-ring.
- xviii. Diverter switch cleaning & replacement of gasket.
- xix. Checking and cleaning of tap changer contacts (Moving and fixed) and its operating lever condition.
- xx. Assembling of all accessories of transformer (like- radiators, conservator, buchholz relay pipeline, etc.)

- xxi. Vacuum of Transformer.
- xxii. Filling of dry air at a certain pressure for a limited time period.
- xxiii. Dehydration of transformer (i.e. Dry air).
- xxiv. Checking and servicing of Buchholz relay.
- xxv. Checking of oil and winding temperature indicator. Checking of Oil level indicator.
- xxvi. Filling of new transformer oil through oil filter machine after checking its BDV.
- xxvii. Dehydration of transformer for improvement of insulation resistance by hot oil circulation.
- xxviii. IR value measurement at every 2 hrs during filtrations.
  - xxix. Erection & Commissioning of Air-cell.
  - xxx. Replacement of silica Gel in breather and checking the condition of breather.
- xxxi. Checking of all protections for transformer such as Buchholz Relay, PRV, OSR, OTI & WTI, etc.

#### 2. PRICE/RATE:

The price quoted should be firm, inclusive of all taxes and duties and GST. F.O.R. Destination at 400220/132 KV Grid Sub-Station, Meramundali.

#### 3. Purchaser's right to accept/reject bids:

The purchaser reserves the right to reject the tender without assigning any reasons what so ever if it is in the interest of OPTCL, under the existing circumstances. If the contractor fails to perform the contract or fails to carry out the work assigned to him successfully during the contract period ,the contract can be terminated by the OPTCL authority and be without prejudice to any other remedy for breach of contract.

#### 4. VALIDITY:

The rate with terms and conditions of the offer shall be valid for a minimum period of 180 (one hundred eighty) days from the date of opening of tender.

#### 5. TERMS OF PAYMENT:

- i. 90 % (Ninety percent) of cost of the repaired transformer along with taxes & duties if any will be paid after completion of the repair works of the Transformer at OPTCL Site and verification thereof & against approval of test certificate & guarantee certificate.
- ii. Balance 10 % will be deducted from the bill as security deposit. The security deposit will be released after two months of completion of Guarantee period subject to fulfillment of Guarantee stated in clause no 10.
- ii. The Manufacturer/Repairer shall furnish Composite Bank Guarantee of appropriate amount to OPTCL covering 10% for destination cost of work order well in advance within 15days from the date of issue of work order & treated as acceptance of order. In the event of any breach or default in all or any condition of the contract, the contract Security-cum-performance guarantee shall be forfeited.
- iv. No interest shall be payable on contract Security-cum-Performance Guarantee.

#### **6. EXTENSION OF TIME:**

If the Completion of work is delayed due to reasons beyond the control of the Contractor, the Contractor shall without delay give notice to the purchaser in writing of his claim for an extension of time. The Purchaser on

receipt of such notice may or may not agree to extend the contract period date as may be reasonable but without prejudice to other terms and conditions of the contract.

#### 7. PRICE REDUCTION FOR DELAY IN COMPLETION OF CONTRACT:

- a. If the executing agency fails to complete the work within the time period as specified in the contract including extension of time, if any, granted there to, OPTCL shall have the right to reduce price @0.5% for each week of delay or part thereof limited to maximum of 5% of contract Price.
- b. OPTCL shall recover the price reduction schedule from the bills of the executing agency.
- c. However, if the price reduction schedule remain un-recovered the same shall be recovered from the Contract Performance Bank guarantee.

#### 8. COMPLETION OF WORK:

- i. The works awarded should be commenced within 15 days of the award of the contract and to be completed within 60 days from the date of issue of work order.
- ii. The work should be executed to the full satisfaction of the concerned Authorities strictly as per the direction laid down in the work order/instruction of the Officer In-charge. Any substandard materials supplied/substandard work noticed/negligence in discharging the entrusted works should be replaced/rectified immediately on receipt of such complaint from the concerned officers in charge. Non-response to the above complaint may lead to termination of the work order with forfeiture of security deposit.

#### 9. Security Deposit

- i. 10 % of the ordered value as security deposit will be deducted from the bill. The security deposit will be released after two months of completion of the Guarantee period subject to fulfilment of guarantee stated under clause no 10 below on a receipt of application for this purpose. No interest shall be paid to Contractor towards the security deposit so deposited by him.
- ii. If Security deposit not claimed for refund within a period of three years after completion of work, it will be forfeited.
- iii. In case of non-fulfilment of contractual obligation, the security deposit (BG/ Cash) shall be forfeited.
- iv. Whenever any claim against the contractor for the payment of a sum of money arises out of or under the contract, OPTCL shall be entitled to recover such sum of appropriating in part or whole from the security deposit of the Contractor. In the event of Security deposit being insufficient, the balance or the total sum recoverable as the case may be shall be deducted from any sum then due or which at any time thereafter may become due. The Contractor shall pay to OPTCL on demand any such balance remaining due.
- v. In the event of any breach of the terms of the contract by the Contractor or any loss or damage occurred to OPTCL which in the opinion of OPTCL has arisen, the decision where of shall be final and binding on the Contractor or in the event of the termination of the contract or for any such breach the security deposit liable to be forfeited. The decision of forfeiture shall be final and binding on the Contractor.

#### 10. GUARANTEE:

The work shall be guaranteed against defects in design, quality of materials used, workmanship of the repair & satisfactory performance for a period of 24 months (Twenty Four) from the date of completion or 18 months from the date of commissioning whichever is earlier. Any defects noticed during this period should be rectified/replaced by the firm free of cost to OPTCL provided such defects are due to faulty design, bad workmanship or bad material used within three months upon written notice from the purchaser ,failing which the security deposit/BG will be forfeited..

The above Guarantee Certificate shall be furnished in triplicate to the undersigned for his approval.

#### 11. **FORCE MAJEURE**:

The Contractor shall not be liable for any penalty for delay or for failure to perform the contract for reasons of force majeure such as acts of god, acts of the public enemy, acts of Govt., Fires, floods, epidemics, Quarantine restrictions, strikes, Freight Embargo and provided that the Contractor shall

within Ten (10) days from the beginning of delay on such account notify the purchaser in writing of the cause of delay. The purchaser shall verify the facts and grant such extension, if facts justify.

#### 12. AUTHORITY:

#### 13. **GST & PAN**:

Any dispute or difference arising out of the contract shall be mutually settled, but if the Contractor disagrees to such settlement, the decision of the General Manager, EHT (O & M) Circle, Chainpal or his authorized representative shall be final & binding.

#### 19. JURISDICTION OF THE HIGH COURT OF ODISHA. :

Suits, if any, arising out of this contract shall be filed by either Party in a court of Law to which the jurisdiction of High court of ODISHA extends.

#### 20. <u>CORRESPONDENCE</u>:

- i. Any notice to the Contractor under the terms of the contract shall be served by Registered/Speed Post or by hand at the Contractor's Principal Place of Business.
- ii. Any notice to the Purchaser shall be served at the Purchaser's Principal Office in the same manner.

#### 21. OUTRIGHT REJECTION OF TENDERES:

The tender shall be outright rejected if they do not comply the following requirements.

e-RA shall be carried out after opening of Price bids and completion of Price bid evaluation, which will be intimated only to the techno-commercially qualified bidders by OPTCL as per procedure given below.

b. OPTCL reserves the right to conduct e-RA and it is obligatory on part of bidder(s) invited to participate in e-RA process once they have responded to the techno-commercial bid.

Prior intimation/ Notice for RA invitation will be given to techno-commercially qualified bidders regarding the date & time of opening of the e-RA.

The start bid price (SBP) for e-Reverse Auction of each bidder under a particular package shall be the L1 evaluated price for the subject package including Taxes & Duties for the total scope for subject Package. Taking the above discovered L1 price as the upper limit e-RA will be conducted to determine the lowest possible price.

Reverse Auction will be conducted amongst first 50% of the technically qualified bidders arranged in order of prices from lowest to highest, as L1, L2,L3 ------- Ln, and L1 price will be discovered. Minimum of 3 bidders shall be eligible for e RA. (eg. If 4 bidders are financially evaluated then the L1, L2 and L3 bidders shall be eligible for e-RA). Number of bidders eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L1 to L4).

However, in case only two bidders are found to be responsive, e-RA would be carried out with both the parties without any elimination. However, OPTCL reserves the right to invite the evaluated L1 bidder for negotiation without conducting the e-RA.

In case of price submitted by any bidder is found to be abnormal, OPTCL reserves the right to reject the bid of the bidder(s).

Rank of bidders would be displayed as per the total cost to OPTCL, i.e including Taxes and Duties payable by OPTCL as per the provisions of the biding document & after e-RA process is over.

Names of bidders/ vendors shall not be disclosed during the e-RA process. Names of bidders/ vendors shall be anonymously masked in the e-RA process.

In case of RA, start/reference price and step value of decrement shall be indicated to the bidders at the start of the auction. Any participating bidder can bid one or multiple step decrement lower than the prevailing lowes bid at that time. The Bidder shall be able to view Bid Start Price, Bid Decrement Value, Prevailing Lowest Bid value, last Bid Placed by him and time left for bidding.

The step value of decrement in a package to be offered by bidder (the minimum amount of reduction in the total bid price including all taxes & duties during auction), shall be kept at 0.15% of L1 bidder's final evaluated price (or) at approved amount as decided by OPTCL.

Bidders can only quote any value lower than their previous quoted price. However, at no stage, increase in Price will be permissible.

- (iv)At any point during Reverse Auction, bidding Price field shall remain enabled for the bidders. The reverse auction period shall be **unlimited** and the initial auction period (1st slot) will be of thirty (30) minutes with provision of auto extension by (10) ten minutes from the schedule/ extended closing time. If any fresh lower bid is received in last ten minutes of initial auction period or extended auction period, the auction shall get extended automatically for another 10 minutes. In case, there is no b id received during schedule/extended slot, the auction shall get closed automatically without further extension.
- (v) However, bidders are advised not to wait till the last minute or last few seconds to enter their bid during the period of e-reverse auction to avoid complication related with internet connectivity, network problem, system crash down, power failure etc.

After conclusion of e-Reverse Auction i.e (Closing Price in Reverse Auction will be taken as offered price by the L1 bidder), decrease in price of individual head of the template shall be considered proportionately on all individual line items of the respective head of the price schedule of the successful L1 bidder.

Any bid received at the tender wizard server end subsequent to closure of the e-RA shall be summarily rejected

Any bid received at the tender wizard server end subsequent to closure of the e-RA shall be summarily rejected and shall not be considered as a valid bid under whatsoever circumstances. For this purpose, tender wizard server log shall prevail.

The bidder shall not involve himself or any of his representatives in price manipulation of any kind directly or indirectly by communicating with other bidders.

During Reverse Auction, If no bid is received within the specified time, OPTCL, at its discretion, may decide to close the reverse auction process/ proceed with conventional mode of tendering [Evaluation of (price bid) submitted by bidders earlier].

9 Consequent upon completion of e-Reverse Auction, OPTCL's decision on award of contract shall be final and binding on the bidders.

OPTCL shall be at liberty to call the L1 bidder for further process/ negotiation and also at liberty to cancel the e-reverse auction process/ re-tender at any time, without assigning any reason thereof. OPTCL can decide to reschedule or cancel any reverse auction: the bidders shall be informed accordingly.

OPTCL/ Service Provider shall not have any liability to bidders for any interruption or delay in access to the e-Tender site/ Reverse Auction link irrespective of the cause.
