(O&M) Division, Jharsuguda invites sealed Tenders in duplicate from intending experienced electrical Contractors having valid Contract License, PAN card with GSTIN Certificate for supply and fitting of 01No. of indoor floor mounted ACDB and 01No. of DCDB for the new control room at 132/33kV Grid Sub-Station, Brajrajnagar under EHT (O&M) Division, Jharsuguda.

The tender specification can be obtained from the office of The General Manager (El.), EHT (O&M) Division, Jharsuguda on payment of Rs. 2000/- (two Thousand only) + GST @ 12% (Non Refundable) in shape of Cash/Bank Draft in favor of EHT (O&M) DIVISION, JHARSUGUDA payable at Jharsuguda on any working day from **Dt. 11-07-2019 to Dt. 27-07-2019** during office hour. In case the B.D made any other nationalized bank payable at any clearing branch at Jharsuguda will be allowed, but the bidders have to deposit the collection fee (Bank transaction fee) along with the paper cost. The collection fee & Paper cost is Nonrefundable. Additional amount of Rs.100/- (One Hundred only) may be paid extra for postal delivery of the tender specification. The undersigned shall not be held responsible for any postal delay.

The Tender shall be received Up to 01:00 PM of dated 29.07-2019 & will be opened at 03:00 Hrs of same day in the Office of the undersigned in the presence of the Bidders (or) their Authorized Representatives present if any. If any of the above date happens to be a holiday, the next working day will be the corresponding effective date. One Tender paper shall be issued to one Bidder. E.M.D @ 1% of the estimated value i.e. **Rs. 3,558/-** should be deposited in shape of Demand Draft / Cash in favour of E.H.T. (O&M) Division, Jharsuguda & payable at Jharsuguda along with Self Attested Copy of PAN and GSTIN Certificate failing which the tender will be liable for rejection.
