



The tender specification can be obtained from the office of the Deputy General Manager (Elect.), EHT Construction Division, Bhubaneswar-751022 from 10 A.M. to 3 P.M. during **Dt. 10/10/2017 to Dt. 20/10/2017** on any working day (except 20.10.2017-1.00P.M.), on payment Rs.2,000/-+GST as applicable (non-refundable) towards cost of tender documents in shape of Demand Draft/Banker's Cheque drawn from any nationalized bank in favour of "**EHTC Division, Bhubaneswar**" payable at **Bhubaneswar**.

Complete bids will be received up to 1.00 P.M. of Dt. **20.10.2017** and the bids will be opened at **04.00 P.M** on the same day at the office of Deputy General Manager (Elect.), EHT Construction Division, Bhubaneswar-751022. Date and time of opening of price bids shall be intimated to the techno-commercially qualified bidders only. In the event of any specified date for the sale, submission or opening of bids being declared a holiday for OPTCL, bids will be sold/ received/ opened up to the appointed times on the next working day.
