1. TENDERS:

- B) Tender must be submitted in sealed cover subscribed as "O.T No. 02/2018-19: Supply of various type clamps, connectors & nut bolts for Grid S/s Berhampur, Narendrapur & Digapahandi".
- C) Tender shall be submitted either in person or by registered post & any other means of delivery shall not be accepted. Detailed postal address with PIN No., Phone / Fax/Email of bidder must be mentioned in the application requesting for tender document and on the tender bid. The authority is not responsible for receipt of tender after due date due to postal delay or any other reasons. The tender should be posted by the registry post to reach at Odisha Power Transmission Corporation Ltd., Office of the Dy. General Manager, EHT (O & M) Division, Berhampur, Duduma colony, Digaphandi Road, Berhampur-700 006, Odisha. Tenders received after due date due to postal delay or any other reason will not be considered. 2. FORFEITURE OF EMD:

- A) In the event the successful tenderer fails to supply the materials as per the technical specification, the EMD so deposited shall be forfeited.
- B) Any deviation from the terms and conditions of the contract the EMD so deposited shall be forfeited without any notice.
- C) The EMD not claimed within a period of **one year** from the date of issue of this order & the Security deposit not claimed for refund within **three years** after completion of contract, will be forfeited. Hence you are requested to claim the EMD & the Security deposit within the scheduled period.

3. <u>INFORMATION ON COMPETITORS:</u>

Bidders have right to know information on competitors only at the time of opening of the bids. No further information on competitors shall be provided at any other point / stage of the tender without prejudice to Right to Information Act - 2005.

4. OPENING OF TENDERS:

- A) Copy of PAN card, GST Registration must be enclosed with the tender bids.
- **B)** Bidders themselves or their authorized representatives limited to one person only (possessing authorization letter in original) shall be allowed to attend opening event of the tenders.
- **6.** The purchaser may alter the quantities of materials at the time of placing orders. Orders may also be split up among more than one tenderer if necessary. The purchaser reserves the right to reject the lowest or any other Tender or all tenders without assigning any reason what so ever.
- **7.** Tender should be prepared clearly and without any overwriting and corrections. Erasures and other changes shall bear the dated initial of the person signing the Tender.
- **8.** In the event of discrepancy or arithmetical error in the schedule of price, the decision of the purchaser shall be final and binding on the tenderer. For evaluation, the price mentioned in words shall be taken if there is any difference in figure and word in the price bid.

GENERAL TERMS AND CONDITIONS

- **1.** <u>Validity:</u> Tenderers are requested to keep the validity of their offer for a period of 03months from the date of opening of tender.
- **2.** <u>Scope of Contract:</u> The scope of the contract shall be to deliver the materials on at the destination sites i.e at Grid Sub-station, Berhampur in accordance with the technical specification.
- **3.** <u>Sample & Test Certificate:</u> One set sample / Type Test Certificate has to be submitted by the tenderer for approval for verification. The test certificate from ISI approved testing laboratory will also be accepted as and where applicable.
- **4.** <u>Price:</u> The price quoted by tenderer should be firm, F.O.R. destination inclusive of freight, Insurance, Packing, Forwarding charges inclusive discount, if any. Taxes, if any shall be mentioned extra.
- **Terms of Payment**: 100% payment with taxes etc shall be made after receipt of materials in full and in good condition & verification thereof by the consignee.
- **6.** <u>Delivery:</u> The materials in full quantity shall be delivered within 30 days of receipt of purchase order, failing which purchase order shall be liable for cancellation with forfeiture of Earnest money/ Security Deposit.
- 7. Penalty: If the supplier shall fail to deliver the materials within the delivery period as stipulated under clause No. 6 (Section-II) of this Tender document or any extension granted there to, the purchaser shall recover from the supplier penalty for a sum of half percent (i.e. 0.5 %) of the contract price for each calendar week or part thereof of delay. However the total amount of penalty shall not exceed 5% (five percent) of the contract/ undelivered items price. Materials will be deemed to have been delivered only when all the component parts are also delivered. If certain components are not delivered in time, the supply will be treated as delayed until such time the missing/ undelivered parts are delivered period.
- **8.** Extension of time: If the delivery of materials is delayed due to reason beyond the control of supplier, the supplier shall without delay give justification. The purchaser on receipt of such notice may agree to extend the contract delivery date if reasonable but without prejudice to other terms and conditions of this contract.
- 9. Security Deposit: The tenderers whose offer qualifies for acceptance will be awarded the Order and the supplier shall have to be deposit Security-cum-performance guarantee equal to 10% (Ten percent) of contract value in shape of Cash / Bank Draft/B.G/K.V.P in favour of Dy. General Manager, EHT (O&M) Division, Berhampur. The Security deposit will be released after two months of completion of the guarantee period subject to fulfillment of guarantee stated under clause-10 on a receipt of application for this purpose. No interest shall be paid to the supplier towards the security deposit so deposited by the supplier.
- 10. Guarantee: The materials covered under this contract should be guaranteed for trouble free and satisfactory performance against any defect in design, materials and workmanship for a Period of either at least 18 (Eighteen) months from the date of delivery or 12(Twelve) month from the date of use. Any defect noticed during this period should be rectified / replaced by the firm free of cost provided such defects are due to faulty design, bad workmanship or bad materials used. The replaced materials

- should also have similar guarantee. In the event of any breach on default in all or any condition of purchase order Security Deposit will be forfeited.
- 11. <u>Insurance:</u> Insurance of materials is to be done by the supplier at their own cost. The responsibility of delivery of the materials at destination in good condition rests with the supplier. Any claim with the insurance company Railway authority/ Road transport authorities arises due to loss or damage in transits has to be settled by the supplier. The supplier shall undertake free replacement of materials damage or lost which will be reported by the consignee within 30 Days of the receipt of the materials at destination without waiting for the settlement of the claims with the carriers.
- **12.** <u>Despatch Instruction & Consignee:</u> The SDO, TLS, Berhampur is the consignee & verifying officer for the contract.
- 13. <u>Paying Officer:</u> The DGM, EHT (O&M) Division, Berhampur is the paying officer for this contract.
- 14. <u>Rejection of Materials:</u> In the event any of the equipments/ material supplied by the manufacturer is found defective due to faulty design, bad workmanship, bad materials used or otherwise not in conformity with the requirements of the Specification, the Purchaser shall either reject the equipment/material or ask the supplier in writing to rectify or replace the defective equipment/material free of cost to the purchaser. The Supplier on receipt of such notification shall either rectify or replace the defective equipment/material free of cost to the purchaser within 15 days from the date of issue of such notification by the purchaser. If the supplier fails to do so, the Purchaser may:-
- A. At its option replace or rectify such defective equipments/materials and recover the extra costs so involved from the supplier plus fifteen percent and/or.
- B. Terminate the contract for balance work/supplies, with enforcement of penalty Clause as per contract for the un-delivered goods and with forfeiture of Performance Guarantee/ Composite Bank guarantee.
- **15.** Experience: The bidders are required to submit the list of his past experience on supply of similar materials to OPTCL,/DISCOM/OPGC/OHPC or equivalent. Agency having experience will be given preference to others.
- **16.** <u>Jurisdiction of Court</u>: Dispute if any, arising against the supply order issued to the supplier shall be filed by either party in any court of law to which the jurisdiction of Odisha High Court extends.

TECHNICAL SPECIFICATION OF CLAMP, CONNECTOR& NUT BOLTS

This Specification covers supply and delivery of clamps connectors and nut bolts suitable for use in 132 KV and 220 KV Grid S/S of OPTCL.

Standard: The materials to be supplied should be conforming to ISS & IEC standard.

i)	IS:5561 - 1970	Aluminium Clamps and Connectors
ii)	IS:2633	Method of testing of uniformity of coating on zinc
		coated articles
iii)	IS:209	Specification for Zinc.

1. Clamp & Connector:

- The materials offered shall be of first class quality, workmanship, well finished and approved design. All castings shall be free from blow-holes, flaws, cracks of other defects and shall be smooth, close grained and true forms and dimensions.
- All current carrying parts shall be so designed and manufactured that contact resistance is reduced to the minimum.
- The fittings offered shall be inherently resistive to atmospheric corrosion or be suitable to protect against corrosion both during storage as well as in service.
- The clamps/connector shall not cause any damage to the conductor in any way. No part of a clamp shall be less than 15 mm thick for fittings suitable for ACSR Panther/Zebra/ Moose conductor.
- All bolts, clamps, etc. shall have suitable locking arrangements to safe guard against vibration and loosening.
- For bimetallic connectors, copper alloy liner of minimum thickness of 2 mm shall be cast integral with aluminum body.
- The required bolts and nuts for terminal connector must be hot dip galvanized with suitable check nut/washer.

2. Nut & Bolt with spring &flat washer

• All ferrous parts including fasteners shall be hot dip galvanized, after all machining has been completed. Nuts may however be tapped (threaded) after galvanizing and the threads oiled. Spring washers shall be electro-galvanized. The bolt threads shall be undercut to take care of the increase in diameter due to galvanizing. Galvanizing shall be done in accordance with IS-2629-1985 and shall satisfy the tests mentioned in IS 2633-1986. Fasteners shall withstand four dips while spring washers shall withstand three dips of one-minute duration in the standard Preece test. Other galvanized materials shall be guaranteed to withstand at least six successive dips each lasting one minute under the Standard Preece test for galvanizing.
