All other expenses like replacement of Engine Oil, replacement of spare parts, maintenance charges etc., are to be borne by the Travel Agency/Owner of the vehicle. **(i)Engine Oil (Mobil) – One Ltr. on every 750 KM of running.(ii)H.S.D @ 13 KM/Ltr.**
