1. For and on behalf of Odisha Power Transmission Corporation Limited, the Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar invites percentage rate bids in **Double Cover system** for a work through e-procurement as detailed in the table. The bid should be submitted only online in the <http://tenderorissa.gov.in> by eligible class of contractors for construction of building works registered with the State Government and Contractors of Equivalent Grade / Class Registered with Central Government / MES / Railways having registration for execution of civil works. Successful bidders other than State/ MES/Railway/ CPWD equivalent rank have to be registered under the State P.W.D. before signing the agreement.
2. The bidders should submit bid for the work as per the following table :-

Bids must be accompanied by Earnest Money Deposit / Bid Security of the amount @ of 1 % of the estimated cost specified for the work in shape of **Term Deposit Receipt of Nationalised Bank /N.S.C. / K.V.P. / Post Office Savings Bank Account /Post Office Time Deposit Account** pledged in favour of **Superintending Engineer(Civil), Civil Works Circle, OPTCL, Bhubaneswar, payable at Bhubaneswar** and will have to be in any one of the forms as specified in the bidding document. Bidders desirous to hire machineries or equipments from outside the State owned but deployed outside the state are required to furnish 2 % of the amount put to tender as Bid security.

4. The Bid documents will be available in the <http://tendersorissa.gov.in> from **11.00 Hours of 10.09.2018 to 01.10.2018 up to 17.00 Hours.**
5. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
6. Bids shall be received only **“online”** on or before **17.00 Hours of 01.10.2018.**
7. The packet super scribing the name of the work and containing cost of bid document & EMD/Bid Security in original and other documents may be submitted in the office of the undersigned after bid closing date **01.10.2018** and on or before 17.00 Hours on date **05.10.2018** during office hours on working days .Submission of the same by courier/postal will not be received after 17.00 hours of **05.10.2018.**
8. The Cover-I (Techno-Commercial Document) of the Bids received “on line” shall be opened at 10.00 Hours on **06.10.2018** in the office of the Superintending Engineer (Civil), Civil Works Circle, OPTCL, Bhoinagar, Bhubaneswar, in presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids by logging on to the site through their DSC. If the office happens to be closed on the date of opening of Bids as specified, the bids will be opened on the next working day. The date of opening of Cover-II (financial bid) will be communicated in due course of time to the qualified bidders of Cover-I.
9. The bidders shall furnish the self-attested copies of Labour Licence, Contract License, PAN, GSTIN and other documents as mentioned in the DTCN. They may go through the outright rejection criteria as mentioned in the DTCN.
10. Additional performance security shall be obtained from the bidder at the time of drawl of agreement ,he has to submit when the bid amount is less than the estimate cost put to tender. In such an event the bidders who have quoted less bid price/rates than the estimate cost put to tender shall have to furnish the exact amount of differential cost i.e. estimate cost put to tender minus the quoted amount as Additional Performance Security in Shape of NSC/KVP/Term Deposit Receipt from nationalised bank pledged in favour of SE, CWC, OPTCL, BBSR in the sealed envelope .The Tender Cost & EMD should be submitted before tender opening ,failing which the bid will be rejected.

11. For a particular work a bidder can submit only one set of tender paper. Submission of more than one set of tender paper by a bidder for a particular work will be liable for rejection of all such tender paper of the concerned bidder.
12. The cost of bid documents shall be in shape of demand draft drawn in favour of Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar from any Nationalised Bank mentioned at column-6 above, payable at Bhubaneswar **separately** towards cost of tender.
13. The bidders are to submit an affidavit certifying the documents & information furnished by them are genuine.
14. Before tendering, the bidder may visit the sites and satisfy himself, as no claim what-so-ever shall be entertained for any alleged ignorance, after the tender is opened.
15. Corrigendum/Addendum if any will be uploaded in the e procurement portal <http://tendersorissa.gov.in/>.
16. Other details can be seen in the bidding documents.
17. The authority reserves right to cancel any or all bids without assigning any reason thereof.
18. The amount put to tender is inclusive of 1% cess which will be adjusted during payment of bills .
19. The unsuccessful contractors shall have to claim for refund of EMD within a period of one year from the date of drawl of agreement and shall have to claim for Security deposits within a period of three years from the date of completion of DLP, otherwise it will be forfeited.
20. The rates of the items in the estimate have been derived from the current Odisha schedule of rates, Delhi schedule of rates and from local markets wherever applicable.
21. If any bonafide mistake or omission in the wording,description of item,unit,quantity and any clause in TCN / Tender schedule / Tender paper document is left unnoticed & inadvertently & the same is detected after sale of the bid document, then the Tender inviting authority i.e. the Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar reserves every right to correct that and all purchasers will abide by that correction.
