ABOUT:

Civil Works Circle, Bhubaneswar of OPTCL looks after the civil maintenance requirements of over 173 Grid sub-Stations and different office building complexes across Odisha.

QUALIFICATION CRITERIA:

A: For Civil Works:

- I. The agency must be registered with Govt. of Odisha having a valid **C or D class** civil contractor licence with minimum validity of at least up to 31/09/2022.
- II. The agency must be possessing a valid GST & PAN.
- III. The Agency must have completed at least 3 no. of repair works in last 2 years.

B: For Landscaping Works:

- I. The agency must be registered with Govt. of Odisha having a valid **C or D class** civil contractor licence with minimum validity of at least up to 31/09/2022.
- II. The agency must be possessing a valid GST & PAN.
- III. The agency should have nursery registration under his name or agreement with a registered nursery.
- IV. Labour Licence for nursery.

C: For Termite Treatment of Buildings:

- I. The agency must be registered with Govt. of Odisha having a valid



- C or D class** civil contractor licence with minimum validity of at least up to 31/09/2022.
- II. The agency must be possessing a valid GST & PAN.
 - III. The agency should have pest control of India registration or license under his name or agreement with a registered pest control of India agency.

DOCUMENTS REQUIRED:-

- I. Valid contractor license (C&D Class only).
- II. PAN Card with last 3 years IT return acknowledgement copy.
- III. GST Registration Certificate.
- IV. EPF & ESI Certificate(if any) with last 3 months challan.
- V. Experience Certificate for at least 3 no. repair work above 50 thousand to up to 5 lakhs in last 2 years certified by officer not below the rank of Executive Engineer.
- VI. Copy of nursery registration or agreement copy with a registered nursery for application to category B: Landscaping Works.
- VII. Copy of pest control of India registration or agreement copy with a registered agency for application to category C: Termite treatment Works.

SUBMISSION OF APPLICATION:

- I. Application form can be obtained from office of undersigned. The bidders must fill in the forms in Annexure I & II along with the required documents filled in all shape in an envelope super scribing **"EMPANNELMENT APPLICATION FOR CIVIL WORKS CIRCLE, OPTCL: FOR CIVIL WORKS"** or **" FOR LANDSCAPING WORKS"** or **"FOR TERMITE TREATMENT WORKS"**.
- II. The filled in application form along with all requisite documents will be received from 17/09/2021 to 30/09/2021 up to 5.00P.M, in the office of the undersigned except on holidays.
- III. The application will be opened on 01/10/2021 at 11.00A.M in the office of the undersigned in the presence of the bidders or their authorised agent who wish to attend. If the office happens to be closed on the last date of receipt and opening the document will be receive and opening will be done on the next working day at the same time and venue.



- IV. The documents may be submitted to the office of the undersigned physically or by post (speed post/registered post only) on or before 5.00P.M on dated 30.09.2021. The undersigned shall not be responsible for any postal delay.
- V. The bidders are to submit an affidavit certifying the documents & information furnished by them are genuine and they agree to all the terms and condition of the empanelment.
- VI. The Authority reserves the right to reject any or all applications without assigning any reason thereof.
- VII. The submission of application shall be deemed as bidders acceptance to work anywhere in Odisha.

SELECTION OF BIDDERS:

- I. The bidders shall be invited for individual work from the empaneled list having valid GST & License based on the discretion of the undersigned.
- II. Preference will be given to those contractors, who have successful records of completing & executing Qualitative works under OPTCL.
- III. Time being essence of each project, the bidders with good on-time completion track record will be preferred over others.
- IV. The bidders having EPF & ESI certificate will be preferred for 'higher risk' works based on the risk assessment of the divisional heads. The bidders not possessing the same shall only be considered for general repair works.
- V. A bidder can ordinarily have maximum of 2 nos. of running work orders at any given time. However the undersigned reserves the right for change of criteria as and when required in case of emergency.
- VI. For Landscaping works, bidders with prior experience in Govt. / PSU shall be preferred.
- VII. Empanelment alone doesn't guarantee invitation for works and the discretion of selection of bidders lies solely with the undersigned.
- VIII. Complaints received against any bidder in any form regarding quality, late completion or any such reason thereof shall make the bidder liable for rejection from any future consideration.
- IX. The bidder can be invited for works outside his preferred section and



the choice of preferred section is not abiding. The empanelment list being a state-wide list, the bidders agree to work in any place across Odisha.

- X. Multiple application from single bidder for same category work shall be rejected.
