E.M.D @ 1% of the estimated value i.e. Rs.4,987/- should be deposited in shape of Demand Draft / Cash in favour of E.H.T. (O&M) Division, Jharsuguda & payable at Jharsuguda along with Self Attested Copy of PAN and GSTIN Certificate failing which the tender will be liable for rejection.

ELIGIBILITY FOR SUBMISSION OF BIDS:-

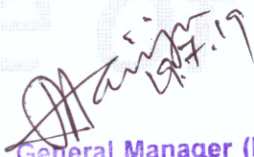
