For and on behalf of Odisha Power Transmission Corporation Limited, the Executive Engineer, Civil Works Division No-I, OPTCL, BBSR invites PERCENTAGE RATE BIDS in sealed cover from the eligible contractors registered with the State Govt. and contactors of equivalent trade / class registered with the central Government /Manufacturers/ MES / Railways with adequate experience for the execution of civil works having a definite proof from the appropriate authority.

5. The sale of the Bid documents shall start from dtd 26.11.2020 & closed on dated 9.12.2020 at 5.00 PM everyday & receipt of the bid documents shall start from 26.11.2020 to 09.12.2020 at 5.00 pm. The Bid shall be received in all offices as well as office of the undersigned where the bids have noticed to be sold.

6. The Bids will be opened on 10.12.2020 at 11.00 A.M. in the office of the undersigned in the presence of the bidders or their authorized agent who wish to attend. If the office happens to be closed on the last date of sale/receipt and opening of the bids as specified the bids will sold/received and opening on the next working day at the same time and venue.

- 7. Bid must be delivered in the tender box having identification NO. E.E. CWD- EE-6/20-21
- 8. Bid document can be purchased from all offices mentioned in the table column 4 against a nonrefundable fee towards cost of the documents as indicated in column 6 of the table in only DemandDraft issued from any Scheduled Bank payable at Bhubaneswar in favor of M/S Civil Works Division, OPTCL, BBSR. Tender papers will not be issued if payment is made in cash.
- 9. Bidding documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs. 500.00 over cost of documents. The Executive Engineer, Civil Works Division NO-I, OPTCL, BBSR will not be held responsible for the postal delay if any in the delivery of the documents or non-receipt of the same in time.
- 10. The bidders shall furnish the copies of all valid Contract Registration certificates, PAN Card, GST certificate, Xerox or original copy of money receipt along with the Bid failing which his/her bid shall not be considered.
- 11. All the facilities as per Notifications/circulars / orders of Government / OPTCL will be available to the eligible Bidders
- 12. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
- 13. Other details can be seen in the bid documents.
- 14. The amount tendered is excluding of GST. While passing bills, GST to be included at the applicable rates observing reverse charge procedure in the bill. The contractor have to deposit the GST amount which are paid by OPTCL along with the contractor bill to the respective Govt Dept within due date and time.
- 15. The amount put to tender is inclusive of 1% cess which will be adjusted during payment of bills. The contractor shall have to produce labour liscence within seven days of agreement if required by the undersigned
- 16. The bidder whose quoted rate is less than the estimated cost by more than 14.99 % will be rejected. The bidder who have quoted less bid price / rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e estimated cost put to tender minus the quoted amount in shape of DD / TDR pleged in favour of EE, CWD-1, OPTCL, BBSR failing which the bids will be rejected.
- 17. The Successful contractors shall have to claim for refund of EMD within a period of one year and shall have to claim for refund of Security deposits within a period of three years from the date of completion of contract, Otherwise it will be forfieted.
- 18. If any bonafide mistake or mmission in the wording, description of item, unit, quantity and any clause in TCN/Tender Schedule/Tender Paperdocuments is left unnoticed & inadvetently & the same is detected after sale of the bid document, then the tender inviting authority i.e. the Executive Engineer, Civil Works Division No-I,OPTCL,Bhubaneswar reserves every right to correct that and all purchasers will be abide by that correction.
