For and on behalf of Odisha Power Transmission Corporation Limited, the Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar invites item rate bids in **Single Cover system** for the works through e-procurement as detailed in the table. The bid should be submitted only online in the http://tendersodisha.gov.in by eligible class of contractors for construction of building works registered with the State Government and Contractors of Equivalent Grade / Class Registered with Central Government / MES / Railways having registration for execution of civil works can participate in the works on production of definite proof from the appropriate authority. But successful bidder other than State/ MES/Railway/ CPWD equivalent rank has to be registered under the State P.W.D. before signing the agreement. The bidders should have the necessary Portal Enrolment (with his own digital signature certificate).
- 2. The bidders may submit bid for the works as per the following table :-

- 3. Bid documents consisting of specifications, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the website http://tendersodisha.gov.in as specified at column-8 above except on Sundays and public holidays.
- 4. The Bid documents will be available in the http://tendersodisha.gov.in from 11.00 Hours of 24.04.2023 to 15.05.2023 up to 17.00 Hours.

5. Bids be accompanied by and Earnest Money Deposit / Bid Security of the amount @ of 1 %

of the estimated cost put to tender specified for the work in shape of Deposit Receipt of Schedule Bank /N.S.C. / K.V.P. / Post Office Savings Bank Account /Post Office Time Deposit Account pledged in favour of EE, CWD-I, OPTCL BBSR and will have to be in any one of the forms as specified in the bidding document. Bidders desirous to hire machineries or equipment's from outside the State or owned but deployed outside the state are required to furnish 2 % of the amount put to tender as Bid security.

- 6. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class-III or Class-III.
- 7. Bids shall be received only "online" on or before 17.00 Hours of 15.05.2023.
- 8. The Bids received "on line" shall be opened at 11.00 Hours on dtd.17.05.2023 in the office of the Superintending Engineer (Civil), Civil Works Circle, OPTCL, Bhoinagar, Bhubaneswar, in the presence of bidders who wish to attend Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on at the date of opening of Bids as specified, the bids will be opened on the next working day.
- 9. The bidders shall furnish the self-attested copies of Contract License, PAN, GSTIN and other documents as mentioned in clauses of the DTCN. They may go through the outright rejection criteria as mentioned in DTCN.
 - 10. Additional performance security shall be obtained from the bidder **before drawl of agreement**, he has to submit the Additional Performance Security for the amount as detailed below in Shape of Bank Guarantee/ NSC/KVP/Term Deposit Receipt pledge in favour of **EE**, **CWD-I**, **OPTCL**, **Bhubaneswar at the time of agreement**.

- 11. ISD (Initial Security Deposit) value is 1% of the bid amount and is to be deposited by the contractor before drawl / signing of the agreement in the shape Bank Guarantee/ NSC/KVP/Term Deposit Receipt pledge in favour of EE, CWD-I, OPTCL, Bhubaneswar at the time of agreement.
- 12. Exemption holder like SC/ST contractors should submit attested copy of caste certificates and an application for rate preference and for availing the facilities. The Security Deposit(Earnest Money, Initial Security and Performance Security) at half the usual rate may be deposited/ realised by/ from the Scheduled Caste or Scheduled Tribe Contractors coming under the categories upto "B" Class only as against the prescribed bids.

- 13. E-Reverse Auction (if applicable) shall be held on www.tenderwizard.com/OPTCL amongst the technically qualified bidders who will be invited as per the terms laid in DTCN.
- 14. For a particular work a bidder can submit only one set of tender paper. Submission of more than one set of tender paper by a bidder for a particular work will be liable for rejection of all such tender paper of the concerned bidder. A bidder cannot be purchaser of tender paper of another bidder.
- 15. The packet super scribing the name of the work and containing cost of bid document in original and other documents may be submitted to the office of the undersigned physically or by post(speed post/registered post only) on or before 17.00 Hours on dated 16.05.2023. The undersigned shall not be responsible for only postal delay. The tenders shall be opened on dated at 11:00 Hrs of 17.05.2023.
- 16. The cost of bid documents in shape of demand draft drawn in favour of Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar on any Scheduled Bank mentioned at column-5 above, payable at Bhubaneswar separately towards cost of each tender.
- 17. The bidders are to submit an affidavit certifying the documents & information furnished by them are genuine.
- 18. Before tendering, the bidder may visit the sites and satisfy himself, as no claim what-so-ever shall be entertained for any alleged ignorance, after the tender is opened.
 - 19. Corrigendum/Addendum if any will be uploaded in the e procurement portal http://tendersodisha.gov.in/. Other details can be seen in the bidding documents.
- 20. The authority reserves right to cancel any or all bids without assigning any reason thereof.
- 21. The amount put to tender is inclusive of 1% cess which will be adjusted during payment of bills .The contractor shall have to produce labour licence within seven days of agreement if required by the undersigned.
- 22. EPF and ESI certificate with last 03 month (i.e, January 2023 to March 2023) updated challan is mandatory for qualification.
- 23. If any bonafide mistake or omission in the wording, description of item, unit, quantity and any clause in TCN / Tender schedule / Tender paper document is left unnoticed & inadvertently & the same is detected after sale of the bid document, then the Tender inviting authority i.e. the Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar reserves every right to correct that and all purchasers will abide by that correction.
