(size W-755mm, H-915mm) for 220/132/33KV Grid Sub-Station, Budhipadar under EHT (O&M) Division, Jharsuguda.

(O&M) Division, Jharsuguda & payable at Jharsuguda along with Self Attested Copy of PAN and GSTIN Certificate failing which the tender will be liable for rejection.
