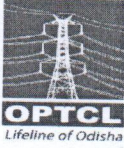

4	TOP UP FACILITY	To be provided by the insurance company. And, financial bid to be submitted accordingly.	Top-up bid is separated from existing financial bidding
5	SUB-LIMITS FOR DISEASES	As per sub-limits specified separately in sheet-1	Sub Limit Capping is deleted
6	ADVANCE PROCEDURE	Covered up to family Sum Insured.	The coverage of advance procedure will be covered upto the family sum insured subject to IRDAI regulation

10	AIR AMBULANCE	To be covered limited to family sum insured.	Air ambulance clause from tender is deleted.
11	FOREIGN TREATMENT	To be covered	Foreign treatment clause from tender is deleted.
12	FINANCIAL BID	Annexure-VIII of the tender document, filling up of all the columns are mandatory.	Financial bid is revised and the bid should only contain bidding space for sum insured towards regular and retired employees.
