The Government of India (herein after referred to as borrower) and Odisha Power Transmission Corporation Limited (OPTCL) (herein after referred to as executing agency) has received a ODA loan from Japan International Cooperation Agency (JICA) (formerly JBIC) ), in the amount of JPY 21,787 Million Japanese Yen, equivalent to approximately USD 182 Million, or approximately Rs. 1,1467 Million towards the cost of Odisha Power Transmission System Improvement Project. Disbursement of an ODA Loan by JICA will be subject, in all respects, to the terms and conditions of the Loan Agreement, including the disbursement procedures and the "Guidelines for Procurement under JICA ODA Loans." No party other than Government of India and OPTCL shall derive any rights from the Loan Agreement or have any claim to loan proceeds.

The above Loan Agreement will cover major part of the project cost. As for the remaining portion, Government of India and OPTCL will take appropriate measures for finance."

- 2. Bidding will be conducted through procedures in accordance with the applicable Guidelines for Procurement under Japanese ODA Loans, and is open to all Bidders from eligible source countries, as defined in the Loan Agreement.

The OPTCL now invites sealed Bids from eligible Bidders for the construction and completion of Design, Supply and Installation of Sub-Stations & Transmission Lines for Procurement of AIS S/S & 132kV DC Line at Gondia, Rajnagar & Bahugram in Odisha State of India under Package-6 ("the Facilities"). International Competitive Bidding will be conducted in accordance with JICA's Single-Stage Two Envelop Bidding Procedure.
