The bidders are allowed to quote their bid having the registration of their vehicles within three years i.e on or after 1<sup>st</sup> September, 2010. The required diesel and mobile (lubricants) will be supplied by the vehicle owner and the cost of such fuel and lubricants only will be reimbursed during submission of monthly bills by producing original fuel vouchers. No other expenditure will be entertained by OPTCL. The consumption of diesel should not be less than 13Kms per litre and lubricant of one litre mobile oil for every 750 Kms run of the vehicle. The bidders are required to produce the copies of the following documents along with quotations and to produce the original documents at the time of opening of tender for verification.

Photocopy of RC book, driving licence of driver, valid insurance coverage, valid non-pollution certificate, PAN/TIN of the agency / owner, valid taxi permit and fitness certificate.

The tender should reach this office on or before 1.00PM of Dt. 7.10.2013 and will be opened at 3.30PM on the same day. The bidders are required to deposit an amount of 1% of their quoted rates as EMD in shape of Demand Draft / Cash in favour of G.M., EHT O & M Circle, Berhampur. Incomplete tender and tender without requisite EMD will be rejected. The undersigned reserves the right to accept or reject any or all tenders without assigning any reason thereof.
