CIRCULAR

In pursuance of Office Order No. 3182 Dated 04.2.2026 issued by the Finance Department, Govt. of Odisha regarding extension of Odisha Electric Vehicle Policy 2021, OPTCL is pleased to extend the existing **Electric Vehicle Advance Policy** on the following terms and conditions:

1. The advance will be sanctioned subject to the **availability of the budget**.
2. The advance will be **interest-free** and will be granted to eligible employees for the purchase of **electric two-wheeler** and **electric car**.

Sl. No.	Category of Employees	Vehicle Type	Maximum Loan Amount
1	NE-9 & NE-10/ EE-2 & above	Electric-operated motor car	75% of the cost of the vehicle (Ex-showroom Price) or repaying capacity, limited to Rs. 15 Lakh
2	NE-1 to NE-8	Electric two-wheeler	75% of the cost of the vehicle (Ex-showroom Price) or repaying capacity, limited to Rs. 2 Lakh

- Employees eligible for motor cars can also avail electric two-wheelers as per their requirements.
- 3. Further, in line with the above-mentioned Office Order issued by Finance Department, Govt. of Odisha, the following timelines shall be adhered to for availing interest free EV advance by OPTCL employees:
 - a. Last date for Receipt of Applications: **28th February 2026**.
 - b. Last date for sanction of advance and release of funds: **10th March, 2026**.

All the other terms and conditions, as mentioned in Circular No. 3358 Dated 03.03.2023 will remain the same.


