Odisha Power Transmission Corporation Limited (OPTCL), a State owned Power Utility in Odisha is engaged in the business of Transmission of electricity with a vision to emerge as one of the leading power utilities in the country in Transmission space.

OPTCL invites applications from young and meritorious aspirants for engagement of different disciplines Degree (Engineering. and Non-Engineering.), Diploma and Trade (ITI) Apprentices for one year. Selection will be made on the basis of Academic merit / Written Test / interview as required.

- Number of vacancies against each trade / discipline may change i.e. increased or decreased as per the requirement of corporation.
- OPTCL will pay 50% stipend to Degree Engineering Apprentice, Diploma Technician Apprentice, Degree Non-Engineering Apprentice and rest 50% will be paid by BOPT through DBT.
- The apprentice seats will be filled as per the reservation rules applicable.
- If a vacancy remains unfilled due to the unavailability of suitable candidates in a specific discipline, candidates from other disciplines within the same apprenticeship type (degree, diploma, or ITI) will be considered.

Eligibility Conditions

1. Indian Nationals belonging to the **state of Odisha** are only eligible to apply.
2. Age: Candidate should not be less than eighteen years of age as on 01.08.2026.
3. Educational Qualification: As per **Table-A**.
4. The prescribed qualification shall be from a recognized Board / Council / University / Institute as a regular full-time course.
5. Candidates shall have Minimum Physical Standard as prescribed in Clause 4 of the Apprenticeship Rules 1992 and amended thereof.
6. Candidates who have completed Apprenticeship training as per Apprentices Act 1961 or job experience for a period of one year or more shall not be eligible to apply.
7. The candidate who are appearing for requisite essential qualifying examination will not be eligible to apply.
8. The candidate should have the passing certificate / final year mark sheet of the required qualification as on 01.07.2026.
9. The gap between the date of joining in Apprenticeship Training and passing date of essential qualifying examination for Apprentices **should not be more than 3 years** and passed during Academic Year **2023-24, 2024-25 & 2025-26**.
10. Candidates must have registered at **NAPS / NATS** portal and **the bank account of candidates must be seeded with Aadhar Number of the candidate for DBT**.

Period of Apprenticeship Training

1. The period of apprenticeship training shall be one year i.e. 12 Months.
2. The training period shall commence from the online contract date of Apprenticeship Training and will continue for a duration of one year. Apprentices shall be entitled to a stipend from the start of the online contract date, subject to their satisfactory performance during the training period.
3. It shall not be obligatory in the part of OPTCL to offer employment to any apprentice who has completed his / her apprenticeship, nor can an apprentice claim right for employment on the ground of completion of Apprenticeship Training.

Location of Apprentice Training

1. Apprenticeship Training will be provided at different Units and offices of OPTCL spread across all over Odisha.
2. No accommodation or allowance in lieu thereof shall be provided to the engaged apprentices by OPTCL at the training locations.
3. Apprentices shall have to abide by safety rules strictly at their respective places of engagement.

Procedure for Submission of Application

Interested candidates who fulfils the eligibility criteria may submit their application as below:

- a. Candidates should first register themselves (as a candidate) on NAPS / NATS portal.

1. The Degree Engg. (Electrical, IT & Telecomm) and Diploma (Electrical, Telecomm & Civil) apprentice and Degree Non-Engg. (HR, Finance & Law) aspirants need to register themselves at NATS 2.0 portal i.e. <https://nats.education.gov.in/> .
2. The ITI Trade apprentices need to register themselves at NAPS portal i.e. <https://apprenticeshipindia.gov.in>
3. The candidate must ensure that, his/her Aadhar is seeded with Bank Account for DBT.
- b. After generation the registration / enrolment number from the NATS/NAPS portal they should apply on the OPTCL website as per the following steps: -

Educational, Personal, Bank account details and Aadhaar Card details must be entered duly in profile of respective apprenticeship portal login by the candidate. Any discrepancy or lacunae found in this regard at any stage will render the candidate ineligible for the Apprenticeship training.
- b. Canvassing / Pressuring through any source will disqualify the candidature and their name will be removed from our official record without prior intimation and this organisation will not responsible for such cases.
- c. At any stage of the selection process of Apprentices, if it is found that the candidate has furnished false or incorrect information, then the candidature / engagement of the candidate is liable to be cancelled.
- d. The decision of Management of OPTCL will be final and binding on all candidates on all matters relating to eligibility, acceptance or rejection of the application, mode of selection, and cancellation of the selection process either in part or full etc. No correspondence will be entertained in this regard. Filling up of the seats is solely at the discretion of the Management of OPTCL based on suitability of candidates and no claim will be entertained, if some of these seats are not filled due to unsuitability / insufficient number of candidates.

- e. No TA / DA / Other expenses will be paid for attending Document verification / Interview.
