## **ADVERTISEMENT FOR ENGAGEMENT OF CONSULTANT FOR 765/400 kV PROJECTS IN OPTCL**

### 1. Company profile:

Odisha Power Transmission Corporation Limited (OPTCL), established on 29th March 2004, is a State owned Power Utility in Odisha. OPTCL has infrastructure that spans for about 17261 CKT KMs of transmission line, encompassing a vast and robust transmission network of 207 substations ranging from 132 kV to 400 kV. The growth of OPTCL is supported with advance technologies such as System Automation, STAMS, DRONE based Survey, PG – DARPAN Software, O-LAMP & SAP etc. OPTCL has successfully executed transmission projects up to the 400 kV level and is now planning to venture into the 765 kV transmission system.

### 3. Job description & responsibilities of Consultant:

The Consultant (765 kV Transmission Projects) shall provide strategic, technical, and project management support to OPTCL for pre-tender design/ engineering and review of post tender design/ engineering, procurement, construction, testing, commissioning, and monitoring of 765/400 kV transmission infrastructure projects. However, she/ he will also be responsible for identifying and implementing improvements in the 400 kV system, with a focus on designing cost-optimization measures to enhance operational efficiency within OPTCL. The key responsibilities shall include:

- Provide expert guidance and technical oversight for the implementation of 765/400 kV Grid Substations and associated transmission lines, ensuring adherence to applicable technical standards, quality requirements, and industry best practices.
- Advise OPTCL on all aspects of planning, design, engineering, procurement, construction, testing, commissioning, operation and maintenance of Extra High Voltage (EHV) transmission systems.
- Review and validate engineering designs, technical specifications, bidding documents, contract packages, and procurement strategies for successful execution of the projects.
- Monitor project progress, identify technical and execution-related risks, recommend corrective measures, and support timely completion of projects within approved cost, quality, and safety parameters.
- Coordinate with consultants, contractors, equipment manufacturers, regulatory authorities and other stakeholders to facilitate effective project implementation and resolution of technical and contractual issues.
- Provide technical leadership, mentoring, and capacity building support to OPTCL personnel and submit periodic reports, recommendations, and technical assessments to the Management.
- Perform any other duties and assignments related to the successful implementation of 765/400 kV transmission projects as may be assigned by OPTCL from time to time.

#### **4. Eligibility Conditions:**

- B.Tech./B.E./B.Sc. (Engineering) in Electrical Engineering from a recognized Institution/University.
- An Indian national with maximum age of 63 years as on 01.06.2026.
- Minimum 20 years of professional experience in the design, engineering, execution, or project management of 400 kV/220 kV transmission lines and substations.
- Minimum 5 years of specific experience in 765 kV transmission line or substation projects.
- Proven experience in leading and managing a team of Engineers.
- Demonstrated involvement in the design and execution of at least two 765 kV transmission line or substation projects.
- Strong track record of handling high-voltage transmission infrastructure projects from planning through execution and commissioning.
- Date of Birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/council will only be accepted.

- Officers against whom departmental proceedings or criminal cases are contemplated or pending or who have been penalized for misconduct during their service will not be considered for engagement.

#### **5. Mode of Selection:**

Selection shall be made through personal interview by a duly constituted Selection Committee.

#### **6. Tenure, Terms & Conditions:**

- a. The monthly consolidated remuneration shall be Rs.3,50,000/- to Rs.5,00,000/- depending on experience and qualification.
- b. The engagement shall initially be for a period of Two (02) years. Further extension may be considered based on satisfactory performance and requirement of OPTCL.
- c. She/ he will not be entitled for Dearness Allowance or any other Special Pay or Allowance, over & above the consolidated remuneration.
- d. During the period of engagement, she/he will be entitled to get TA/DA for approved tours admissible to the officers in the rank of Sr. General Manger in line with the Corporation's prevailing norms.
- e. She/ he will be entitled for CUG SIM to be provided by the Corporation & hired vehicle for official use.
- f. Coverage under the Company's Group Health Insurance Scheme shall be provided as per applicable policy provisions.
- g. This is a full-time engagement, hence the appointee shall not accept any other appointment paid or otherwise.
- h. Suitable accommodation shall be provided, subject to availability and in accordance with the prescribed norms of the organization.
- i. The Consultant will be eligible for 10 days of casual leave in a calendar year & will not be carried forward to subsequent years. In case of engagement during mid of the calendar year this leave shall be reduced proportionately. No payment in lieu of unutilized leave will be paid at the end of expiry of contractual period.
- j. The engagement may be terminated by either party by giving two months' notice. The Consultant shall not leave the organization without giving two months' prior notice or she /he will deposit two months' remuneration in lieu of notice period. The Corporation may also terminate the engagement by giving two months' notice in the event of unsatisfactory

performance. However, the Corporation reserves the right to terminate the engagement without notice in cases of misconduct, including but not limited to misappropriation, negligence, or any act causing loss to the Corporation.

- k. She/ he shall be subject to and abide by the Conduct Rules applicable to OPTCL officers.
- l. The Consultant shall disclose any actual or potential conflict of interest and shall not undertake any activity, assignment or engagement that may impair or appear to impair the Consultant's independence, objectivity, integrity or the interests of OPTCL. Failure to do so, shall constitute a material breach and may result in immediate termination of the engagement without notice.
- m. All drawings, designs, calculation sheets, reports, software models/files (including PDF, DWG, XLS, PLS-CADD, STAAD, etc.) and other project-related documents prepared during the engagement shall be handed over to OPTCL and shall remain its exclusive property. The Consultant shall not disclose, reproduce or share any such information with any third party without the prior written approval of OPTCL.
