ORDER

Subject: Functioning of Government Offices from August, 2021, onwards.

All Departments of the State Government and Sub-ordinate Offices in the State shall function with full strength of employees with effect from 2nd August, 2021 until further orders.

It is reiterated that since most of the employees are now fully vaccinated they shall mandatorily to attend office regularly. The employees who are unable to get vaccinated for medical or some other compelling reason(s), may seek exemption from attending Office from the Head of Office, which would be considered on a case-to-case basis. Employees who are neither vaccinated nor exempted would not be permitted to attend office and their absence will be treated as wilful.

All the State Government Offices shall remain closed on 2nd & 4th Saturdays and shall function on other Saturdays of the month.

All the precautionary measures indicated in Letter No. 13365/Gen Dt. 08.06.2020 issued by this Department to prevent spread of COVID infection shall be strictly adhered to by all concerned and in case of detection of detection of infections, protocol issued vide Letter No. 17290 Dt. 23.07.2020 of this Department shall be followed and be reported to concerned Head of Office, forthwith.
