Foundation Stone for proposed 132/33 kv GIS substation at BJB Nagar, Bhubaneswar was laid on 5th April, 2021 in kind presence of Honble Minister, Science & Technology Sri Ashok Panda and Honble Minister Energy Captain Dibya Shankar Mishra. The 40.38 Cr. worth GIS substation will have 2x63 MVA transformation capacity. This Grid will be connected to Kesura and Satya Nagar Grid through underground cabling. Consumers of Kalpana Square, Badagada, BJB Nagar, Lingipur, Old Town, Nageswartangi, Uttara and Samantrapur will be benefited through this project with quality and reliable power. # OPTCL SURGES AHEAD IN PROJECT COMMISSIONING

**O**PTCL, the State Transmission Utility, commissioned a number of power transmission projects in 4<sup>th</sup> Quarter of FY 2020-21. The long awaited 132/33 KV G Udaygiri Grid sub-station with 20 MVA Power Transformer and its associated 12 km of LILO line from Bhanjanagar-Phulbani line was commissioned in the month of March. The 132/33 KV Manesar Grid substation with 2X40 MVA transformer and associated LILO line from Sambalpur-



Rairakhole line was commissioned in the month of February. This will facilitate power distribution to Sambalpur and Manesar area. Further, the much awaited 132 KV RTSS Godbhaga line from Katapalli Grid and the 132 KV RTSS Manesar line feeding power to railway traction system were commissioned amidst severe ROW problems. The 15 km 132 KV D/C Phulnakhara-Pratapsasan line was commissioned, which not only brought the twin cities of Cuttack & Bhubaneswar in a 132 KV Ring system but also improved the power transmission reliability to the State



Capital Region with multi point power injection. In the Southern part of Odisha, OPTCL commissioned the 58 km long 132 ky Javnagar - Tentulikhunti 2<sup>nd</sup> circuit in February. This line shall cater to the increasing power demand for Nabarangpur, Dabugaon and Umerkote area from the U-Kolab and Balimela power houses. The 132 KV LILO line from Barpali-Bargarh line to 220/132/33 KV New Bargarh was also commissioned in March. This line shall improve the power reliability of Bargarh area. OPTCL has also an obligation to supply power to the Industries. Power supply to Sree Cement at 132 KV was extended through a 6.5 km long 132 KV transmission system in March. In spite of difficult due to Covid-19 resurgence, OPTCL Engineers are working hard to commission the power projects and have ensured power availability to the general public, railways and industries. During the guarter OPTCL has added 100 MVA transformation capacity and 154 ckt km of transmission line with 2 nos of Grid sub-stations to the Odisha Power System.

# INAUGUARATION OF D3 APPLICATION

Principal Secretary Energy, Sh Nikunja Bihari Dhal, IAS, inaugurated the Online Webportal Drawing, Design & Document (D3) approval system of OPTCL on 31<sup>st</sup> March 2021. The online portal shall be available for all vendors, suppliers and EPC contractors of OPTCL from 1st April, 2021 for uploading their drawings, design documents online and getting them approved. Now it will be easy for them to obtain approval without physically going to respective construction sites. The web portal is a Transparen and less Time consuming application.

# GPMS APPLICATION TO MONITOR CONSTRUCTION WORK

**O**PTCL signed an MOU with HDFC bank on 15<sup>th</sup> April for Government Project Monitoring System (GPMS) for monitoring of its High Voltage Power transmission projects. The state of the art computerised application shall be very much useful for OPTCL Engineers for online posting of various project activities from award to closure. It is a path-breaking mobile application and collaborates Government departments, Engineering teams, Contractors, and QC professionals on one mobile management and cloud platform. Speaking on the occasion of the signing of the MOU, Sri Rajib Lochan Panda, Director(Projects) OPTCL said that project monitoring is an important tool for early commissioning. From site survey, engineering drawing approval to material supply, erection, testing and commissioning, are all important activities in any project. With so many projects currently being undertaken by OPTCL, it is a gigantic task to have proper monitoring of each project.

The GPMS system shall be helpful for both site Engineers and the senior level officers at Headquarters to have status updating, real time work progress, online MIS and help in quick decision making process. Presiding on the occasion Shri Sanjeev Singh, MD, OPTCL said that the adoption of new



technology in Project monitoring is the need of the hour and a welcome step by the Project team. Shri Sudipta Sengupta, CGM, OPTCL and Shri Deepak kumar Singh, Senior Vice President HDFC Bank Ltd, Odisha signed the MOU. Present on the

## OPTCL INKS LOAN AGREEMENT WITH UNION BANK OF INDIA

**B**hubaneswar22.04.2021: OPTCL inks a loan agreement with Union Bank of India for term loan of 607.12 Crore in kind presence of Corporation's Chairman and Principal Secretary to Govt.of Odisha, Department of Energy, Sri Nikunja Bihari Dhal, IAS. This loan



amount will be utilized for construction of 18 Nos of EHT projects started way back in 2016-17. The total cost for 18 Nos EHT projects is Rs.857.12 Crore. Govt. of Odisha has also approved equity infusion of Rs.250.00 Crore over a period of 5 years for these projects. The rest amount of 607.12 Crore is arranged today by availing loan from Union bank of India.

"The Union Bank of India by providing loan assistance to Government projects is participating in the State's progress and such kind of gesture from nationalized banks should be emulated by all." Said Sri Dhal in his address.

Many Nationalized banks and financing institutions participated in the Bid invited by OPTCL and Union bank of India quoted lowest rate of interest i.e 7.20% MCLR with other favorable terms & conditions of loan repayment to OPTCL. OPTCL has to repay the loan amount over a period of 177 months including moratorium period of 33 months. Sri Samir Kumar Swain,



Director (Finance) and Sri Ramakanta Pradhan, Field General Manager of Union Bank of India signed the MoU on behalf of OPTCL and Union Bank of India respectively. Present on the occasion were Sri Sanjeev Singh, MD, OPTCL, all the functional directors and senior officials from OPTCL & GRIDCO.

### SUCCESSFUL COVID MANAGEMENT IN OPTCL





The Covid-19 Pandemic has posed challenge in all spheres of life and our transmission sector is no exception. During this time, the health safety of the employees is very important to ensure uninterrupted transmission of electricity in the state. In view of this the Management of OPTCL took many strategic steps to contain the spread of the virus and also took many proactive steps for Covid affected employees.

**Tele-Medicine Facility:** With the help of the Doctors of OPTCL Power Hospital, 24X7 tele-medicine facility has been extended to the employees of OPTCL. This facility enables the employees to consult telephonically at any time. In moderate and severe cases, doctors ensured their hospitalization in local Covid Hospital in coordination with the Covid Cell.

**Isolation Facility:** Isolation facility at transit house has been facilitated at four rooms for mild and asymptomatic employees those do not have such facility in their home due to space constraint.

**Covid-Coordination Cell:** A Covid Coordination Cell has been set up to assist the Covid Positive employees for their hospitalization. Also home delivery of essential goods have been ensured to the affected employees of Colony and cooked food is provided where all the members are affected.

**Financial Compensation:** OPTCL has extended Financial Compensation/Exgratia of Rs. 5.00 Lakhs to the nominee or eligible legal heir of the deceased employee who have died due to Covid-19, while in service w.e. f. 22, 03, 2020.

Precautionary measures: Automatic Hand sanitizing Dispensers have been installed at strategic points of Hqrs Office and field office. For visitors also, provision of wash basins with soaps have been made. Free Masks have been distributed to outsourced persons (security guards, sanitation workers and other low paid outsourced personnel). Use of Conference Halls are minimized & executives are attending meetings through online from their work places. An Apex Committee comprising senior most officers has been constituted to evaluate the emerging situation and oversee the compliance of Covid 19 appropriate behaviour and approve all emergent procurements. Similarly four Zonal Committees have also been formed for implementation of all guidelines and instructions issued by GoO as well as the Corporation. The Committee ensures periodic sanitization of all offices, vaccination of employees and compliance of Covid 19 appropriate behaviour in all units under their jurisdiction. All the Divisional Head are designated as COVID Compliance Officer (CCO).



### EMPLOYEE WELFARE MEASURE

Being in a bad physical condition due to illness (acute or chronic) affects one's mental condition adversely. And, for optimum productivity in the job, one needs to have stability in both physical and mental health. To ensure that the Organisation and its employees don't distract from providing their best service to the people of Odisha, the management of OPTCL has implemented many steps. Implementation of Group Health Insurance Policy for its employees and their family members w.e.f 01.04.2021 on its 16<sup>th</sup> founding day is one of such measure. More than 10,000 life units are covered under the scheme with 5 to 7lakh sum insured. Being borne wholly by the Organisation and tailor-made, the employees are left untroubled with regards to payment of the premium. We, at OPTCL, value our vision i.e. the lifeline of Odisha, and understand our employees play a key role to realise and sustain that vision. Also, as another goodwill gesture, the Organisation has decided to extend Group Health Insurance Policy to its retired employees and their spouse. While, premium will be borne by the retiree; the management will help to facilitate and cater the scheme. This is a benevolent measure by the Organisation for retirees as a recognition to their long service.

> BHARATNET PHASE-II PROJECT IN ODISHA



**B**haratNet is a flagship project of Government of India (GoI) funded by Universal Service Obligation Fund(USOF), Department of Telecommunications, Ministry of Communication to provide broadband connectivity(High speed internet) at all Gram Panchayats (GP)s to enable key services like administration, education, health, banking and agriculture

in becoming efficient and transparent at grass root level. Under Bharat Net Phase-I, 15 coastal Districts in Odisha were covered earlier being executed by PGCIL/BSNL. Under Phase-II, the rest 15 districts and balance left over GPs from Phase-I is being implemented by OPTCL. A team of dedicated Telecommunication engineers of OPTCL are working relentlessly to provide Broadband connectivity to 3072 Nos of GPs where 19,795 Kms of Over Head OFC cable are being laid.

A State Level Implementation Committee under the chairmanship of chief Secretary is monitoring the implementation of the project. Till date 15,976 KM of overhead fibre have been strung covering 2181 nos of GPs

Under this scheme, Broadband services are being made available to the much talk about Kutia village of Koraput district and Odisha's Honorable CM interacted with the district administration on 5th Feb,2021 who were present at Kutia using this broadband service. As such FTTH connection have been completed for provision of high speed internet in in 756 nos of GPs as on date.

OPTCL expresses deep condolence on passing of these two family members and we wish for their souls to rest in peace.



OPTCL is comping up with a new Data Centre equipped with latest infrastructure and technology. At present data centres of OPTCL, GRIDCO & SLDC are functioning separately. For smooth operation of such important infrastructures, a Data centre has been constructed near hgrs office where all the data centres will be accommodated in a single building. The data centre has been developed with tier-III datacentre architecture with financial implication of 55 Cr. Which includes around 11 Cr operation cost. Management is also planning to accommodate the data centres of DISCOMs in this Date Centre for better coordination and decision making. All electrical and non-IT works have been completed and the migration of existing date centres will take place very soon.

### YASS RESTORATION BY OPTCL

Preventive measures by OPTCL minimized the damages in YASS cyclone. OPTCL has planned in advance for a possible summer cyclone in the month of May. OPTCL planned meticulously so that damages could be restricted and restoration work begins soon after the Cyclone. Nine restoration gangs with tools and implements, generators, gas cutters were deployed in vulnerable locations where the cyclone Yass made landfall. Similarly ten emergency towers were also kept ready in Balasore, Bhadrak and kendrapada district so that restoration could be made in case of uprooting of towers. Team of engineers



headed by Sr. general Manager/ General Manager was deployed at different grids to take immediate post cyclone restoration. It was decided to restore power on priority to essential services like Covid hospitals, water supply and telecommunication. Though the damage of HT lines and transmission system was very less in the YASS cyclone, restoration of transmission service could be made immediately after the cyclone due to adequate planning and pre-positioning of men , materials and machine at strategic locations. To motivate the restoration workers, OPTCL announced accident benefit for casual electricity workers engaged in transmission restoration. The full cost of the treatment will be borne in case of injury and hospitalization. Compensation of 10.00 lakhs was made provision for the legal heir of the worker in case of unfortunate death during the restoration work. These benefits were above any other benefits the workers entitles under law.
