SECTION-III

1. Scope of the contract:

- a) All the surfaces to be painted shall be free from grease, oil and other contaminants by applying de-greasing solvent.
- b) Removal of rusting is to be done and surfaces to be cleaned by making full use of mechanical tools along with manual scrubbing and wire brushing.
- c) Surface to be washed thoroughly and then dried properly.
- d) Painting of equipment structure at least 1.50m from the base by applying one coat of zine phosphate primer of ASIAN/BERGER make.
- e) 2 coats of Aluminium paint of ASIAN/ BERGER make including cost of materials, consumables, T&P and as per instruction of Engineer-in-Charge.

The painting work shall be done carefully in such a way that the paint shall not scale off or crinkle or shall not be removed by abrasion due to normal handling and capable to withstand extremely of weather condition.

All materials required for painting including Berger paints, Asian Paints, thinners etc., tools and plants are to be supplied/ arranged by the contractor. A joint verification report made by contractor with the consignee regarding use of genuine quality of primer & Berger/ Asian make paints to be used for painting works towers with the bill.
